# REMARKS

### SABG TA Supplement

A supplement to your FY 2019 Substance Abuse Prevention and Treatment Block Grant (SABG) allotment is being made for providing and/or obtaining training and technical assistance.

The authorized amount of the supplement is reflected in **Section I – Award Data as AMOUNT OF THIS ACTION (FEDERAL SHARE)**. Set-aside requirements and administrative limitations do not apply to the supplement amount.

This funding may only be used for technical assistance and training activities, and can range in scope from technical assistance to the state, technical assistance to block grant providers, workforce development meetings and activities. Funds cannot be used for service delivery;

they are strictly limited to training and TA. Funds must be used for technical assistance and training activities related to serving the SABG priority populations: Pregnant Women, Injecting Drug Users, Women with Dependent Children, Persons at Risk for Tuberculosis, Individuals in Need of Primary Substance Abuse Prevention, and, for FY 2019 HIV-designated states or a state designated in any of the prior three FY and opted to use SABG funds for early intervention services for HIV (EIS/HIV), Persons at Risk for HIV.

Funds awarded under this supplement must be obligated and expended by <u>September 30,</u> 2020.

Supplement funding must be reported as part of the total FY 2019 allotment on the:

- o Federal Financial Report due by December 29, 2020; and,
- SABG Report due by **December 1, 2020.** 
  - All prior terms, conditions, and reporting requirements for the FY 2019 allotment are still in effect.

In accordance with the regulatory requirements provided at 45 CFR 75.113 and Appendix XII to 45 CFR Part 75, recipients that have currently active Federal grants, cooperative agreements, and procurement contracts with cumulative total value greater than \$10,000,000 must report and maintain information in the System for Award Management (SAM) about civil, criminal, and administrative proceedings in connection with the award or performance of a Federal award that reached final disposition within the most recent five-year period.
