According to Centers for Disease Control and Prevention (CDC), injected medicines are commonly used in healthcare settings for the prevention, diagnosis, and treatment of various illnesses. Unsafe injection practices put patients and healthcare providers at risk of infectious and non-infectious adverse events and have been associated with a wide variety of procedures and settings. This harm is preventable. Safe injection practices are part of Standard Precautions and are aimed at maintaining basic levels of patient safety and provider protections. As defined by the World Health Organization (WHO), a safe injection does not harm the recipient, does not expose the provider to any avoidable risks and does not result in waste that is dangerous for the community.

To better assist your facility's efforts toward education of safe injection practices and the prevention of exposing patients and healthcare personnel to any avoidable risks, the Office of Public Health Informatics and Epidemiology is offering a free online training as noted below.

**Safe Injection Practices Training

- Recommendations on the use of needles and intravenous delivery systems
- Common safety breaches
- Unsafe injection practices and disease transmission
- Dangerous misconceptions
- Single-use/single-dose vials vs. multi-use/multi-dose vials
