2. Public Comment

There was no public comment.

- **3.** Approval of Minutes from the Meeting on April 29, 2020 Ms. Thompson moved to approve the minutes with corrections. Mr. Kuzhippala seconded. The motion passed without abstention or opposition.
- Approval of Minutes from the Statewide Epidemiology Workgroup (SEW) Data Subcommittee Meeting on June 24, 2020 Ms. DeLett-Snyder moved to approve the minutes. Ms. Asteriadis-Pyle seconded. Ms. Long abstained. The motion passed without opposition.
- 5. Propose and Approve Any Additional Data Recommendations to SAPTA for Consideration Under the 2020/2021 Grant Year Objectives Ms. Barker reminded the group that its purpose is to discuss and review data and provide recommendations to SAPTA and the MPAC. SAPTA takes the



recommendations into consideration when establishing their grant objectives for the year. The executive summary was approved as the recommendations that will go before the MPAC and SAPTA. The Epidemiologic profile is used for the recommendations, as well as the coalition presentations and dose reporting. SAPTA has until August 14, 2020 to receive any recommendations from the SEW.

Ms. Thompson found the data from the coalitions helpful. It will be added as a recommendation. Ms. DeLett-Snyder agreed.

Ms. Henderson felt that domestic and intimate partner violence are missing and would like to address the issues in screening and seeking data sources.

Ms. Long moved to approve the additional data recommendations. Ms. Thompson seconded. The motion passed without abstention or opposition.

6. Review and Approval of Recommendations for the Next Statewide Epi Profile from the Data Subcommittee

Ms. Barker referred to the handout which can be viewed here.

Ms. Barker proposed the Epi profile be done every two years, as previously discussed. Ms. Asteriadis-Pyle agreed.

Mr. Yehn mentioned the Epi profile was missing the Pregnancy Risk Monitoring Systems (PRAMS) data, as previously discussed.

Ms. Long moved to approve the recommendations with the changes. Ms. Mburia seconded. The motion passed without abstention or opposition.
