The RWPB Member ID Cards are created by the Eligibility & Enrollment providers and are used by the clients to obtain pharmaceutical or care services benefits. Each client receives a Member ID Card from the Eligibility & Enrollment provider after they complete the necessary paperwork. The Member ID Cards are for each six-month enrollment window as noted by the **Effective Dates**. The **Member ID** that is on the card is the client's **Ryan White Part B Member ID Number**.

If the client is enrolled in Medication or Insurance Assistance, select the appropriate **Benefits Program**, if not then select Care Services and stop here. The information that the pharmacy needs in order to correctly process the billing claim is in the **PCN**, **BIN** and **Submitter Code** fields.

On the back of the card is the contact information to the service provider that enrolls the client into Medication or Insurance Assistance.

PROVIDER RESPONSIBILITY

It is the responsibility of each provider to verify Ryan White Part B enrollment before service delivery. Using the Member ID Cards is one way to verify enrollment. An alternate method for verifying enrollment is checking the client's enrollment dates in CAREWare.

CLIENT RESPONSIBILITY

It is the responsibility of the client to keep and maintain an undamaged RWPB Member ID Card.
