EMS Community,

The State of Nevada EMS Program will soon implement a new web-based Patient Care Reporting system called “Elite” as the State’s enterprise solution for reporting, and the new Repository for the collection of ePCR data. The Project Team will migrate all Direct Reporting Agencies/Providers and all Agencies that use 3rd party vendors from the current Intermedix system to the new ImageTrend application called “Elite”.

- The enterprise solution will be administered and sustained by the State, and supported by the vendor
- The new system will provide Agencies a no-cost solution for reporting via a web-based application
- Agencies that wish to remain with their 3rd party vendors for reporting will be provided access accounts and new/changed Schematrons (well in advance of the changes taking effect) as they are available

****No Schematron changes will take effect until after all Agencies are onboarded to new Patient Care Reporting Repository****

- Future changes to validation rules will first be “warnings” to allow lead time for 3rd party vendors to make necessary programming changes. This will ensure data continues to be accepted by the State’s new ePCR Repository “Elite”, while allowing for reporting compliance to increase standardization and accuracy
