## NOTICE OF PUBLIC HEARING

Intent to Adopt Regulations LCB File No. R156-18

NOTICE IS HEREBY GIVEN that the Division of Public and Behavioral Health will hold a public hearing to consider amendments to Chapter 449 of Nevada Administrative Code (NAC), Medical Facilities and Other Related Entities, LCB File No. R156-18. This public hearing is to be held on January 10, 2019.

The proposed changes will revise Chapter 449 of the Nevada Administrative Code and are being proposed in accordance with §§1-6, Nevada Revised Statutes (NRS) 449.2425.

The proposed changes to NAC Chapter 449 include the following:

Existing law requires the Division of Public and Behavioral Health of the Department of Health and Human Services to establish: (1) a system for awarding a star rating to certain health care facilities on compliance with certain requirements relating to staffing, which must be posted on the Internet website of the Division and in the facilities that are rated; and (2) procedures by which such a health care facility may appeal a finding of a violation of those requirements or request a follow-up inspection. (NRS 449.2425) Sections 3 and 4 of this regulation define terms used in provisions establishing the rating system and in procedures for requesting an appeal or follow-up inspection. Section 5 of this regulation establishes the rating system and requires the Division to issue to each facility that is inspected or investigated a placard that states the name

and rating of the facility. **Section 6** of this regulation prescribes the procedures for requesting an appeal or follow-up inspection.

- 1. Anticipated effects on the business which NAC Chapter 449 regulates:
  - A. Adverse effects: There are minimal anticipated adverse effects on business. Although it is possible for a facility to receive a low star rating, as the requirements relating to staffing only apply to the health facilities defined in NRS 449.2414 and limits it further to those facilities located in a county whose population is 100,000 or more and which is licensed to have more than 70 beds, it would only impact hospitals. In addition, the star rating is limited to compliance with the staffing statutes (NRS 449.241 to 449.2428) and is based on the severity of the violation. The lower star ratings are also associated with a higher severity score for violations of the staffing statutes. In the last year no hospitals were cited a high severity score (severity 3 or 4) for a violation of these staffing statutes; therefore, it is anticipated that few hospitals would receive a low star rating. All these factors combined suggest the adverse effects on business would be minimal.
  - B. *Beneficial:* Facilities noted in A above will be required to post the final star rating assigned to the facility after the most recent investigation or inspection in a conspicuous place near each entrance to the facility that is regularly used by the public and, if the facility maintains an Internet website that is accessible to the public, on that Internet website. This will allow facilities that receive a high star rating to showcase their high rating to the public.
  - C. *Immediate:* Impacted facilities would be assigned staffing related star rating upon passage of the proposed regulations and after an inspection or investigation is conducted. The consequences would be unknown at this time, as we don't know which facilities will receive a low or high star rating, although it is anticipated few facilities would receive a low star rating as noted previously.

D. *Long-term:* There are no known anticipated long-term beneficial or adverse effects. 2. Anticipated effects on the public:

- A. Adverse: There are no anticipated adverse effects on the public.
- B. *Beneficial:* The public will have greater transparency related to a hospital's compliance with the requirements related to staffing statutory requirements.
- C. *Immediate*: The beneficial effects noted above will apply upon passage of the proposed regulations and issuance of a staffing star rating.
- D. *Long-term:* There are no anticipated beneficial or adverse long-term effects on the public.

3. The estimated cost to the Division of Public and Behavioral Health for enforcement of the proposed regulations is estimated to be minimal as the workload will be absorbed into its normal inspection and investigation workload. There may be some mailing costs associated with issuing the placards, but the Division will look into either combining the mailing with other facility mailings or look into the possibility of issuing the placards in an electronic format.

The proposed regulations do not overlap or duplicate any federal or other Nevada state regulations.
