The Nevada Department of Education, Office of Early Learning and Development has partnered with ZERO TO THREE to bring *Knowledge and Know-How: Nurturing Child Well-Being* online lessons to teachers working with very young children and families in Nevada.

The topics of the lessons are:

3. Building A Healthy Brain
4. Promoting Well-Being and Preventing Maltreatment of Very Young Children
5. Culture and Caring for Young Children
6. Understanding Temperament
7. Responding to Challenges in Young Children's Behavior
8. Relationship-Based Practice

*Knowledge and Know-How* provides essential core content that can support your professional development goals as infant toddler teachers.

The series has been approved by The Nevada Registry for eight clock hours or .8 CEU's. You must complete all eight lessons to receive either hours or CEU's – no partial clock hours will be awarded.

<b>Steps to Accessing Online Lessons:</b>	
1. Submit Application	You will receive an e-mail confirming receipt of your application.
2. Receive Notice of Award	Once your application has been reviewed, you will receive a second e-mail. If your application is accepted, the e-mail will include a user guide and log-in code. If your application is not accepted, the e-mail will include explanation.
3. Complete Eight Online Lessons with a Post Assessment Score of 80% (Minimum)	You will have six months from the date you register to complete all eight modules.
4. Receive Certificate with Nevada Registry Training Approval Number	After you have completed all eight lessons, you will be able to print a certificate of completion. You must submit a copy of the certificate to the Office of Early Learning and Development to receive a certificate specific to Nevada that includes the Nevada Registry approval number.
