## A Note from the Administrator



Welcome to the Nevada Division of Public and Behavioral Health's (DPBH) program guide. Our services focus on the health and wellness of those residing or visiting the state. DPBH serves as the state's Public Health Authority and Mental Health Commissioner, on the federal level and supports other agencies in urban and rural/frontier areas through funding and oversight. In addition, the regulatory branch of the agency also provides licensing and certification to most healthcare facilities and food establishments thereby protecting the public's health. Our programs are established in each region by evaluating the needs and available resources and then focusing our efforts on the health-related concerns. We add any funding in support of services, when possible, or where gaps exist, provide access to services offered by our agency.

Our dedicated staff of more than 1,800 employees and contractors, focuses on health and wellness issues as we work as a collaborative partner under the Department of Health and Human Services, (DHHS). DPBH also works closely with other state agencies and stakeholders to fund statewide programs to ensure sustainability and growth at the local level. DPBH writes grants for federal funds that, when successfully-funded, are passed down to local agencies so that services can be provided by local neighbors, friends, and community-members based in the areas where Nevadans live. DPBH also provides oversight to the WIC, (Women's Infants and Children's) nutrition program, immunizations, HIV/AIDS, substance use disorder treatment and prevention, chronic and communicable disease programs and public health preparedness as well as others.

DPBH provides direct services for those suffering from mental illness by operating inpatient hospitals at both ends of the state. The civil hospitals include Rawson-Neal, in Las Vegas, and Dini-Townsend, in Sparks. The forensic hospitals include Lakes' Crossing Center and Stein Forensic hospital. Additionally, outpatient services are provided statewide including in the rural and frontier communities for public and mental health needs.

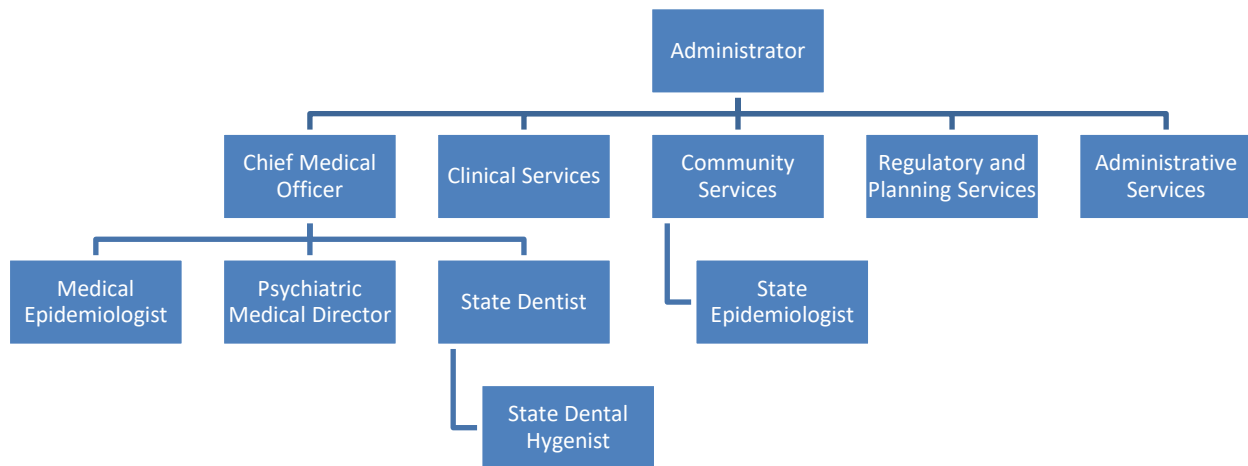
## Division of Public and Behavioral Health Overview

The Nevada Division of Public and Behavioral Health (DPBH) is part of the Department of Health and Human Services (DHHS), under the Executive Branch of the state of Nevada. DPBH is comprised of the former Nevada State Health Division and the former Division of Mental Health and Developmental Services. On July 1, 2013, the two divisions merged to form DPBH.

The executive team that leads DPBH is comprised of the Administrator, Chief Medical Officer (CMO), Senior Advisor on Psychological Services, Medical Epidemiologist, Psychiatric Medical Director, and State Dental Officer.

DPBH is organized into four branches, each overseen by a Deputy Administrator and Subject Matter Experts, as shown below, which includes: Community Services, Regulatory and Planning Services, Clinical Services, and Administrative Services. ## Office of the Chief Medical Officer

The Office of the Chief Medical Officer is comprised of four additional clinical executive positions in addition to that position: Medical Epidemiologist, Psychiatric Medical Director (Dr. Leon Ravin), State Dentist (Antonina Capurro), and State Dental Hygienist (Judy White). Dr. Ihsan Azzam is Nevada's Chief Medical Officer. Dr. Azzam is directly responsible for enforcing all laws and regulations pertaining to public health throughout Nevada. This includes interpreting, implementing and providing guidelines for the State Board of Health, and public and private entities on federal and state laws and Board of Health regulations. He also investigates causes of disease, epidemics, sources of mortality, and other matters impacting public health.



## Community Services Branch

The Community Services (CS) Branch is led by Julia Peek, who serves as the Deputy Administrator. The primary purpose of the programs within the CS Branch is to establish and develop relationships with community partners to improve public health and behavioral health outcomes for all communities within Nevada.

### Office of Public Health Investigations and Epidemiology (OPHIE)

The Office of Public Health Investigations and Epidemiology (OPHIE) plays a pivotal role in improving the health of all Nevadans by providing public health data and epidemiological investigation, prevention, and surveillance. The OPHIE is a committed and responsive team whose mission is to provide quality, timely, and relevant data and statistics to public health stakeholders. These stakeholders include local health authorities, as well as local, state, and national planning and research bodies, and the public. Staff in the OPHIE performs data management, quality assurance, analysis, and reporting in a broad spectrum of public health areas. The OPHIE houses many core public health datasets, including communicable disease data, health survey data, inpatient hospital discharge data, births, deaths, fetal deaths, abortions, marriages, and divorces. Common elements between databases enable matching or linking of these databases in order to provide newly accessible and standardized information for analytical and programmatic purposes. Extracted databases derived from each database and linked databases are available for statistical data analysis. Analyses are compiled in a variety of reports, which are posted on the DPBH's website, making the data available for program evaluation and planning and policy development.

The OPHIE has three offices: central office in Carson City, and satellite offices located in Las Vegas and Reno.

### **Adult Viral Hepatitis Prevention and Control Program**

Primary activities of the Adult Viral Hepatitis Program include development and implementation of a case management program to provide testing, partner counseling and referral health education, patient assessment, assistance with insurance enrollment, facilitation of support groups, vaccination against HAV/HAB, and medical follow-up to specialty care, mental health services, substance abuse treatment, and hospice care and other health care services. Additionally, the program provides hepatitis education and outreach activities and regularly updates the Hepatitis State Plan and the Nevada Hepatitis Resource Directory.

**Behavioral Risk Factor Surveillance System**

The Behavioral Risk Factor Surveillance System (BRFSS) is a state-based nationwide survey sponsored by the Centers for Disease Control and Prevention (CDC) to gather data on health risk behaviors, preventive health practices, and health care access primarily related to chronic disease and injury health risks in the U.S. The survey has been ongoing in Nevada since 1992. The information gathered is used to identify health issues and determine how public health funds will be expended in Nevada. Currently, data is collected monthly in all 50 states, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, and Guam. More than 350,000 adults are interviewed each year, making the BRFSS the largest telephone health survey in the world. Nevada uses BRFSS data to identify emerging health problems, establish and track health objectives, and develop and evaluate public health policies and programs.

**Epidemiology and Laboratory Capacity Program**

The Epidemiology and Laboratory Capacity (ELC) Program conducts communicable disease surveillance, investigates disease outbreaks, and initiates disease control activities. The ELC Program records and analyzes reportable disease information, conducts interviews with infected individuals and their contacts, refers individuals for medical treatment, analyzes data from disease investigations, identifies risk factors, provides education and recommendations on disease prevention, and works in conjunction with appropriate agencies to enforce communicable disease laws. ELC activities include:

- Enhancing the capacity to respond to complex infectious disease threats in Nevada through:
  - strengthening epidemiology capacity
  - enhancing laboratory capacity
  - improving health information systems
  - enhancing collaboration
- Developing, implementing, and evaluating public health interventions
- Providing a platform for networks to be created and managed on a variety of infectious disease issues (e.g., FoodNet, CaliciNet, PulseNet, ArboNet) to ensure prompt identification of emerging infectious diseases
- Integrating epidemiology, laboratory, and health information systems
- Promoting early detection methods to ensure timely implementation of control measures and minimal transmission of infectious diseases

### **HIV/AIDS Surveillance Program**

The primary functions of the HIV/AIDS Surveillance Program are to monitor the HIV/AIDS epidemic and provide data for prevention and care efforts. The tasks to achieve this include soliciting, receiving, reviewing, and filing HIV/AIDS case reports in a timely manner; determining if case reports meet the HIV infection or AIDS case definitions, or both; ensuring the collection of all required information (e.g., through follow-up investigation); and maintaining a complete and accurate HIV/AIDS surveillance database.

### **Nevada Central Cancer Registry**

The primary purpose of the Nevada Central Cancer Registry (NCCR) is to collect and maintain a record of reportable cases of cancer in the state. The data is used to evaluate the appropriateness of measures for the prevention and control of cancer and to conduct comprehensive epidemiological surveys of cancer and cancer-related deaths. Cancer case data is collected from hospitals, medical laboratories and other freestanding facilities and from physicians that provide screening, diagnostic or therapeutic services to patients with respect to cancer. The information on these cases of cancer is reported to NCCR. This is accomplished by reporting facilities abstracting state-required patient cancer information from their medical records. Collected data is entered into a specialized database where additional case information is added, edited, and consolidated for accuracy and completeness. The Registry conducts follow-up activities with facilities and/or physicians and uses sources such as the Department of

Motor Vehicles, Hospital Discharge, Social Security Death Index, Voter Registration, Census Tract and death information from the State Office of Vital Records to assure case record completeness.

NCCR annually compiles comprehensive cancer data collected for all years of operation and submits a report to the Centers for Disease Control and Prevention (CDC)/National Program of Cancer Registries (NPCR) and the North American Association of Central Cancer Registries (NAACCR) and for analysis, certifications, and inclusion in national cancer statistics.

Timely and complete cancer data are used to evaluate the appropriateness of measures for the prevention and control of cancer and conducting comprehensive epidemiological surveys of cancer and cancer-related deaths statewide and nationally.

NCCR is a vital tool for monitoring the incidence of cancer within the state and sharing that information with health care professionals, researchers, and the general public.

## **Nevada Violent Death Reporting System (NVDRS)**

The National Violent Death Reporting system is a CDC grant that provides states and communities with a clearer understanding of violent deaths to guide local decisions about efforts to prevent violence and track progress over time. NVDRS is the only state-based surveillance system that pools data on violent deaths from multiple sources into a usable, anonymous database. These sources include stand and local medical examiner, coroner, law enforcement, toxicology, and vital statistics records.

### **Prescription Drug Overdose Prevention for States**

### **Sentinel Events Registry**

The Sentinel Event Registry (SER) Program tracks reportable sentinel events in acute care hospitals, ambulatory care centers, independent emergency room centers, and obstetric centers. A sentinel event is defined as an unexpected occurrence involving facility-acquired infection, death or serious physical or psychological injury or the risk thereof, including, without limitation, any process variation for which a recurrence would carry a significant chance of a serious adverse outcome. The term includes loss of limb or function (NRS 439.830). It is called a sentinel event because it signals the need for immediate investigation and response.

The section assists state, local and community efforts with interrupting the transmission of chlamydia, gonorrhea, syphilis and other STDs, and reducing the health burden and costs associated with these infections. Primary activities of STD Prevention and Control include testing and treatment of chlamydia, syphilis and gonorrhea (reportable STDs); surveillance of reportable STDs; providing opportunities for statewide STD stakeholder planning and goal development input; locating and treating contacts of known cases with an STD and providing risk reduction education and material.

### **HIV/AIDS Prevention and Care Programs**

Guided by the principles of public health and social justice, the HIV/AIDS Prevention and Care Program mission is to promote health and reduce the impact and incidence of HIV/AIDS by working in partnership with other agencies and diverse community groups. The Program is comprised of two sub-programs – HIV Prevention and Ryan White Part B. HIV Prevention Program staff coordinates its efforts in collaboration with the local health districts, HIV prevention planning groups, HIV-infected and affected communities, state and local HIV prevention providers, and other concerned and committed citizens to improve HIV prevention service delivery in Nevada; to ensure the HIV prevention planning process supports a broad-based participation; that HIV prevention needs are adequately identified in each jurisdiction; and that resources target those at greatest need and interventions set forth in its Integrated HIV Prevention and Ryan White Care Plan. The Ryan White HIV/AIDS Part B Program (RWPB) provides medications and services to eligible HIV/AIDS clients. Nevada's AIDS Drug Assistance Program (ADAP) formulary is geared toward optimum patient care; medications are maintained in coordination with and by recommendation of the HIV/AIDS Medical Advisory Committee (MAC). The program also assists with Housing Opportunities for People with AIDS (HOPWA). Funds are used to prevent and eliminate homelessness among people living with HIV/AIDS in Nevada. Services include, but are not limited to, the acquisition, rehabilitation, or new construction of housing units; costs for facility operations; rental assistance; and short-term payments to prevent homelessness.

- Increase the number of central, population-based registries from the 50 States and the District of Columbia that capture case information on at least 95 percent of the expected number of reportable cancers (Healthy People C-12).
- Reduce the female breast cancer death rate (Healthy People C-3).
- Reduce the death rate from cancer of the uterine cervix (Healthy People C-4).
- Reduce invasive uterine cervical cancer (Healthy People C-10).
- Increase the percentage of reporting sources (facilities) that submit data electronically to the central registry to 60%.

- 3 - Before THREE months of Age: Hearing Evaluation by an audiologist if baby did not pass hearing screening; and
- 6 - Before SIX months of Age: Early Intervention if baby is diagnosed with hearing loss.

In addition to assuring screening and intervention for children with hearing loss, the EHDI program provides advocacy for children and families. This is done through the development of partnerships and working with community programs to create awareness and ensure access to services.

### **Nevada Home Visiting**

Home visiting is a service offered to support positive parenting, develop nurturing homes and promote healthy child development through regular home visits by trained professionals. Families with children up to age five and/or families expecting a baby may voluntarily request these free in-home services. The Nevada Home Visiting Program



supports agencies and organizations that conduct home visiting services to pregnant women, mothers, fathers, and caregivers to educate their young children, improve maternal and newborn health, improve school readiness, and reduce child injuries, neglect, and abuse. Scientific studies have confirmed the positive impacts of home visiting for children and families while yielding between \$3 - \$6 savings to federal, state, and local governments for every dollar spent.

Nevada Home Visiting exists to develop and promote a state-wide coordinated system of evidence-based home visiting that supports healthy child development and ensures the safety of young children and family members.

### Goals

- Develop a state-wide infrastructure to support home visiting and agencies who administer home visiting programs.
- Provide training and technical assistance to local home visiting agencies.
- Improve the quality of home visiting services by incorporating Continuous Quality Improvement (CQI) principles in the administration of Nevada Home Visiting and in its relationships with its partners.
- Improve the coordination and referrals to community resources and support these resources through interaction and collaboration with public and private organizations.
- Develop a home visiting database to facilitate the reporting, tracking, and analysis of home visiting program outcomes, CQI measures, and model fidelity.
- Assist funded home visiting agencies to focus their efforts on the National MIECHV benchmarks, which include:
  - Improvements in Maternal and Newborn Health
  - Prevention of Child Injuries, Child Abuse, Neglect, or Maltreatment and Reduction of Emergency Department Visits
  - Improvements in School Readiness and Achievement
  - Reduction in Crime or Domestic Violence
  - Improvements in Family Economic Self-Sufficiency
  - Coordination and Referrals for Other Community Resources and Supports

## **Nevada State Immunization Program**

The Nevada State Immunization Program administers the Vaccines for Children (VFC) Program, Section 317 and Nevada Cocooning Programs, and is responsible for operating and maintaining Nevada WebIZ. The VFC Program is administered to pediatricians, internists, family practitioners, hospitals, school districts, and public health providers.



The Section 317 Program is administered to the jail/prison system, hospitals, federally qualified health centers (FQHCs), adult internists, and public health providers. The Nevada Cocooning Program is administered to all of Nevada's birthing hospitals as well as OB/GYN providers. Nevada WebIZ is a web-based immunization registry that is required to be used by immunizing providers in the state of Nevada. Nevada WebIZ allows access for both private and public providers with minimal hardware/software requirements; it also allows organizations like schools and daycares to view a student's immunization record to verify compliance to Nevada's school-entry laws.

There are three health authorities in Nevada: Washoe County Health District, serving Reno and Sparks; Southern Nevada Health District, serving the greater Las Vegas area; and Carson City Health and Human Services, serving Carson City, Lyon, and Douglas counties. The Nevada Division of Public and Behavioral Health serves the remaining counties, except Elko County with public immunization services through local community health nurses.

The Nevada Chief Medical Officer (CMO) provides strict enforcement of health laws/regulations to the local health officers. The Nevada State Immunization Program is completely funded by the Centers for Disease Control & Prevention through an annual non-competitive grant, "Nevada Immunization and Vaccines for Children." Funds are subgranted from the Immunization Program to the three local health authorities and to one non-profit community coalition (Immunize Nevada) to conduct activities on behalf of the program. The local health authorities conduct VFC/AFIX visits and Perinatal Hepatitis B Prevention activities in their jurisdictions. They also conduct special projects to help increase immunization rates in their jurisdictions. The coalitions conduct education and advocacy activities in their jurisdictions. Immunize Nevada provides immunization education opportunities and advocacy activities to promote immunizations across the state.

**Nevada Women, Infants and Children Program**

The Special Supplemental Food Program for Women, Infants, and Children, commonly known as WIC, provides nutritious food to supplement the diets of limited-income pregnant, postpartum and breastfeeding women, infants, and children under age five who are at nutritional risk. WIC provides participants with healthy food, advice on good nutrition, health screening, information on health care services such as immunizations, prenatal care, and family planning, and information about other family support services available in their community. Applicants must be an infant or child under five years of age, a pregnant woman, a postpartum woman (up to six months after giving birth), or a breastfeeding woman (up to the breastfed infant's first birthday). Applicants must be Nevada residents who physically live in Nevada at the time of application, and must be at or below 185% of the federal poverty level. In addition, applicants must be at nutritional risk, as determined by a Competent Professional Authority (CPA) at the WIC clinic.

### **Office of Suicide Prevention**

The Nevada Office of Suicide Prevention (NOSP) is the clearinghouse for suicide prevention information in Nevada. The Suicide Prevention Coordinator, Northern Suicide Prevention Training/Outreach Facilitator, Youth Mental Health First Aid (YMHFA) Coordinator, along with the Suicide Prevention Assistant are located, in Reno. The Southern Suicide Prevention Training/Outreach Facilitator, YMHFA Assistant, and AmeriCorps Volunteer are located in Las Vegas. This team is responsible for the development, implementation, and evaluation of the Nevada Suicide Prevention Plan. A major initiative is following up on the Veterans' Suicide Mortality report through collaboration with Nevada National Guard, the Nevada Substance Abuse Prevention and Treatment Agency (SAPTA), the Governor's Office, and the Nevada Department of Veterans Services, to prevent suicides among service members, veterans, and families. Collaboration for awareness/prevention/intervention is occurring in all regions of the state along with strong partnership with local coalitions, school districts, and the Nevada Coalition for Suicide Prevention. Some of our most successful initiatives with our partners have been with Signs of Suicide middle and high school suicide awareness curriculum and screening programs statewide, text messaging crisis intervention, safeTALK and Applied Suicide Intervention Skills Trainings. NOSP is staff to Nevada's Committee to Review Suicide Fatalities. NOSP is also making great strides toward increasing awareness about addressing access to lethal means through the Suicide-Proof Your Home, Securing Firearms Education and The 11 Commandments of Gun Safety. Collaboration with Nevada School Districts on education requirements through safeTALK training is occurring in partnership with the Nevada Department of Education. In addition Youth Mental Health First Aid training is in our communities through NOSP and Project Aware. NOSP will coordinate statewide YMHFA training with all Project Aware grantees and community partners.

**Nevada Pregnancy Risk Assessment Monitoring System (PRAMS)**

The Nevada Pregnancy Risk Assessment Monitoring System (PRAMS) is an ongoing survey project of mothers who deliver live births in Nevada. PRAMS is a part of a national effort to reduce infant mortality and adverse birth outcomes by providing information useful for developing and implementing intervention programs and for evaluating existing programs. Data obtained from PRAMS is used to monitor progress toward national and state pregnancy-related health objectives, including Title V maternal and Child Health Priorities. PRAMS is also used to identify and monitor selected self-reported maternal behaviors and experiences that occur before, during, and after pregnancy among women who deliver live-born infants. PRAMS staff collect data through a mailed survey with follow-up of non-respondents by telephone. The PRAMS survey is revised every three to five years, and each revision is referred to as a phase. Nevada is currently using PRAMS Phase 8 questionnaire.

### **Public Health Preparedness Program**

Public Health Preparedness (PHP) assists Nevadans in preparing for public health emergencies and protects the health of all Nevadans and visitors to our state through the prevention of disease, injury and disability. The NTR data are collected from all licensed acute care hospitals and trauma centers in Nevada.

The RCP is responsible for providing health, safety and security functions associated with radioactive materials; radiation-producing machines; mammography; investigation of radiation incidents; radon public information and outreach; education and training of emergency first responders; licensing and oversight of the closed low-level waste disposal site near Beatty, Nevada. RCP also conducts statewide radiological emergency response activities.

## Revenue Management

The Billing Office works directly with NNAMHS, SNAMHS and Rural Clinics to serve as the billing agent for all Behavioral Health services provided to clients. This includes all billing, accounts receivable and denial management processing. Additionally, staff performs rate development for Behavioral Health services, state and federal reporting, projections for fiscal staff and invoicing other state agencies for services provided by Rural Clinics.

The Cost Allocation office works with Program and Fiscal Staff to determine how expenditures are assigned to various cost pools within the behavioral health agencies. This information is used to develop the Cost Allocation Plan which is used as the guide for fiscal staff to determine the coding of expenditures. Additionally, staff assists in identifying Medicaid administrative reimbursable activities, and collaborates with the Division of Health Care Financing and Policy to collect appropriate funds. On the Public Health side, the Cost Allocation office uses financial data to calculate the indirect cost rates for the Division's Public Health programs. Additionally, staff is responsible for the development and management of the Division's time tracking system, submits county assessment data, and provides fee analysis for programs.

## Clinical Services Branch

The Clinical Services Branch is led by Duane Young, who serves as the Deputy Administrator. The primary purpose of Clinical Services is to provide statewide inpatient, outpatient and community-based public and behavioral health services to Nevadans.



Clinical Services Branch is comprised of the following programs and services:

- Lake's Crossing Center (LCC)
- Northern Nevada Adult Mental Health Services (NNAMHS)
- Rural Clinics (RC)
- Southern Nevada Adult Mental Health Services (SNAMHS)
- Stein Forensic Unit
- Oral Health Program

Behavioral Health programs provide behavioral services to individuals with behavioral health disorders across the continuum of care based on their individually assessed biopsychosocial needs. Services are provided on a sliding fee basis and Medicaid, Medicare and most insurance carriers are accepted.

### Behavioral Health Inpatient Services – LCC, NNAMHS, SNAMHS, and Stein

**Psychiatric Hospitalization Services** assist individuals needing a high level of psychiatric care requiring 24-hour observation and supervision by mental health professionals. This service includes comprehensive discharge planning and formal aftercare coordination. Discharge planning meetings are held with family and other support persons to allow individuals to move to least restrictive/community setting as quickly as possible. Length of stay is usually a few days to several months.

### Behavioral Health Outpatient Services – All Agencies (unless otherwise indicated)

**Crisis Intervention (CI) Services** assist individuals in acute psychiatric and/or personal distress to reduce this symptom and improve coping and stabilization to prevent hospitalization.

**Day Treatment Services** are provided in a therapeutic environment to reduce emotional, cognitive, and behavioral problems and improve functioning for community transition and integration. Service available at SNAMHS.

**Medication Clinic/Psychiatric Services** provides medication management and monitoring, medication training and support, health education and pharmacy services to consumers. Clinics are staffed with Psychiatrists, Advanced Practice Nurses, Registered Nurses, Pharmacists and Pharmacy Technicians.

**Mental Health/Behavioral Health Therapy**, provided individually or in a group, is a dynamic, holistic, strengths-based and psychoeducational modality of treatment that is designed to assist an individual in increasing functioning and improving coping strategies to manage symptoms; change distorted thinking patterns; improve communication and interpersonal relationships and learn successful problem-solving techniques.

**Mental Health Court** is a collaboration between each agency and the Criminal Justice system. This program provides opportunity for people with misdemeanor and minor felony criminal charges who would benefit from behavioral health and case management services to be diverted from the standard criminal justice system if they participate in the voluntary program. It is a multidisciplinary treatment model, ensuring consumers obtain benefits, comply with court ordered treatment, medication and substance abuse recovery. Services available at NNAMHS, SNAMHS, and RCHS.

**Mobile Crisis Team (MCT)** is a specialized unit that works with Las Vegas area hospital emergency departments. The Team is comprised of licensed clinical social workers who travel to local emergency rooms (ER) to evaluate patients on involuntary holds and when feasible, develop safe discharge plans to allow the ER to discharge the person back to the community. This service averts unnecessary psychiatric hospitalizations, saves ER personnel time and reduces the numbers of psychiatric patients in the ER. Services available at SNAMHS.

**Mobile Outreach Safety Team (MOST)** is a specialized program staffed with two Licensed Clinical Social Workers from NNAMHS, in collaboration with local law enforcement agencies (Reno, Sparks, and Washoe County) to offer psychiatric services to homeless mentally ill and those with mental illness who bring themselves to the attention of law enforcement. This helps prevent increasing numbers of mentally ill from being housed in the jail and assists with enrolling them in appropriate services. Services available at NNAMHS.

**Psychosocial Rehabilitative Mental Health (RMH) Services** assist consumers in recovering their ability to perform activities of daily living, social activities, relationships and employment related skills. Services include:

**Basic Skills Training (BST):** BST services teach individuals a variety of life skills such as self-care, social, communication, organization, transitional living and time management.

**Consumer Assistance Programs – Peer Support Services:** Peer run programs offering clients the opportunity to connect with others are run by specially trained consumers. Peer Support Services are designed to improve functioning and to help the individuals live, work, learn and participate fully in their communities. These services include peer groups, education, and advocacy. Peer Drop-In Centers are currently available at SNAMHS, NNAMHS, and RCHS.

**Psychosocial Rehabilitation (PSR):** PSR services target psychological functioning within a variety of social settings and may include any combination of the following interventions: behavior management, social competency, problem identification and resolution, effective communication, moral reasoning, identity and emotional intimacy, self-sufficiency, life goals and sense of humor.

**Residential Support**, offered in conjunction with other services, assists those living with severe mental illness to remain in a community living situation. The program includes rent and utility assistance and assistance with activities of daily living based on the individual consumers' particular needs. This program is funded in part by the HUD Shelter Plus Care Grant and also the Olmstead Grant (the Olmstead Grant is received by the Nevada DHHS Director's Office and then given to DPBH through a contractual arrangement). The remaining resources come from general fund. Services available at NNAMHS, SNAMHS, and RCHS.

**Projects for Assistance in Transition from Homelessness (PATH)** assists homeless, or those at risk of becoming homeless, individuals access mental health services, apply for housing assistance, and/or maintain current housing. This program is funded through a grant from the Substance Abuse and Mental Health Services Administration (SAMHSA). DPBH contracts with three private providers throughout the state to meet the program objectives. Service available at: Statewide.

**Service Coordination/Case Management Services** link individuals to needed medical, social, educational, and other community support services. The caseload guideline is 1/35. Services available at NNAMHS, SNAMHS, and RCHS.

**Intensive Service Coordination** is similar to service coordination, but is limited to serving people who have a mental illness and have committed a felony offense, those deemed incompetent to stand trial, as well as those released from the corrections system after they have served their sentence. Clients are provided coordination of care specific to





housing, medication management, obtaining benefits, and community resource assessment. This service is funded primarily with State General Funds. Services available at SNAMHS.

**Program for Assertive Community Treatment (PACT)** is a multi-disciplinary, team-based approach of 24/7 comprehensive and flexible treatment, support and services within the community. Sometimes described as a hospital without walls, this service provides intensive support to people (caseload ratio of 1/12) with mental illness who have a history of high use of emergency, hospital and law enforcement services. The teams work in an interdisciplinary manner to support consumers in living in the community with adherence to their medication program and employment rehabilitation. The PACT team must be composed of at least one qualified mental health professional (QMHP) and one other QMHP, qualified mental health associate (QMHA) or Peer Supporter. PACT is for individuals who have the most serious and intractable symptoms of a severe mental illness and who, consequently, have the greatest difficulty with basic daily activities, keeping themselves safe, caring for their basic physical needs or maintaining a safe and affordable place to live and require interventions that have not been effectively addressed by traditional, less intensive services. Services available at NNAMHS and SNAMHS.

**Co-occurring Disorders Programs** for individuals who have both substance abuse and mental health treatment needs, may receive specialized services that address both disorders. This treatment is provided in an outpatient setting and may include individual and group therapy. Treatment may be provided within a specific mental health program or may be coordinated with additional treatment providers in the community, including SAPTA-funded agencies.

**Community Triage Centers** are operated by a private non-profit provider, and funded through a cooperative agreement between DPBH, the counties in which they operate (Washoe in the north, and Clark in the south), and local hospitals. The centers provide short-term (maximum three day) residential and medical services primarily for individuals with alcohol/substance abuse problems. The purpose of the centers is to serve as an alternative to local emergency rooms for individuals who do not meet the criteria for involuntary commitment but require brief detoxification and assessment/referral for co-occurring disorders.

**Forensic Mental Health Services** at the Lake's Crossing Center (LCC) and Stein Forensic Unit provides statewide forensic mental health services in a maximum security facility to offenders who are referred from the court system so their competency can be restored. LCC and Stein are Nevada's only facilities for this purpose and, therefore, serve people from throughout the state. On the DPBH Campus in Sparks, evaluations are done to determine capacity for restoration of legal competency to stand trial and for treatment of clients adjudicated Not Guilty by Reason of Insanity (NGRI) so they may return safely to the community. LCC staffs the Sex Offenders' Certification Panel and the Community Tier Reconsideration Panel with a licensed Psychologist. LCC is also charged with certifying all Forensic Examiners throughout the state.

**Psychiatric Residency** is run in conjunction with the University of Nevada School of Medicine. Residents in psychiatry complete educational and clinical practice rotations at the Dini Townsend and Rawson Neal Hospitals, as well as in SNAMHS outpatient clinics. Most of the psychiatrists who work at these facilities are former residents. Services available at NNAMHS and SNAMHS.

### Community Health Nursing

Community Health Nursing (CHN), as the sole provider of public health nursing in Nevada's 10 frontier and rural counties, endeavors to promote optimal wellness through the delivery of public health nursing, preventive health care, and health education.

Each Community Health Nursing clinic offers a variety of services including nursing services to residents of all ages and incomes. The community health nurses provide services in 13 locations. Each clinic provides services at a low cost or uses a sliding scale dependent upon income. CHN does not deny services due to inability to pay. The clinics accept self-pay, private insurance, Medicaid and Medicare.



CHN provides essential public health services such as immunizations, well child exams, breast and cervical cancer screenings, sexually transmitted disease prevention and treatment, and men and women reproductive health services an area of responsibility of over 96,000 square miles. The nurses average 1,000 miles per month of traveling throughout the rural counties to serve residents in the state of Nevada. Community Health Nursing has earned a reputation of reliability and is a trusted source for healthcare for rural populations within Nevada.

### **Services Provided**

The Community Health Nursing program offers a variety of services to residents of all ages in rural Nevada. Residents are asked to check with their local clinic for available services in their area and to schedule appointments.

### **Lake's Crossing Center for Mentally Disordered Offenders**

Lake's Crossing Center (LCC) is Nevada's first forensic psychiatric facility. The program provides inpatient and outpatient services statewide to individuals involved with the criminal justice system who have concurrent mental health issues. The biggest portion of the population served is individuals for whom there is a question of their competency to stand trial and who may need restoration to competency so they can proceed with their adjudication. Approximately 850 outpatient evaluations are performed by the clinical staff annually to determine whether individuals referred by the courts from the counties need to be committed for restoration. LCC performs all pre-commitment evaluations for the state except for Clark County, which contracts with private providers. When a need for restoration is determined, defendants are sent to LCC for restoration. Approximately 230 defendants a year are provided those inpatient services. The program also treats individuals who are found Not Guilty by Reason of Insanity and those who cannot be restored to competency and are too dangerous to be committed to the civil hospitals. Some



of these individuals are successfully treated to qualify for conditional release in the community where they are supervised by LCC caseworkers. Eventually, if they are successful in treatment, the court may discharge them from supervision. Lake's Crossing also provides staff for the Community Tier Notification Review Panel and other community education and service projects such as trainers for the Crisis Intervention Teams. LCC is largely funded by state general funds, with a small amount coming from county reimbursements. LCC also provides fee-based assessments to consumers in detention facilities.

**Northern Nevada Adult Mental Health Services (NNAMHS)**

NNAMHS occupies part of 92 acres deeded to Nevada in the 1800s for the benefit of the mentally ill and intellectually disabled. Located adjacent to the Truckee River in Sparks, Nevada, it shares sculpted grounds with Lake's Crossing Center, the State Forensic Hospital, and Sierra Regional Center, the treatment center for the intellectually disabled. NNAMHS is a comprehensive, community-based, behavioral health system for adult consumers. Inpatient services are provided through Dini-Townsend psychiatric hospital, located on the same campus as the central NNAMHS site. Numerous outpatient services are available which include but are not limited to the Washoe Community Mental Health Center, Outpatient Pharmacy, Program of Assertive Community Treatment (PACT), Psychosocial Rehabilitation Program, Medication Clinic, Service Coordination, Mental Health Court, Residential Programs, and Mobile Outreach Services Team (MOST).

### Rural Community Health Services (RCHS)

Rural Clinics Administration provides oversight authority for two agencies:

- Rural Clinics (RC) – provides a full array of outpatient behavioral health services for adults and children in 16 clinics in 12 counties across Rural Nevada (see below). CHS provides essential public health and nursing services, including: immunizations, HIV/AIDS services, School health services, well-child services, breast and cervical cancer screenings, dental health, sexually transmitted disease prevention and treatment, and reproductive health/family planning services for both men and women. Nursing personnel in CHS support behavioral health services provided by Rural Clinics.

As an organization, services provided by agencies within Rural Clinics Administration will not be denied based on ability to pay, and people will be assessed for their payment responsibility based on a sliding fee scale. Additionally, self-pay, private insurance, Medicaid and Medicare are accepted.

## **Southern Nevada Adult Mental Health Services (SNAMHS)**

SNAMHS provides inpatient and outpatient services for adults living in Clark County and adults, children and adolescents in four southern rural communities – Pahrump, Mesquite, Caliente and Laughlin. Inpatient services are provided on the main SNAMHS campus located at 6161 West Charleston Boulevard, Las Vegas. There are three hospital buildings on the campus designed to provide services for adults with mental illness. The three buildings are the Rawson Neal Hospital Building, the 3A Hospital Building and the Stein Hospital Building. Currently the hospital buildings serve the civil population. In 2015, the Stein hospital building will also serve the forensic population for adults. The campus is co-located with the state hospital for children and adolescents and with the southern facility



for the intellectually disabled, Desert Regional Center. SNAMHS has seven behavioral health clinics serving the community and rural southern Nevada. There are three urban clinics serving the Las Vegas Valley and four rural clinics serving Nevada's southern rural areas. SNAMHS services include, but are not limited to, Inpatient Acute Psychiatric, Mobile Crisis, Outpatient Counseling, Service Coordination, Intensive Service Coordination, Medication Clinic, Residential Support Programs, Mental Health Court, Peer Support Programs and Programs for Assertive Community Treatment (PACT) Teams.
