Chair Pennell opened the meeting at 9:00 a.m.

Roll call was taken and it was determined that a quorum of the State Board of Health was present.

Approval of Minutes:

Chair Pennell asked if there were any additions or corrections to the minutes from the March 8, 2019 or June 19, 2019 meetings. No recommendations were made.

Public Comment: There was no public comment.

A motion was made to approve the minutes by Dr. Murawsky, seconded by Dr. Shah and carried to approve the minutes of March 8, 2019 and June 19, 2019.

Consent Agenda:

Consideration and approval of 2019 Proposed Regulation Amendments to Washoe County Health District's Food Establishments pursuant to NRS 439.366(3)

Consideration and appointment of Erik Jimenez to the Nevada Office of Minority Health and Equity (NOMHE) Advisory Committee

Public Comment: There was no public comment.

CHAIR PENNELL ENTERTAINED A MOTION ON ITEM 3, CONSENT AGENDA. A MOTION BY DR. MURAWSKY TO APPROVE THE CONSENT AGENDA WAS MADE AND SECONDED BY DR. SHAH; THE MOTION PASSED UNANIMOUSLY.

Approval of 2020 Board of Health Meeting Dates:

A motion was made to approve the meeting dates by Dr. Murawsky, seconded by Dr. Shah and carried to approve the 2020 meeting dates.

Update on Sentinel Events according to NRS 439.843:

Mr. Wellman informed the definition of sentinel events is defined by Assembly Bill 28 effective October 1, 2013. It refers to the National Quality Forum definition and it lists various events which result in permanent harm or death. Currently the list of reporters includes hospitals, obstetric centers, surgical centers for ambulatory patients and independent centers for emergency medical care. The data collection methods are event report forms and summary annual report forms. The top two sentinel event types are pressure ulcer and falls. The locations where sentinel events occurred the most are medical/surgical and intensive/critical care. There have been fewer counts among youth and children compared to 2017. New metrics added were sentinel events versus patient discharges and comparison of Nevada's program to nearby states. The Sentinel Events Registry uses the Research Electronic Data Capture Application system to gather information. There is a new workgroup focusing on the implementation of Senate Bill 457 which will expand the definition of reporters from medical facility to health care facility and expand the levels of reporting from 150 facilities to approximately 1500. In conclusion, most facilities are earnestly attempting to implement the sentinel events registry mandate and are complying to the best of their ability.

Dr. Murawsky thanked the program for the detailed report. Dr. Murawsky commended Mr. Wellman for the addition of chance of an event by discharge and sentinel events per discharge. It provides a new level of insight and will continue to be important with the expansion of the definition to adding more health care facilities. Dr. Murawsky thinks there is still opportunity to look at the weight of sentinel events per discharge in the geographic tables.

Mr. Wellman replied they would research the suggested metric and see how it can be presented.

Reports:

Nicki Aaker, Director of Carson City Health and Human Services (CCHHS)- Ms. Aaker reported CCHHS has completed the 2018 Annual Report. (Exhibit "A") CCHHS is working on their strategic plan and should be completed this month. A presentation about vaping was conducted to Carson City's School District School Nurses. Staff presented to Carson City's Parks Commission and Open Space about smoke-free parks. A Back to School immunization event was conducted during the week of August 12-19. Ms. Aaker reported there was a 7% decrease in Title X funding. A transportation pilot program was launched using Uber health in collaboration with Carson Tahoe Hospital. A pocket resource guide has been developed for the community. Columbia Suicide Screening has been adopted and training was conducted. The contract for Carson City to provide Environmental Health Services in Douglas County was approved for another 3 years. Pulse Point has been implemented in Carson City and Douglas County. Pulse Point is an application the public can install on their smart phones which alerts individuals of the need for Cardiopulmonary resuscitation (CPR) trained citizens to go to a cardiac arrest situation and perform CPR until the paramedics arrive on scene.

Kevin Dick, District Health Officer for Washoe County Health District (WCHD)- Mr. Dick reported the WCHD received accreditation from the Public Health Accreditation Board. Two confirmed cases of Hantavirus were reported. The written report provides updates on immunization statistics and history. Mr. Dick reported there have not been any confirmed human cases of West Nile Virus. Emergency Preparedness Funds were utilized to purchase radiological detection protection equipment and shared with some of the law enforcement partners. WCHD has acted with businesses to cease adding cannabinoids to food products. WCHD has coordinated with DPBH and other local health authorities in having a consistent approach to cannabinoids in food products.

Dr. Joseph Iser, Chief Health Officer for Southern Nevada Health District (SNHD)- Dr. Iser reported a conference will be held at the end of the month to provide education on tuberculosis. The first academic health department conference in the nation for the Western organizations will be held in December. With the recent hepatitis A outbreak, SNHD continues to administer vaccinations. Clark County has experienced an influx of West Nile Virus cases. The SNHD has been accredited for the preventive medicine residency program. The health districts are concerned with the epidemic in vaping disease and death. Dr. Iser informed the Health District is in the final phase of accreditation.

Ms. Sherych introduced herself as the new Administrator for the Division of Public and Behavioral Health.

Recommendations for future agenda items:

No recommendations were made.

Public Comment:

Jessica Padron, Office of Minority Health- Ms. Padron introduced herself and stated she works with Tina Dortch in the Office of Minority Health. Ms. Padron informed it is important for their Board to grow and have all diversity included. The expanded scope includes rural communities, aging population, and individuals in underserved communities. Ms. Padron thanked the Board for all they do.

The meeting adjourned at 9:48 a.m.

CCHHS is Nevada's first and only accredited health department through the Public Health Accreditation Board (PHAB).

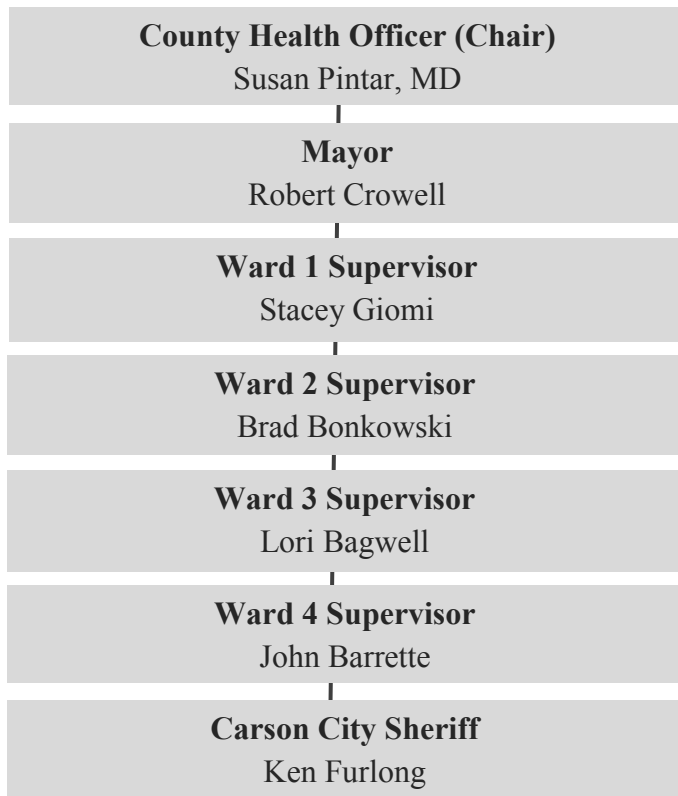
CCHHS is a department of the Carson City, Nevada Government, a consolidated municipality. CCHHS also provides some services in adjoining counties.

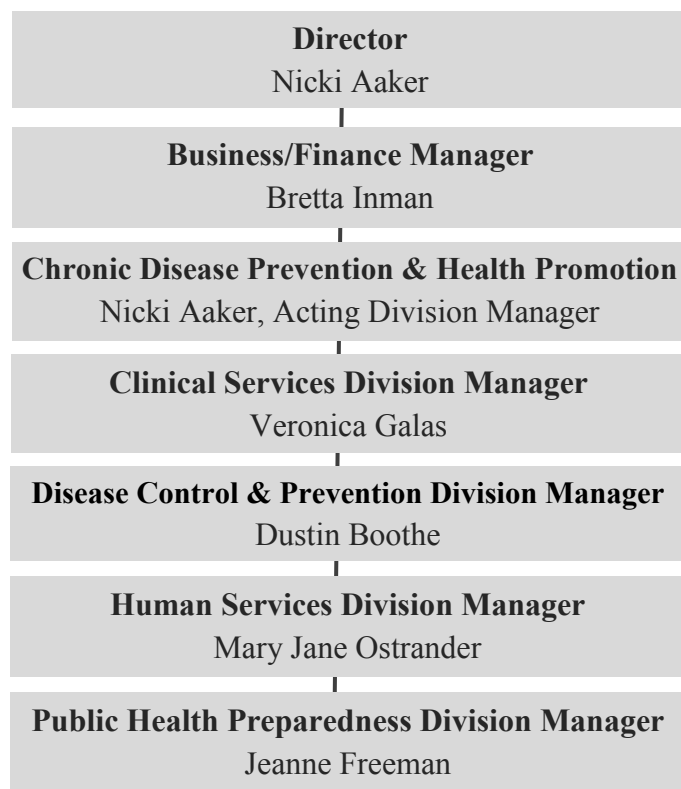

Public health works to make your community healthy.

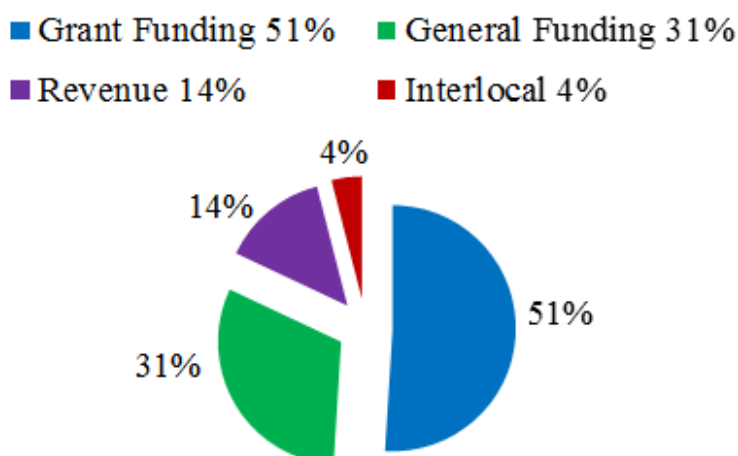
CCHHS takes our role of promoting and protecting our community's health very serious. CCHHS employees are committed to serving Carson City residents and surrounding areas in a professional, effective, and efficient way. As part of our commitment, CCHHS applied to be and is the first Accredited Health Department in Nevada. This means our practices have been evaluated against national standards and measures. CCHHS promotes a culture of continually evaluating our performance in providing public health services, also known as performance management or quality improvement.

CCHHS Funding Overview: FY 2018

CCHHS' funding is comprised mainly of grants (51%). These grants are federal and state government grants. Thirty-one percent (31%) is received from Carson City's General Fund. CCHHS is a city department. Revenue (14%) is received from health permits, along with health insurance billing for services provided to clinic patients. Four percent (4%) of the funding is a contract with Douglas County to provide restaurant inspections, plan reviews, and other duties.



Chronic Disease Prevention & Health Promotion Division

Adolescent Health

In 2018, the **Sexual Risk Avoidance Education (SRAE)** evidenced-based program was given to help young people get the information and tools they need to avoid unplanned pregnancy and sexually transmitted diseases (STDs). The program focused on puberty, abstinence, peer pressure, STDs, and pregnancy. In 2018, the program served:

573 youths

The **Personal Responsibility Education Program (PREP)** is an evidence-based program that helps to: delay sexual activity among youth, increase condom and contraceptive use for sexually active youth, and lower pregnancy among youth. The program served:

232 youths

The **Families Talking Together (FTT)** evidenced-based parent intervention training helps teach parents how to talk to their youth about sex, gives parents information on STDs and pregnancy myths, and addresses reasons why parents don't talk to their youth. The training served:

37 parents

Diabetes Outreach

In 2018, CCHHS received a Prediabetes Outreach grant to fund pre-diabetes screenings and outreach. The pre-diabetes screenings were held at the Ron Wood Family Resource Center food bank and the Carson Valley Community Food Closet. At the Ron Wood Family Resource Center:

23.5% of people screened were at risk for pre-diabetes

The pre-diabetes outreach focused on health care providers (HCPs). CCHHS gave HCPs toolkits, presentations, and education materials to help HCPs better understand pre-diabetes and diabetes for their patients. HCPs were also shown how to find diabetes prevention and diabetes self-management courses, as well as find information on Medicare and Medicaid payment options.

Tobacco Control & Prevention

CCHHS' tobacco control and prevention program raises awareness about smoking and tobacco-related issues.

Eighty percent (80%) of our population **does not smoke**. The four major goals of the program are to: 1) prevent youth initiation of smoking, 2) promote cessation among youth and adults, 3) eliminate secondhand exposure, and 4) eliminate health disparities.

Youth e-cigarette tobacco use in 2018 has been called an epidemic by the Surgeon General. In Carson City and Douglas County high schools:

50% of students have tried an e-cigarette
20% use e-cigarettes regularly

CCHHS' Ryan White Retention in Care Program locates individuals with HIV/AIDS who are no longer receiving medical care or are newly diagnosed within Nevada. This program focuses on the rural counties. The Treatment Adherence Counselor locates these individuals, identifies struggles the individual is facing, then helps get them into medical care. In 2018, the program served:

356 clients, mainly within the 55-64 age range

24 clients were provided transportation services

Clinical Services Division

Family Planning

In 2018, Clinical Services held **2,628** screenings in women of child-bearing age. These screenings led to information, counseling, and referrals for:

1,334 users of alcohol

407 substance abusers

318 women with depression

47 women affected by intimate partner violence

Clinical Services also partnered with the Division of Welfare and Social Services (DWSS) to help:

526 families apply for Medicaid insurance

Well-Child Check-Up Exams

Clinical Services gives well-child check-up exams to children ages 0-12 years. These check-ups include a full physical exam, a review of healthy eating habits, and childhood vaccines. In 2018, clinical services well-child exams and WIC hemoglobin checks had:

103 patients

105 visits

Immunizations

Clinical Services gives childhood and adult vaccines, such as: TDAP (Tetanus, Diphtheria, and Pertussis); MMR (Measles, Mumps, and Rubella); Hepatitis A, Hepatitis B, Twinrix (combined Hepatitis A and B), Seasonal Influenza (flu shot and nasal spray); H1N1 Influenza, Varicella (Chicken Pox); Meningococcal (Meningitis); HPV (Human Papilloma Virus); Zoster (Shingles, for adults ages 60 years and older); and more. In 2018, Clinical Services had and gave:

2,064 patients

4,198 vaccines

2,316 individual patient visits

STD Testing & Treatment

In 2018, Clinical Services gave **1,524** Chlamydia tests. Chlamydia is the most common reported STD in Carson City and Douglas County. Chlamydia can cause pelvic inflammatory disease, ectopic pregnancy, and infertility. In the Carson City and Douglas County areas*:

89% of all STDs diagnosed are Chlamydia

80% of Chlamydia diagnoses are in people ages 25 years and younger

36% of all STDs were diagnosed by public health family planning clinics

Services and Patient Portal

Clinical Services helps all patients, regardless of insurance status or income. Services offered include: immunizations, well-women exams; pap smears; breast exams; referrals to mammography; birth control and family planning; sexually transmitted diseases (STDs) and HIV testing; vaccines for all ages; TB testing and reading; and well-child exams. In 2018, the clinic had:

5,058 patients

9,863 individual patient visits

Disease Control & Prevention: Environmental Health Division

The major focus areas of the CCHHS Environmental Health Division include:

- Food protection
- Individual sewage disposal systems
- Private wells
- Public swimming pools
- Public accommodations
- Vector control
- Public and private schools
- School and childcare
- Invasive body decoration and permanent makeup (tattoos and piercings)

Food Safety Grading System

Keep an eye out for our new Food Safety Grade Placards! The placards are part of the department's new food inspection grading system, which helps alert the public to an establishment's food safety compliance.



The new grading system, which uses A, B, and C placards, has lowered the number of follow-up inspections. Establishments who fail to earn an A grade are likely to fix all violations by the first follow-up visit.

Score	Grade
0 - 10	"A"
11 - 20	"B"
21 - 40	"C"
≥ 41	"Closure"

Violations fall into three categories:

High Risk Factor – Critical = 5 points
High Risk Factor – Minor = 2 points
Low Risk Factor – Minor = 0 points

The points for a violation depend on the health risk to the public. The lower the score, the better the grade. For information, visit:

Establishments/Violations

Establishments: CCHHS leads food service facilities inspections for restaurants, schools, and day care centers in both Carson City and Douglas County.

In 2018, Carson City had 443 food establishments and Douglas County had 618 food establishments (1,061 total food establishments). The exact number of establishments changes often as establishments open and close.

Of these food establishments, staff conducted **698** inspections within Carson City and **697** inspections in Douglas County. The number of inspections is higher than the total number of establishments because the number of inspections for an establishment depends on the type of food service, the customer base, and the inspection history.

Violations: Of the **698** Carson City and **697** Douglas County scored compliance inspections:

293 violations were reported in Carson City

Food establishment inspections are made to lower risk factors for foodborne illnesses such as:

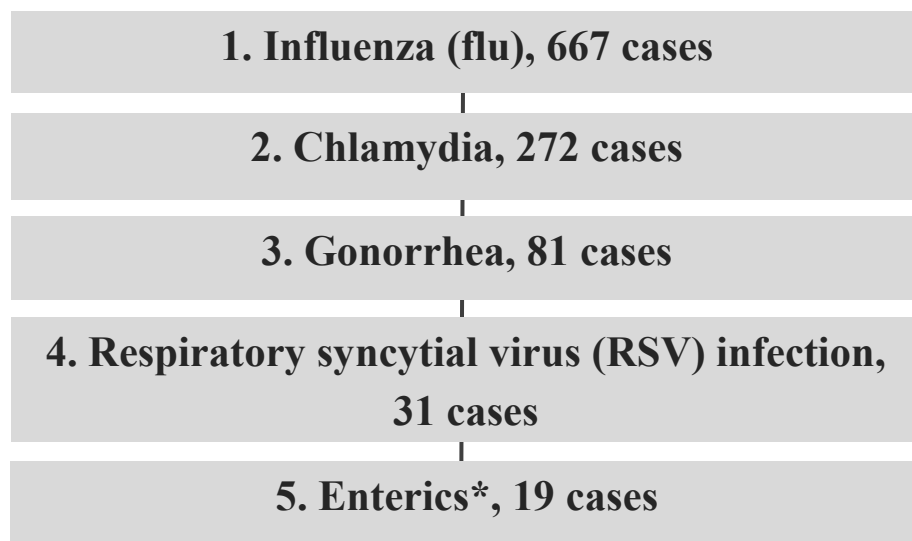
- Food from unsafe sources
- Unsafe cooking temperatures
- Unsafe holding temperatures
- Unclean or contaminated equipment
- Poor employee hygiene



Disease Control & Prevention: Epidemiology Division

The Epidemiology program staff is responsible for the investigation of cases, clusters, outbreaks, and suspected cases of reportable diseases. The staff is also responsible for tracking and reporting more than 70 notifiable conditions to the State of Nevada, Division of Public and Behavioral Health (DPBH). The staff works to control the spread of disease in the community by processing data requests and providing health advice, training, education, and outreach. This information is provided to other public health staff, hospital staff, physicians and other health care providers, school and day care center staff, and other members of the community.

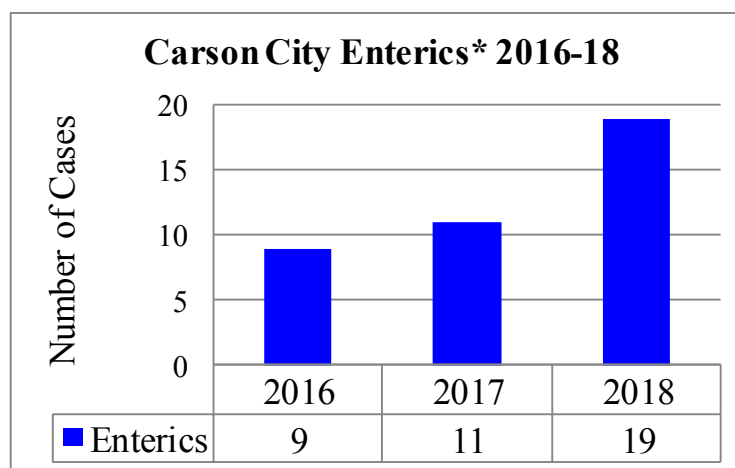
Top 5 Most Reported Conditions in 2018*

In Carson City, cases of foodborne illness increased

71% from 2016 to 2019. No known outbreaks were associated with this increase.

Human Services Division

Support Services

Emergency Solutions Grant (ESG): Works as a rehousing program that gives case management to help families stay in permanent housing.

Shelter Plus Care (SPC): Works as a rehousing program for the chronically homeless who have a disability.

Low Income Housing Trust Fund (LIHTF): Works closely with the ESG program and provides rent assistance. In addition, LIHTF helps with homeless prevention.

Welfare Set Aside: Allows CCHHS to provide households one-time financial help with rent and/or security deposits.

Utility Assistance: Provides electric and gas help on current bill (one time in a 12-month period).

Women, Infants and Children



Women, Infants and Children (WIC) is a federally funded health and nutrition program for women, infants, and children. CCHHS has two WIC clinics—one in Carson City and one in Douglas County. In 2018, the WIC program served: **1,589** patients.*

*This is an unduplicated number. Patients are seen multiple times per year.

294 women served in Carson City

161 women served in Gardnerville

328 infants served in Carson City

172 infants served in Gardnerville

380 children served in Carson City

254 children served in Gardnerville

Workforce Development

Community Services Block Grant (CSBG): Helps unemployed individuals with getting and maintaining employment. In addition, provides direct services for individuals with identification, transportation, and work clothing/equipment needs.

Life Skills Workshops: Workshops focus on healthy eating tips, financial skills, job readiness skills, and healthy relationships.

217 participants have joined the workshops

Employment Readiness Assistance: Helps individuals with resume building, interview skills, job searching methods, and job readiness.

107 individuals have used the program

Onsite Health Services

Carson City's Aging and Disability Resource Center: Helps make customized care and support plans for older adults, people with disabilities, and their caregivers and family members.

Nevada State Welfare Division Eligibility Workers: CCHHS is a hosting site for Nevada State Welfare Division Eligibility Workers. Individuals without health insurance can be helped at CCHHS and enroll in Nevada Medicaid and Nevada SNAP programs.

448 residents have used the programs

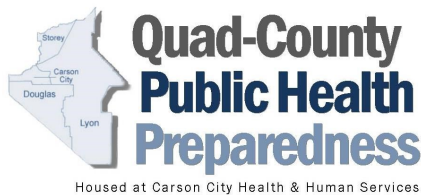
Northern Nevada Center for Independent Living: Works one-on-one with individuals to help them achieve their independent living goals and provides most community service at little to no cost.



Public Health Preparedness Division

What is PHP?

Public Health Preparedness (PHP) is the process of planning and creating programs to respond quickly and effectively to threats that impact the health of the public. The Quad-County PHP division works with community partners, neighboring counties, and the state to assure the most effective response possible to disease outbreaks, public health threats, and other emergencies.



CASPER Survey Data

Carson City was the first jurisdiction to conduct a Community Assessment for Public Health Emergency Response (CASPER) door-to-door survey. The survey was done in partnership with Emergency Management (EM) and Law Enforcement personnel. The survey helped EM and PHP learn how prepared residents are for an emergency. The information will help Carson City leaders and residents become better prepared for future emergencies or disasters.

AFN Support Team

Quad-County PHP, in partnership with the Washoe County Health District, formed an Access & Functional Needs (AFN) Support Team. AFN refers to people who are or have:

- Physical, developmental, or intellectual disabilities
- Chronic conditions/injuries
- Limited English proficiency
- Older adults or children
- Low income, homeless, and/or dependent on public transit



Over this past year, the PHP team gave four AFN trainings across the State to improve AFN response in an emergency. There are currently **38** people signed up to serve on the team!

Coalition Surge Test

PHP planned a No-Notice Coalition Surge Test with community healthcare partners to test the ability to evacuate patients from multiple facilities at the same time. Over 15 different agencies participated from across the quad-county region including hospitals, long-term care facilities, EMS, emergency management, public health, skilled nursing facilities, and surgery centers. Overall, the test measured the preparedness and response of health care facilities and EMS partners in the region.



Drive-Thru POD Exercise

In partnership with Carson City Emergency Management, EMS, Carson City Fire Department, Public Works, Carson City Sheriff's Office, and the HOSA program at Carson High School, more than 80 volunteers and CCHHS staff held a drive-thru Point of Dispensing (POD) exercise in October 2018. This was done to practice emergency response time and to test Carson City's ability to give out medications during a disaster. The drive-thru POD exercise was done as a flu clinic. CCHHS staff worked with Carson City and Douglas County community partners and schools

to give **3,949** total flu vaccines, with:

1,344 vaccines given at community events

1,711 vaccines given at Carson City schools

894 vaccines given at Douglas County schools



Performance Management

Performance Management Team

CCHHS Performance Management Team (PMT) is composed of five program-level staff, all from different divisions of the organization, plus the Health Department Director. By having representatives from different divisions at the table, PMT members are able to advise co-workers on quality improvement projects in their day-to-day activities, along with projects in different divisions.

Quality Improvement

The leadership of CCHHS encourages quality improvement in every division. CCHHS has a Quality Improvement Plan that serves as guidance for quality improvement projects. Quality improvement is a very important component of Public Health Accreditation. The plan is updated annually and describes the process for projects. Projects can be short or very lengthy.

- Reduction of Patients Not Showing Up for Their Appointment Within the Family Planning Clinic
- Use of the Electronic Health Record's Patient Portal Within the Clinic
- Use of a Community Health Worker (CHW) in the Human Services Housing Program
- Ryan White's Customer Satisfaction Survey
- Making the Clinic Teen Friendly
- Making the Lobby Safe for Staff and Clients



Training

CCHHS has a Staff Development Committee that finds out which trainings are required and are requested by staff. Every other month there is an All Staff Training Hour in the morning. This gives staff an opportunity to learn from experts within the Health Department and others within our community on very important topics. In addition, this committee has organized “Lunch & Learns” for staff.
