MEMORANDUM

Re: Consideration and adoption of proposed regulation amendments, LCB File No. R052-16
Amendments to Nevada Administrative Codes (NAC's) 392.105, 394.250 and 441A.755.

Purpose of Amendment

The purpose of the amendment is to add immunization against *Neisseria meningitidis* (e.g., *meningococcal disease* or *meningitis*) as a requirement for 7th grade public and private school enrollment in Nevada. As meningitis is a serious communicable disease among adolescents, it is important Nevada students receive age-appropriate protection through vaccination prior to entering school. A 7th grade entry requirement is consistent with Centers for Disease Control and Prevention (CDC) dosing recommendations at 11-12 years. An amendment will also change the college immunization requirements for *N. meningitidis* to remove the "on-campus housing" stipulation. All college students have a greater risk for encountering and contracting meningococcal disease than the general population, regardless of their housing situation; therefore, all incoming college students should receive age-appropriate meningococcal vaccination prior to attendance.

Summary of Changes to Nevada Administrative Code (NAC)

The proposed amendments accomplish the following:

- Declares *N. meningitidis* to be a communicable disease;
- Prohibits a child from being enrolled in grade 7 in a public or private school unless immunized against *N. meningitidis* after the student obtains 10 years of age;
- Prohibits certain persons from attending a university until the person submits to the university proof of immunity to *N. meningitidis*;
- Provides exceptions to such prohibitions; and
- Provides other matters properly relating thereto.

Possible Outcome if Proposed Amendment is Not Approved

A risk of communicable disease outbreaks due to meningococcal infection exists as long as students go unvaccinated. The case-fatality ratio is 10-15% even with timely and appropriate antibiotic therapy and as many as 20% of survivors have permanent issues such as hearing loss, neurologic damage or loss of limbs. The incidence of disease in the U.S. is relatively low; however, a peak in disease incidence among adolescents and young adults 16-21 years of age has persisted, even after routine vaccination of adolescents was recommended in 2005. The majority of cases occur in the adolescent and young adult population, making timely and appropriate vaccination of this population an important public health endeavor. Currently, 23 states and the District of Columbia include a meningococcal immunization mandate for middle school entry and 37 states have a college-entry mandate. The most effective method for ensuring appropriate immunization coverage levels in a population is to link immunization with school enrollment/entry.

Applicability of Proposed Amendment

These regulations will apply statewide to public and private primary schools and the state's two Universities.

Public Comment

On May 9, 2016 a Small Business Impact Questionnaire, along with a copy of the proposed regulation changes, was sent to each public school district, private school and university statewide. Of the nine (9) responses received, seven (7) had no comment to any adverse or beneficial impact. One respondent indicated an adverse economic effect upon their business; they estimate that they may lose tuition for up to two students due to the new requirement. Another respondent indicated an adverse economic effect due to additional staffing costs to comply with screening student records, as well as their personal belief that vaccines are not advisable. The beneficial effect of these regulations is to reduce vaccine-preventable disease in school-age and college-age populations. The adverse effects include additional staff time to check for the newly required immunization and possible increased record-keeping requirements for universities.

The Division of Public and Behavioral Health used methods to reduce the impact of proposed regulations on small business including discussions with stakeholders, parent and provider focus groups, and distribution of the small business impact questionnaire to gather input from stakeholders on how the proposed regulation(s) may impact their business. Nevada public school districts, private schools and universities were given the opportunity to discuss the economic impact the proposed regulations may have. No modifications to the proposed regulations have been made as a result of this input. The Division of Public and Behavioral Health has reviewed all school immunization regulations and has been unable to identify any adverse impacts on small businesses.

June 30, 2016: A public workshop was held on the proposed regulations at the Division of Public and Behavioral Health located at 4150 Technology Way, Hearing Room 303, Carson City; video conferenced to the Desert Meadow Area Health Education Center in Las Vegas at 3050 E. Flamingo Rd.; and a teleconference line was available for all other commenters.

One verbal statement of support was received during the public workshop, and three letters of support were received via e-mail prior to the workshop. No opposition was received during the public workshop, either verbally or in writing. No recommendations for language changes were received during the public workshop. Minimal to no opposition is anticipated for the public hearing with the Board of Health.

Staff Recommendation

Staff recommends the State Board of Health adopt the proposed regulation amendments to NAC's 392.105, 394.250 and 441A.755 as presented in LCB File No. R052-16.

EXPLANATION – Matter in *italics* is new; matter in brackets ~~[omitted material]~~ is material to be omitted.

AUTHORITY: §1, NRS 392.435 and 439.200; §2, NRS 394.192 and 439.200; §3, NRS 441A.120.

A REGULATION relating to communicable diseases; prohibiting a child from being enrolled in grade 7 in a public or private school unless the child has been immunized against *Neisseria meningitidis* after he or she obtained 10 years of age; prohibiting certain persons from attending a university until the person submits to the university proof of immunity to *Neisseria meningitidis*; providing exceptions to such prohibitions; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law authorizes the State Board of Health to adopt regulations to define and control dangerous communicable diseases. (NRS 439.200)

Existing law generally requires that a child be immunized against certain diseases, including, without limitation, such diseases as the Board or the local board of health may determine, before enrollment in a public or private school. (NRS 392.435, 394.192)

Existing regulations categorize certain diseases as communicable diseases and set forth requirements concerning a child's immunization against such diseases for the purpose of enrollment in a public or private school. (NAC 392.105, 394.250) **Sections 1 and 2** of this regulation categorize *Neisseria meningitidis* as a communicable disease and provide that a child may not be enrolled in grade 7 in a public or private school, respectively, after June 30, 2017, unless the child has been immunized against *Neisseria meningitidis* after he or she obtained 10 years of age. **Sections 1 and 2** further provide that such a requirement does not apply to a child who is excused because of religious belief or medical condition or who is enrolled in a public or private school, respectively, before July 1, 2009.

Existing law requires the Board to adopt regulations governing the control of communicable diseases in this State, including regulations specifically relating to the control of such diseases in educational, medical and correctional institutions. (NRS 441A.120)

Existing regulations prohibit, with certain exceptions, a person who is less than 23 years of age and is enrolled as a freshman at a university from residing in on-campus housing after

September 1, 2008, until he or she submits to the university proof of immunity to *Neisseria meningitidis*. (NAC 441A.755) **Section 3** of this regulation instead prohibits such a person from attending a university until he or she submits proof to the university of such immunity. **Section 3** also requires the Division of Public and Behavioral Health of the Department of Health and Human Services to establish the immunization schedule required for admission of such a person.

Section 1. NAC 392.105 is hereby amended to read as follows:

392.105 1. The State Board of Health hereby declares the diseases of:

- (a) Mumps;
- (b) Hepatitis A;
- (c) Hepatitis B;
- (d) Varicella; ~~{and}~~
- (e) Bordetella pertussis if a child is 6 years of age or older ~~{}~~; *and*
- (f) *Neisseria meningitidis*,

↳ to be communicable diseases.

2. Unless excused because of religious belief or medical condition, a child may not be enrolled in a public school in this State unless the child has been immunized against the mumps.

3. Except as otherwise provided in subsection ~~{5,}~~ 6, unless excused because of religious belief or medical condition, a child may not be enrolled in a public school in this State:

(a) After June 30, 2002, unless the child has been immunized against hepatitis A and hepatitis B; and

(b) After June 30, 2003, unless the child has been immunized against varicella.

4. Unless excused because of religious belief or medical condition, a child may not be enrolled in grade 7 in a public school in this State after June 30, 2008, unless the child has been immunized against Bordetella pertussis. To satisfy the requirements of this subsection, a child

must receive at least one dose of a vaccine against Bordetella pertussis after he or she obtained 10 years of age.

5. *Except as otherwise provided in subsection 6, unless excused because of religious belief or medical condition, a child may not be enrolled in grade 7 in a public school in this State after June 30, 2017, unless the child has been immunized against Neisseria meningitidis after he or she obtained 10 years of age.*

6. The provisions of:

(a) Paragraph (a) of subsection 3 do not apply to a child who is enrolled in a public school in this State before July 1, 2002. ~~{; and}~~

(b) Paragraph (b) of subsection 3 do not apply to a child who is enrolled in a public school in this State before July 1, 2003.

(c) *Subsection 5 do not apply to a child who is enrolled in a public school in this State before July 1, 2009.*

Sec. 2. NAC 394.250 is hereby amended to read as follows:

394.250 1. The State Board of Health hereby declares the diseases of:

(a) Mumps;

(b) Hepatitis A;

(c) Hepatitis B;

(d) Varicella; ~~{and}~~

(e) Bordetella pertussis if a child is 6 years of age or older ~~{;}~~ ; and

(f) Neisseria meningitidis,

↪ to be communicable diseases.

2. Unless excused because of religious belief or medical condition, a child may not be enrolled in a private school in this State unless the child has been immunized against the mumps.

3. Except as otherwise provided in subsection ~~{5,}~~ 6, unless excused because of religious belief or medical condition, a child may not be enrolled in a private school in this State:

(a) After June 30, 2002, unless the child has been immunized against hepatitis A and hepatitis B; and

(b) After June 30, 2003, unless the child has been immunized against varicella.

4. Unless excused because of religious belief or medical condition, a child may not be enrolled in grade 7 in a private school in this State after June 30, 2008, unless the child has been immunized against Bordetella pertussis. To satisfy the requirements of this subsection, a child must receive at least one dose of a vaccine against Bordetella pertussis after he or she obtained 10 years of age.

5. *Except as otherwise provided in subsection 6, unless excused because of religious belief or medical condition, a child may not be enrolled in grade 7 in a private school in this State after June 30, 2017, unless the child has been immunized against Neisseria meningitidis after he or she obtained 10 years of age.*

6. The provisions of:

(a) Paragraph (a) of subsection 3 do not apply to a child who is enrolled in a private school in this State before July 1, 2002. ~~{; and}~~

(b) Paragraph (b) of subsection 3 do not apply to a child who is enrolled in a private school in this State before July 1, 2003.

(c) *Subsection 5 do not apply to a child who is enrolled in a private school in this State before July 1, 2009.*

Sec. 3. NAC 441A.755 is hereby amended to read as follows:

441A.755 1. Except as otherwise provided in subsection 10 or unless excused because of religious belief or medical condition, a person shall not attend a university until he or she submits to the university proof of immunity to tetanus, diphtheria, measles, mumps, rubella and any other disease specified by the State Board of Health. The Division shall establish the immunization schedule required for admission of the student.

2. Except as otherwise provided in subsection 10 or unless excused because of religious belief or medical condition, a person who:

(a) Is less than 23 years of age; and

(b) Is enrolled as a freshman;

➔ shall not ~~reside in on-campus housing after September 1, 2008,~~ *attend a university* until he or she submits to the university proof of immunity to *Neisseria meningitidis*. *The Division shall establish the immunization schedule required for admission of the student.*

3. A student may enroll in the university conditionally if the student, or if the student is a minor, the parent or legal guardian of the student, submits a record of immunization stating that the student is in the process of obtaining the required immunizations, and that record shows that the student has made satisfactory progress toward obtaining those immunizations.

4. The university shall retain the proof of immunity on a computerized record or on a form provided by the Division.

5. The university shall not refuse to enroll a student because he or she has not been immunized if the student, or if the student is a minor, the parent or legal guardian of the student, has submitted to the university a written statement indicating that his or her religious belief prohibits immunizations. The university shall keep the statement on file.

6. If the medical condition of a student does not permit him or her to be immunized to the extent required, the student, or if the student is a minor, the parent or legal guardian of the student, must submit to the university a statement of that fact written by a licensed physician. The university shall keep the statement on file.

7. If additional requirements of immunity are imposed by law after a student has been enrolled in the university, the student, or if the student is a minor, the parent or legal guardian of the student, shall submit an additional proof of immunity to the university stating that the student has met the new requirements of immunity.

8. If the health authority determines that, at the university, there is a case having a communicable disease against which immunity is required for admission to the university, and a student who has not submitted proof of immunity to that disease is attending that university, the president of the university shall require that:

- (a) The student be immunized; or
- (b) The student be excluded from the university until allowed to return by the health authority.

9. A student shall not attend a university from which he or she is excluded until allowed to return by the health authority. The parent or legal guardian of a student, if the student is a minor, shall not allow the student to attend a university from which he or she is excluded until allowed to return by the health authority.

10. Any student who is enrolled in a program of distance education and who does not attend a class on campus is exempt from the requirements of this section.

11. As used in this section:

(a) "On-campus housing" means a dormitory or other student residence that is owned, operated by or located on the campus of a university.

(b) "Postsecondary educational institution" has the meaning ascribed to it in NRS 394.099.

(c) "University" means any university within the Nevada System of Higher Education or any private postsecondary educational institution that provides on-campus housing.

SMALL BUSINESS IMPACT STATEMENT 2016
PROPOSED AMENDMENTS TO NACs 392.105, 394.250 and 441A.755

LCB FILE NO. R052-16

The Division of Public and Behavioral Health (DPBH) has determined that the proposed amendments should not impose an undue economic burden upon a small business or have a negative impact on the formation, operation or expansion of a small business in Nevada.

A small business is defined in Nevada Revised Statutes NRS 233B as a "business conducted for profit which employs fewer than 150 full-time or part-time employees."

This small business impact statement is made pursuant to NRS 233B.0608 (3) and complies with the requirements of NRS 233B.0609.

Background

Existing law authorizes the State Board of Health to adopt regulations to define and control dangerous communicable diseases. Existing law generally requires that a child be immunized against certain diseases, including, without limitation, such diseases as the Board of Health may determine, before enrollment in a public or private school. The key items the proposed regulation includes are as follows:

- Categorizes *Neisseria meningitidis* as a communicable disease;
- Prohibits a child from being enrolled in grade 7 in a public or private school unless immunized against *N. meningitidis* after he or she obtained 10 years of age;
- Prohibits certain persons from attending a university until the person submits to the university proof of immunity to *N. meningitidis*;
- Requires the Division of Public and Behavioral Health to establish the immunization schedule required for admission to a university; and
- Provides exceptions to such prohibitions.

- 1) A description of the manner in which comment was solicited from affected small businesses, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.**

Pursuant to NRS 233B.0608 (2) (a), the Division of Public and Behavioral Health has requested input from each public school district, private school and university in Nevada.

2) Describe the manner in which the analysis was conducted.

An analysis of the input collected from stakeholders conducted by Karissa Loper, Nevada State Immunization Program Manager. The analysis involved analyzing feedback obtained from the small business impact questionnaires as well as information gathered from communications with various immunization and school health stakeholders, including pediatricians, community members, and local health district staff among others. The analysis considered the questionnaire answers and comments, comments and suggestions from related focus groups, as well as the fiscal impacts of requiring an additional vaccination for school/college entry.

3) The estimated economic effect of the proposed regulation on the small business which it is to regulate including, without limitation, both adverse and beneficial effects and both direct and indirect effects.

The beneficial effect of these regulations is to reduce vaccine-preventable disease in school-age and college-age populations. The adverse effects include additional staff time to check for the newly required immunization and possible increased record-keeping requirements for universities.

4) Provide a description of the methods that DPBH considered to reduce the impact of the proposed regulation on small businesses and a statement regarding whether the agency actually used any of those methods.

The Division of Public and Behavioral Health used methods to reduce the impact of proposed regulations on small business including discussions with stakeholders, parent and provider focus groups, and distribution of the small business impact questionnaire to gather input from stakeholders on how the proposed regulation(s) may impact their business. Nevada public school districts, private schools and universities/colleges were given the opportunity to discuss the economic impact the proposed regulations may have. No modifications to the proposed regulations have been made as a

result of this input. The Division of Public and Behavioral Health has reviewed the regulations and has been unable to identify any adverse impacts on small businesses.

The Division of Public and Behavioral Health will hold a Public Workshop on Thursday, June 30, 2016 in Carson City and will be broadcast via videoconference in Las Vegas for the public and the regulated community to provide comments regarding the proposed regulations. Further input by the public, regulated community or other interested parties regarding the proposed regulations and their impact may be solicited at the Public Workshop. These comments will be taken into consideration for possible further revisions to the regulations to reduce the economic impact on facilities. The Notice of Public Workshop is being mailed to interested parties and posted in public locations statewide on Wednesday, June 15, 2016.

There is no estimated cost to the agency for enforcement of the proposed regulation(s).

The agency has concluded there is little to no impact of regulation NACs 392.105, 394.250 and 441A.755 on small businesses as the response from the Small Business Impact Questionnaires did not offer any specific evidence to the perceived impact on the business model. There are no fees associated with requiring a school-entry immunization.

NOTICE IS HEREBY GIVEN that the State Board of Health will hold a public hearing to consider amendments to Chapters 392, 394 and 441A of the Nevada Administrative Code (NAC). This public hearing is to be held in conjunction with the State Board of Health meeting on September 9, 2016.

The proposed changes to NAC's 392.105, 394.250 and 441A.755 include the following:

- Declares *N. meningitidis* to be a communicable disease;
- Prohibits a child from being enrolled in grade 7 in a public or private school unless immunized against *N. meningitidis* after the student obtains 10 years of age;
- Prohibits certain persons from attending a university until the person submits to the university proof of immunity to *N. meningitidis*;
- Provides exceptions to such prohibitions; and
- Provides other matters properly relating thereto.

1. Anticipated effects on the business which the applicable NACs regulate:

- a. *Adverse effects*: Minimal; the adverse effects include additional registrar/school nurse staff time to check for the newly required immunization and increased record-keeping requirements for universities.
- b. *Beneficial*: The beneficial effect of these regulations is to reduce the risk of meningococcal disease in school and university populations.
- c. *Immediate*: Beginning with the 2017 school year, all public and private schools will be required to check incoming grade 7 student records, and all universities will be required to check incoming student records for immunity to *N. meningitidis*, or the proper exemptions, according to the schedules that will be established by the Division of Public

and Behavioral Health (DPBH).

- d. *Long-term*: The DPBH has reviewed all school/university immunization regulations and has been unable to identify any long-term adverse impacts on business.

2. Anticipated effects on the public:

- a. *Adverse effects*: None.
- b. *Beneficial*: Reduces the risk of meningococcal disease spread in school and university populations, thereby protecting the health of all Nevadans.
- c. *Immediate*: Students entering grade 7 or as an incoming freshman to a university in fall 2017 will be required to show immunity to *N. meningitidis*, according to the schedule established by the DPBH, or have the proper exemptions on file or risk being excluded from school entry.
- d. *Long-term*: Sustainable increases in adolescent immunization coverage rates for Nevada students. Increased immunization coverage in a population significantly reduces the possibility of a disease outbreak.

- 3. The estimated cost to the DPBH for enforcement of the proposed regulations would be minimal and handled through existing administrative processes as the vaccines to prevent meningococcal disease are already routinely provided to eligible children 0-18 years by the Division of Healthcare Financing and Policy through the Nevada Check-Up Program and the Vaccines for Children Program.

The proposed regulations do not overlap or duplicate any other Nevada state regulations.


This letter is in support of LCB File No. R052-16 to add protection against *Neisseria meningitidis* to Nevada's school entry immunization requirements for incoming 7th graders. According to the CDC, between ten and fifteen percent of those who contract meningococcal disease will die; and eleven to nineteen percent of those who survive will suffer from permanent hearing loss, developmental delays, loss of limbs, or other serious conditions.

Making sure our entering 7th graders are vaccinated is critical to keeping our students healthy and protected as preteen, teen, and young adults have the highest rates of meningococcal disease. Meningococcal disease can kill an otherwise healthy person within 24 hours, but getting vaccinated can save lives and prevent the devastating side effects of the disease. We can't protect our children against everything; but following the Advisory Committee on Immunization Practices (ACIP) recommendations for adolescent vaccination provides us with one less thing to worry about.

No child in Nevada should suffer from a vaccine-preventable disease, and this regulation ensures that parents and providers are fully educated about the importance of this and other recommended adolescent vaccinations.

In a time of various disease outbreaks nationwide, this regulation makes common sense and will help protect Nevada's children from meningococcal disease for years to come. It puts the health of our children first. Thank you.
