Funding

- Assistance to Victims of Domestic or Sexual Violence, also known as, Marriage License Funding, is outlined in NRS 217.400 – 217.460.
- The funds are generated from the marriage licenses issued in Nevada.
 - \$50 of every marriage license issued goes into the fund.
- Funds are distributed as prescribed in NRS 217.400 217.460

Awards

- Funding is primarily for shelter and shelter-related services. New and current subrecipients are encouraged to propose projects that are innovative and far reaching as the Division's goal is to reach underserved populations and geographical regions throughout the State of Nevada.
- Funds are awarded on a State Fiscal Year (SFY) basis which starts on July 1 through June 30 of each year. The funding process is a combination of application review and grant allocation based on geographic region and is administered by the Division of Child and Family Services (Division).
- Last award period 14 agencies were funded across the state.



Grant Funding Formula

- A basic allocation of \$7,000 must be made for each county whose population is less than 100,000. For counties whose population is 100,000 or more, the basic allocation is \$35,000. These allocations must be increased or decreased for each fiscal year ending after June 30, 1990, by the same percentage that the amount deposited in the account during the preceding fiscal year, pursuant to <u>NRS 122.060</u>, is greater or less than the sum of \$791,000.
- Any additional revenue available in the Account must be allocated to grants, on a per capita basis, for all counties whose population is 20,000 or more.
- Seventy-five percent of the revenue allocated to each county must be allocated for grants for services for victims of domestic violence and 25 percent must be allocated for grants for services for victims of sexual violence.



Eligibility

- 1. Be a nonprofit corporation, incorporated or qualified in this state.
- 2. Be governed by a board of trustees which reflects the racial, ethnic, economic and social composition of the county to be served and includes at least one trustee who has been a victim of domestic violence.
- 3. Receive at least 15 percent of its money from sources other than the Federal Government, the State, any local government or other public body or their instrumentalities. Any goods or services which are contributed to the organization may be assigned their reasonable monetary value for the purpose of complying with the requirement of this subsection.
- 4. Provide its services exclusively for victims of domestic violence and only within this state.
- 5. Require its employees and volunteer assistants to maintain the confidentiality of any information which would identify persons receiving the services.
- 6. Provide its services without any discrimination on the basis of race, religion, color, age, sex, marital status, national origin or ancestry.
- 7. Be able to provide:
 - 1. Except in counties whose population is less than 100,000, shelter to victims on any day, at any hour.
 - 2. A telephone service capable of receiving emergency calls on any day, at any hour.
 - 3. Except in counties whose population is less than 100,000, facilities where food can be stored and prepared.
 - 4. Counseling, or make referrals for counseling, for victims or spouses of victims and their children.
 - 5. Assistance to victims in obtaining legal, medical, psychological or vocational help.
 - 6. Education and training for members of the community on matters which relate to domestic violence.



Service Categories

• Funding can be used for:

- support shelter,
- hotline,
- food assistance for clients,
- counseling services,
- obtaining legal,
- medical,
- psychological or vocational help and outreach, and
- education and training for members of the community.

- The Notice of Funding Opportunity is released on March 1, applications are accepted until April 1
- DCFS receives applications from agencies wishing to apply.
- Applications are reviewed and the allocations are made pursuant to NRS for each county.

- a. DCFS will submit the Assistance to Victims of Domestic or Sexual Violence policy and subsequent updates to the Division of Public and Behavioral Health Commission on Behavioral (NRS 232.361.1) for review and approval.
- b. DCFS will submit to the Division of Public and Behavioral Health Commission on Behavioral Health the total amount awarded each year from the Account for Aid for Victims of Domestic or Sexual Violence for review and approval.
