

Carson City Health and Human Services Report 4th Quarter 2023 (October 1 – December 31)

Program Highlights and Requests

✓ Tobacco Prevention and Control Funding – (This has been intentionally restated from the last reporting .) Continued Youth Vaping Prevention funding was not approved during the 2023 Legislative Session. This is extremely disappointing given the fact that youth vaping is still an epidemic. With the funding, CCHHS staff developed presentations for youth to be conducted within the schools, as well as to teachers and parents. Social media campaigns were created and posted (i.e. – Head in the Clouds and Attracting Addictions). Some of the materials created will be re-used, translated, and continue to be posted; however, no new content will be developed since there is no funding for the project to continue. Currently, CCHHS' Tobacco Control and Prevention Program is still intact for now. This funding loss amounted to \$100,000/year.

The CDC Tobacco Prevention funding remained the same at approximately \$70,000. This results in decreases to the operating or program expenses to accommodate for increasing personnel wages due to cost-of-living adjustments and merit raises. The Nevada Clinical Services grant, formerly the Funds for Healthy Nevada, was reduced so grant deliverables had to be scaled back and adjusted.

<u>Request</u> – Advocate for Youth Vaping Funding to be restored in the future. These funds should not be replaced by the SB118 funding since there is a 30% tax on the wholesale cost of all vaping products passed during the 2019 legislative session.

Prevention Health and Health Services

An existing full-time employee has been recruited to work within the program part-time. This employee works between 3 programs at CCHHS. She will continue with the current scope of work. At all the outreach events she participates in for the other programs, she hands out information about Healthy Eating. Although this is not a grant deliverable, getting this information out to the public may help individuals live a healthier life.

- Staff is working towards CHW II certification to achieve by the end of 2024.
- New process in clinic EHR has been implemented so that reports can be ran on patients who are interested in receiving more information on healthier lifestyles.
