Recommended NRS Augmentations

Relative to Transportation

- Take the requirement for transportation out of the language.
 - Patient does need to be medically cleared
 - Medical clearance exam should be prior to psychiatric inpatient admission
 - Client does not have to be transported to an acute care hospital for medical clearance; rather the medical clearance can take place outside the hospital ED setting and EMS/police/fire can transport to a designated facility if and when another SITE is available for medical clearance.

Recommended NRS Augmentations

- Relative to Medical Clearance
 - No change suggested

Recommended NRS Augmentations

- Relative to Legal 2000
 - Expand the ability to discharge patients off of L2K status to include licensed mental health professionals as defined below:
 - Licensed Physician or psychologist
 - In absence of such, by a person trained and licensed in clinical social work or nursing who has a graduate degree and clinical experience in mental health in consultation with a psychiatrist

Working Group Plans/Next Steps

- Work with the LCB on language for proposed NRS changes
- Continue work on the operationalization of OSCAR to include interim measures
