Coalition Building

- promotes coordination and collaboration,
- efficiently uses limited community resources,
- arranges for cooperation and collaboration between groups or sectors of a community, in which each group retains its identity but all agree to work together toward a common goal.

- To address an urgent situation.
- To actually obtain or provide services.
- To bring about more effective and efficient delivery of programs.

- To increase communication among groups and break down stereotypes.

- To empower the community to take control of its future.
