 - Co-Principle Investigator on two Second Chance Act Comprehensive Statewide Adult Recidivism Reduction Program grants - worked with Dr. Roni Dahir, Director of the Grant Sawyer Center for Justice Studies. Some goals/objectives:
 - Develop formalized collaborative partnerships with community providers, agencies, & families of returning citizens
 - Validate Nevada Risk Assessment System (NRAS) for Nevada's correctional population
 - Integrate NRAS into a seamless data management system for use with DOC, P&P, and Community Partners
 - Adopt & validate existing evidence-based programming for the Nevada corrections population

Correctional Program Checklist (CPC)

- CPC is a tool developed by UCCI for assessing how well correctional intervention programs adhere to the known principles of evidence-based practices for the corrections population (CPC revised 2015; retitled CPC 2.0)
- UCCI has assessed approximately 1,000 programs:
 - Prison/community, adult/juvenile, male/female
 - Has developed a large database on correctional intervention programs
- CPC can be used to: design, develop, fund, evaluate, redesign, & improve programs
 - 2011 DOC used the instrument evaluate & redesign the substance abuse treatment programs

CPC

1. Capacity

- Measure whether a correctional program has the capability to deliver evidence-based interventions & services for offenders.
- 3 Domains:
 - 1. Program leadership & development
 - 2. Staff characteristics
 - 3. Quality assurance

2. Content

- Evaluates the extent to which the program primarily meets the RNR principles
- It has 2 domains:
 - 1. Offender assessment
 - 2. Treatment characteristics

Rating scale:


CPC

- 77 indicators; 83 max. total points
- Highly Effective = 65% or higher
- Effective = 55-64%
- Needs Improvement = 46-54%
- Ineffective = 45% or less


Note: CPC 2.0

- 73 indicators; 79 max. total points
- Very High Adherence = 65% or higher
- High Adherence = 55-64%
- Moderate Adherence = 46-54%
- Low Adherence = 45% or lower


Phoenix Baseline to Current




STARS Baseline to Current
