





Medicaid

Expenditures – All Services Washoe County, 2013-2017 (Q3) \$120,000,000.00 \$100,000,000.00 \$80,000,000.00 \$60,000,000.00 \$40,000,000.00 \$20,000,000.00 \$0.00 2013 2014 2015 2016 2017

- The percent change in total expenditures in Washoe County during the 5 year period was 74% increase.
- This increase is partially due to the increase in Medicaid enrollment (following slide).
- These data represent the amount paid by the MCOs and not a direct cost to the state.

Members Enrolled Washoe County, 2013-2017 (Q3)



- Medicaid expansion took place in 2014.
- From 2014-Q1 to 2017-Q3 there was a 16% increase in enrollment and a 34% increase in expenditures.
