Historical Information: Legislation passed in 2019 and a subcommittee of the Council on Food Security (CFS) was created in 2019 until October 2021. Progress stalled due to funding and the subcommittee meetings ceasing. A template for a toolkit to help fulfill items in the NRS was developed, that included a program seal. The Office of Food Security applied for funds to help support this program but has yet to be awarded any.
