- Partner Capacity



Coverage by Distribution Type





Capacity Building

- Transportation:
 - FBNN has provided a total of 5 refrigerated vans to partners in Lyon, Douglas, Carson, Humboldt and Elko counties, increasing the ability to source fresh, perishable foods but also will be used to build out mobile distributions for rural partners. In addition, Pyramid Lake Paiute Tribe received a stipend to support volunteers and staff to increase their reach with their mobile programs.
 - Example Winnemucca Food Bank is using their van to distribute to McDermitt Indian Reservation monthly.
- Pantry access (frequency and hours of operation)
 - Asking partners to really look at their days and hours of operation and see what is possible, to better support working families.
 - Example HCC in Lyon County is going to add a Saturday distribution starting in November, to better support neighbor needs.
- Knowledge of available Programs and Resources
 - Using grant funding, FBNN is hiring a Rural Program Specialist that will be based in either Humboldt or Elko County and will support the needs of both partners, neighbors, and community organizations. Goal – help connect the dots and be a liaison to bridge the information gap that is there.
- Partner Capacity
 - Meeting with a partner in Elko to look at how we can use grant funding to increase their capacity and improve access to all partners in Elko, Lander, White Pine and Humboldt counties.
