As an educator who teaches two semester courses in community dental health to future dental hygienists and as the community oral health liaison for the dental hygiene program at Truckee Meadows Community College, I feel it is vital that I am current on the public oral health programs, policies and practices in our state. I have actively participated in RAM (Remote Area Medical) events annually for the past three years, and involve the dental hygiene students and faculty from TMCC. I also organize and supervise dental hygiene students who provide oral health educational programs and caregiver training sessions in various senior centers and long term care facilities.

I would greatly appreciate continuing my service on this committee.
