5. Informational

Division of Public and Behavioral Health (DPBH) and Bureau of Behavioral Health Wellness and Prevention Updates (BHWP)

a. Discussion on Fiscal Report - John Borrowman, DPBH, Behavioral Health Fiscal Manager

Andrea Allen with Department of Public and Behavioral Health Fiscal Department provided and updates on fiscal year 2023 and how we ended our total receipts and funding with the total budget of \$2,110,800 in funds, \$17,054.00 was reverted back to the General Fund and within that amount for category 19, we reverted \$11,022.00.

Mr. Borrowman provided a clarification on the original appropriation to Cat 19 was \$2,019,359.00 and then if you recall, we had the authority to balance forward money from state fiscal Year 22 to 23 in the amount of \$5, 299.00. This brought your total authority in Cat 19 to 2,024,00.00

Ms. Allen moved on the updates for the fiscal year 2024. our total receipts and funding for fiscal year 24 for categories 19 and 20 is \$2,478173.00 and the expenditure authority in category 19 is \$1,978143.00 and category 20 is \$500,000.00.

Ms. Garcia gave a breakdown for the fiscal year 2023. She stated that this was less than 1 percent reverted. Thank you to everyone for their efforts in spending. We will work on getting closer next time. Ms. Garcia moved on to fiscal year 2024 with the breakdown and the obligations and remain balance to be obligated during midyear reallocation.

- b. Discussion on Program Updates Kim Garcia, BHWP, Social Services Program Specialist III
 - i. 988 update Rachel Usherwood BHWP, Quality Assurance Specialist III

Ms. Isherwood spoke about the Crisis Response System information and implementation. Ms. Isherwood gave an in-depth presentation on 988 Program updates regarding the telecom fee collections, Mobile Crisis Teams, Crisis Stabilization Centers, Medicaid's current role and their request for information (RFI) that was released earlier in FY23, an overview of information received from RFI and information that will be added to the request for proposal (RFP) as well as a timeline of implementation.

ii. Project Worth - Ashlan Sherron, KPS3, Inc.

Ms. Sherron briefly shared information regarding FY 22/23 recap and FY 23/24 plans. Ms. Sherron also presented Project Worth's Campaign for SY23 and gave details on the most watched videos and audio clips. Jenna Hubert spoke about upcoming campaigns for next year. The current campaign videos were presented to the committee.

iii. Telehealth/Culturally Diverse Language Provider Update - Kim Garcia, BHWP

Dr. Marotta spoke about the expansion of the Hope Counseling Problem Gambling Center project into a telehealth program. Dr. Marotta spoke about many aspects of the current work they are investing time in to enhance onboarding and services in general. Dr. Marotta turned the presentation over to Dr. Miranda Alfonzo. Dr. Alfonza spoke mostly on new services offered to include outpatient counseling services. Dr. Alfonzo spoke about the new certified problem gambling counselor interns, five are on staff to date. Three that are stepping in to offer Spanish speaking services to a population that has not been targeted.

Dr. Alfonzo shared with the committee the importance of telehealth, telecounseling and how to utilize, access and promote services for individuals that may benefit from these services.

- iv. Treatment Provider Updates
 - 1. Bristlecone Family Resources Donna Meyers

Ms. Meyers opened with a brief introduction to Bristlecone Counseling staff and the many services that Bristlecone offers. Ms. Meyers shared with members the way the program works and the services they provide.

2. Dr. Robert Hunter International Problem Gambling Center – Stephanie Goodman

Ms. Goodman introduced the program at Dr. Hunter IPGC as a mix of cognitive behavioral therapy, teaching the science of the brain as well as group therapy. Ms. Goodman spoke of a new section recently added to the important pieces at the center, Weekend Solutions, which is led by a Peer Support Specialist. The programs that the Center offers range from Intensive Outpatient Programs to aftercare. (Within are a variety of services for industry workers to community workers as well.

3. Mental Health Counseling and Consulting - Dr. Rory Reid

Dr. Reid spoke about the recent opening of a satellite office in Reno, Nevada. Dr. Reid spoke about the clients and the possibility of many having co-occurring disorders such as depression, anxiety, bi-polar disorder, and ADHD. Dr. Reid shared his clinical experience on managing the symptoms of mental health disorders often will reduce problem gambling behavior. MHCC offers psychological evaluations and neuropsychological evaluations in situations where it is warranted. Dr. Reid spoke of the importance of wrap-around services. Dr. Reid touched on Cognitive Behavior Therapy, stating that changing the way people think will change the way that they feel. Dr. Reid spoke about negative and positive stressors.

4. New Frontier Treatment Center - Lana Robards

Tina Marie Bisiaux gave a presentation to ACPG regarding the program they facilitate at New Frontier Treatment Center, regarding problem gambling. For starters upon intake the clients are given an assessment with 20 questions to see if the client meets the criteria for services through PG. Once admitted into treatment whether inpatient or outpatient the staff will then access each individual needs and construct a plan for PG treatment. At NFTC there is gamblers anonymous (GA) meeting that takes place once a week to benefit all participants in the program. The families that NFTC assist varies from underserved individuals; homeless, uninsured, elderly, and veteran services. NFTC works with people who have long-term chronic addiction, family addictions, and those with complex health profiles.

5. The Downing Counseling Clinic – Adrienne S. Renwick

Dr. Renwick spoke about CASAT Academic Unit. Dr. Renwick spoke about the collaboration that fosters the development of competency in the treatment of problem gambling and other addictions. Dr. Renwick spoke about the goal in teaching students how to treat mental health disorders and the goal of partnership with CASAT Academic Unit is to further education to PG. Dr. Renwick spoke about FY23 CEP course infusion and many other courses that they teach at the Downing Counseling Clinic.

Ms. Joanne Celeste gave the presentation for the Gambling Treatment Diversion Court, also known as GTDC. GTDC is the only program available in the US currently. This GTDC allows defendants to defer their convictions while participating in the program. The program runs from 13 months to 36 months with 5 phases to complete. Clients enrolled in this program are mandated to be 100% compliant with court issues throughout their time in GTDC.

v. Treatment Provider Data Report for SFY23 - Andrea Dassopoulos, UNLV IGI

Ms. Dassopoulos spoke about the three parts of the program that they provide for treatment services. The first being information management, where they assist in helping the clinics to enter data into a customized data management system. This allows the University of Nevada, Las Vegas International Gaming Institute (UNLV IGI) to expand research and grow research population in Nevada. The second part is the Program Evaluation, where follow-up interviews are done at 30 days, 90 days and 1 year post intake, which allows UNLV IGI to provide individualized recommendations to each clinic and gives an overview of the treatment system. This allows them to process reports. The final piece is the research section. This includes panel studies, rural needs assessments and proposals, extended follow-ups, student surveys, student mini grants and UNLV Behavioral Addictions Lab.

a. Discussion on Legislative Subcommittee Updates – Stephanie Goodman, Legislative Subcommittee Chair

Ms. Goodman gave an update from the Legislative Subcommittee. Ms. Pittman and I had a discussion, and we both were aware of the fact there was going to be a lot of money up there in the legislature. As you know, they turned down our \$1.8 million ask for awareness for the state American Recovery Plan Act. Ms. Pittman did an amazing job; she is very well known and has an incredible reputation up at the legislature. We met with both of the Finance Committee chairs, thought SB 341 the ACPG was awarded \$500,000 and called it a public awareness seminar.

But it is a brochure that is designed to educate student athletes very briefly about the problem of gambling. Some of their particular risk factors, some things that they'll encounter in college if they hope to play their sports and also some our resources for immediate help as well as a QR code to get them to an already developed new area of the Council's website on this issue, which also includes selected current news articles on this topic.

Carol O'Hare, I want to officially object to the suggestion that I would ever lurk anywhere. Although that may be the only thing I really good at these days, I've no I just wanted to say. Retirement is hard because it's one of the biggest changes I've ever had to go through, and I am so grateful to everyone that is in this meeting and the progress that's being made is that a pace that just amazes me and tires me out, which is why I'm no longer in the committee.
