New Vaccination Requirement for Nevada Public and Private Schools

Amendments to Nevada Administrative Code (NAC) 392.105 and 394.250 were adopted by the State Board of Health on September 9<sup>th</sup>, 2016 and affirmed by the Nevada Secretary of State's office on November 2<sup>nd</sup>, 2016. As noted below, the new requirement will go into effect beginning with the 2017-18 school year.

- 1. A child enrolling in seventh (7<sup>th</sup>) grade in a Nevada public or private school after June 30<sup>th</sup>, 2017 must receive an immunization against Neisseria meningitidis (meningitis) in the form of a quadrivalent meningococcal conjugate vaccine (MCV4). The child must receive at least one dose of MCV4 on or after age 10 years.
- This new requirement does not apply to students enrolled in a Nevada public or private school before July 1<sup>st</sup>, 2009.

Nevada's Chief Medical Officer, Dr. John DiMuro, is responsible for providing the direction on the timing (schedule) and number of doses for all required immunizations for school-aged children.

All children enrolling into kindergarten, 7<sup>th</sup> grade, or those who are new to a Nevada school district for any grade must be fully vaccinated per the regulations set by the Nevada Division of Public and Behavioral Health, as illustrated in the following table. The newly required MCV4 vaccination has been highlighted. Children must be fully vaccinated **prior to** being enrolled into school.

Conditional enrollment is only permitted when a child would need multiple visits to a healthcare provider to achieve compliant status. If all needed doses can be administered at one appointment, then the child **cannot enroll** in school until they are vaccine compliant. As a reminder, only medical and religious exemptions are permitted per <u>NRS 392.437-439</u> and 394.193-194.

Nevada WeblZ is the statewide immunization information system used in Nevada; it can assist an authorized user in determining if a student is compliant with Nevada's immunization requirements.
