Margaret McConnell asked if Phil Glessner was brand new to the industry. Shawn McGivney said he was a member of the HIRC Advisory Council, great diplomat and communicator, and commented he is opening a new assisted living facility.

MARGARET MCCONNELL MOVED TO NOMINATE ALL THREE CANDIATES UNDER THE APPROPRIATE CATEGORY OF REPRESENTATION ON THE SNAC. SHAWN MCGIVNEY SECONDED THE MOTION. MOTION PASSED UNANIMOUSLY.

# **Health Care Quality and Compliance update:** *Steve Gerleman, Pat Elkins* **Regulation updates**

Nathan Orme, Education and Information Officer, HCQC commented regulation updates will be posted on our web site. The small business impact survey has been received and posted as well. He said he will try and send them to all the licensees through the CLICS data base. He said that on the Health Facilities home page on the web site, on the right hand side the regulations will be posted.

Shawn McGivney said that they are requesting more open dialogue with the industry than just being referred to a web site. He asked:

- What is the estimated timetable for the regulations that affect assisted living facilities.
- Is there anything that the ALAC can do that can expedite the regulations.
- The live in caregiver exemption is important and he recommended a letter be drafted to the Department of Labor emphasizing how important it is and that we would be willing to work with them to help move that forward.

Nathan Orme said he would be follow up to reach out to the Department of Labor and see what they can do.

**Report on assisted living related programs at Perry Foundation.** *Robert Kidd, President and CEO, Perry Foundation* 

- Robert Kidd said that emails will be sent out for the Tahoe Conference on August 5, 6, 2018.
  He reviewed the keynote speakers and activities for that conference which included Dena
  Schmidt, Administrator, ADSD: Siboney Zelaya, PhD, MPH, MSN, Ed RN, Transformative
  Leadership; Jill Vitale-Aussem, President and DCEO; Ron Reigle, Chief Compliance Officer,
  Marnell Gamin; Manny Clark, President, Optimizing; Ed McMahon, Ph.D, Sunrise Senior
  Living; James Willison, J.D., Laura Beck, MPAIT, Learning Development Guide.
- There will be their annual golf tournament in Sparks with Brookdale and Hearthstone.
- The Perry Foundation recently received their CPE, so they are qualified to give classes for medication management.

## Updates from Aging and Disability Services Division.

Crystal Wren, Social Services Chief II commented on rate reimbursement, the transition process, and other information. She met with the Welfare Division and Health Care Financing and Policy (DHCFP) to come up with a good informational. The waiver application process is between three agencies. The Aging and Disability Services determines eligibility, at the same time the DHCFP is the administrator for the waiver. Welfare approves financially, DHCFP approves actual waiver enrollment.

A member commented that those individuals from the waiver application process may transition to a group home. The payment becomes a concern because if you admit someone today, welfare is not able to make them eligible until the following month.

Crystal Wren said that Welfare has a new system where they can review and remind people what resources they have. Sometimes they have to terminate the application and have them reapply when they can gather all the information. They do what they can to make sure you are paid for the entire item.

Jeanne Bishop Parise asked if there is an annual redetermination process that these waiver people have to undertake that would cause them to be taken off the program on an annual basis. When a Medicaid person is eligible for payment, is there an allowance that if they are in the hospital or skilled nursing that they can get paid for the residential facility for that same day.

Crystal Wren said there is an annual determination that must be completed. They will assist the recipient and generally if the individual has been on the program, they have had on occasion where they help people open a new bank accounts but have had to gather new documentation.

There was a round table discussion regarding clients being eligible for waiver application, what happens, spend down appropriate for the recipient which is determined by Welfare.

Crystal Wren said they would be open putting on a public workshop to help facilities understand their policies and procedures.

### Home Based and Community Waiver Information.

Anna Olsen-Figueroa, Social Services Manager, Home and Community Based Waiver Program commented they are continuing to conduct assessments and place them on the wait list for the program. One of the issues brought to their attention related to when they conduct assessments. She commented that they are working in the north and south to set up trainings on social health assessments with their staff so there is more consistency.

## Assisted Living Industry updates. Lisa Campbell, NALA

- Helen Foley and herself have been attending the Legislative Health Committee and following the topics of reimbursement rates.
- Regulatory Issues/Concerns from Provider Perspective waiting for the workshop dates two work on regulations.
- Trying to increase membership.

Shawn McGivney said there are individual parties that are serving as referral agents which are giving illegal referrals. In nursing homes, the social workers have to use a referral service. He said if you go to a nursing home and ask who the are referral services, they have many.

Margaret McConnell that BELTCA said it is not within the Board's purview to hold these resources accountable. There have been administrators that have reported but BELTCA requests that documentation be provided.

Lynne Tome said this appears to be a huge issue in Southern Nevada.

Shawn McGivney said that ALAC could recommend to HCQC to draft a letter and ask the Board of Health for an investigation on what a legal referral is.

Margaret McConnell said that a referral agency must reach certain standards and the statute is clear.
