Subsection A. <u>Composition</u>. The Council shall consist of no more than six members with a quorum consisting of three members. The members of the Council must either be Owners or Directors of a Home for Individual Residential Care (HIRC) Facility. At least one HIRC provider from Clark County;

At least one HIRC provider from Washoe County;

At least one HIRC provider from rural/frontier Nevada;

- Subsection B. <u>Alternate Member</u>. If a member is unable to attend a meeting, he/she may designate a representative to serve in his/her stead who shall have all the rights and privileges of the member while acting on his/her behalf.
- Subsection C. <u>Term of Membership</u>. Each Member shall serve a term of one to two years or until a successor is selected by a vote of the majority. Members may serve consecutive terms. Member's terms should be staggered so that the entire membership will not be replaced at any one time. In the event of a vacancy, nominations will be solicited and members will be selected by a vote of the majority.
