### January is Radon Action Month

Radon is a colorless, odorless, and tasteless radioactive gas that emanates from decaying uranium found naturally in the soil and rocks. This gas can accumulate in a building and can cause lung cancer. If a home has a level of 4 picocuries per liter of air (pCi/l) or higher, there is potential for a radon problem. To put this into perspective, a home with an annual average of 4 pCi/l presents the same risk of developing lung cancer as someone who smokes about half a pack of cigarettes a day.
