

Division of Public and Behavioral Radiation Control Program Landlord Acknowledgement of Responsibilities Related to Radioactive Materials



The licensee listed below intends to possess, use, or store, radioactive materials regulated by the State of Nevada Radiation Control Program (RCP). The licensee is required to comply with all applicable provisions of Nevada Administrative Code (NAC) 459.010 to 459.950 inclusive, which include requirements necessary to preserve the health and safety of individuals, protect the environment and ensure the security and accountability of the radioactive materials.

The licensee will be required to establish restricted areas at the property. A restricted area is any area to which access is limited for the purposes of protecting individuals from undue harm from radiation exposure and securing radioactive material.

As a landlord of the property you shall not take any actions directly or indirectly that prevent or hinder the licensee from complying with the requirements of NAC 459 or their radioactive material license. The landlord shall only access restricted areas when authorized and escorted by the licensee and/or RCP personnel.

NAC 459.3805 Restricted area: Persons authorized to enter. (NRS 459.201) Only those persons who perform work in a restricted area are authorized to enter such areas. A licensee shall not allow any other person to enter a restricted area.

In the unlikely event that the licensee is no longer in control of the facility, the landlord must continue to limit access to all restricted areas and prevent unauthorized access to or removal of any radioactive materials, sources, waste, and contaminated items until RCP has provided written approval, releasing the property for unrestricted use, in accordance with NAC 459.3801. If requested, RCP will provide the landlord with guidance and assistance for ensuring appropriate controls are maintained.

NAC 459.3801 Restricted area: Release for unrestricted use. (NRS 459.201) A restricted area in which a licensee has used or stored radioactive material must not be released for unrestricted use until the Division has given its approval in writing.
