INTRODUCTION

This report summarizes data compiled from original birth, death, stillbirth and induced abortion, marriage and divorce records filed with the Office of Vital Records as required by law. Standard forms recommended by the National Center for Health Statistics are used for all records, with the exception of marriage and divorce.

Responsibility for the filing of the **birth certificate** lies with the hospital medical records or nursing personnel, the physician, midwife, or other attendant. Funeral Directors, or persons acting as such, are legally charged with filing **death certificates** and **fetal death certificates**. County Recorders are responsible for forwarding the original **marriage certificates** or computerized tapes containing marriage data to the Office of Vital Records for maintenance of a data file. The County Clerk of each county is required to submit a **report of decree of divorce/annulment** to the Office of Vital Records within a month of the occurrence. **Induced abortion reports** are completed and sent in directly to the Office of Vital Records by the physician, hospital or clinic. The quality of data presented in the report is directly related to the completeness and accuracy of the information contained on the certificates.

THE NEVADA REGISTRATION SYSTEM

The Nevada Office of Vital Records has three distinct components:

- The Vital Records Section where public requests for certified copies and amendments of said copies are processed.
- The Quality Control/Data Entry Section where the records are checked for completeness and accuracy and then entered into a database onto the State Mainframe Computer System.
- The Statistical Section that analyzes and publishes reports based on statistics from the database and provides technical assistance to users of the data.

The vital events of deaths, marriages and divorces are first recorded at the county level before being forwarded to the State Registrar. Births in all counties are recorded electronically, directly with the State Registrar, except in Clark and Washoe Counties, where they are initially processed and then transmitted to the State Registrar. Abortions are reported directly to the Office of Vital Records for encoding and entering into the State's database. All records are checked for completeness and accuracy, and then given a state file number before encoding and entering into the State's database. Birth and death records are kept on permanent file for certification use and amendment when necessary by the public and various government agencies. Marriage, divorce, and abortion records are not maintained after entry into the State's database.

DEFINITIONS

- ABORTION:*** The termination of a human pregnancy with an intention other than to produce a live birth or to remove a dead fetus.
- DEATH:*** A person who has sustained irreversible cessation of all functioning of the brain, including the brain stem, is considered dead.
- DIVORCE:*** Termination of a marriage.
- FETAL DEATH:*** A birth that occurs after at least 20 weeks gestation in which the child shows no evidence of life after complete birth.
- INFANT DEATH:*** Deaths occurring to individuals of less than one year of age.
- LIVE BIRTH:*** A birth in which the child shows evidence of life after complete birth. A birth is complete when the child is entirely outside the mother, even if the cord is uncut and the placenta is still attached. Evidence of life includes heart action, breathing, or coordinated movement of voluntary muscles.
- LOW BIRTHWEIGHT:*** A birth wherein the birth weight is less than 2,500 grams (5 ½ pounds).
- MARRIAGE:*** A formal mutual relation of husband and wife that is filed with the County Recorder in the county where the license was issued.
- NEONATAL DEATH:*** Death occurring to infants in the first 27 days of life.

OCCURRENCE

(COUNTY OF):

Data allocated by the location of where the event actually occurred.

PERINATAL DEATH:

Death occurring to a fetus of 20 weeks gestation or more, including infant deaths occurring within 27 days of life.

PRENATAL CARE:

The care received by the mother from a health professional or midwife during the length of the pregnancy.

RESIDENCE

(COUNTY OF):

The usual residence of the individual. For deaths, this is defined as the usual residence of decedent as indicated on the certificate. For births and fetal deaths, the residence is defined as the usual place of residence of the mother.

UNDERLYING CAUSE

OF DEATH:

The disease or condition which gave rise to the chain of morbid events leading to death, including the circumstances of an accident or violent event that produced a fatal injury.

S.I.D.S.:

Death due to Sudden Infant Death Syndrome.

TECHNICAL NOTES

RACE AND ETHNICITY: Hispanics are an ethnic group, not a race, and may include all races within their ethnic classification. In this report, Asian-Pacific Islander, Black, Native-American, and White exclude Hispanics; therefore, no duplicate counting exists.

POPULATION DATA: The Nevada population data is based on the database established by the Nevada State Demographer's Office and the Nevada Department of Taxation.

COUNTY COMPARISONS: The population size of the counties in Nevada is widely varied, from one thousand to over one million. Because of these differences, caution should be used when interpreting the rate comparisons for counties.

REGIONAL COMPARISONS: Eighty five percent (85%) of Nevada's population resides in the urban areas of Clark (Las Vegas) and Washoe (Reno) Counties. In this report, data is stratified into three regions within the State as follows: Clark County, Washoe County, and All Other Counties (all remaining 15 counties).

METHODS FOR AGE ADJUSTMENT AND STATISTICAL ANALYSIS OF MORTALITY

RATES: In order to make meaningful comparisons between mortality rates for the residents from different regions, or from different race/ethnic groups, differences in the age characteristics of the populations should be taken into account. For example, one would expect that the mortality rate for heart disease would be high in a population that has a high proportion of older individuals. Age-adjustment is the application of the age-specific rates in a population of interest to a standardized age distribution in order to eliminate the differences in observed rates that result from age differences in populations compared. This adjustment is usually done when comparing two or more populations at one point in time or one population at two or more points in time.

In this report, the death rates are age-adjusted to the US standard million population (relative age distribution of 1940 enumerated population of the United States totaling 1,000,000). This method produces the rate that would be expected if the population of interest had the same population age distribution as the standard population.

Adjusted rates were calculated in the following manner:

- The expected number of deaths in each age group was determined by multiplying the age-specific rates (N_i/P_i) by the corresponding age-specific standard population total (S_i).
- Age adjusted rates (AAR) per 100,000 population were calculated by dividing the expected total number of deaths (E_i) by the total standard population and multiplying by 100,000.

It should be noted, that the 1999 data used in this report is the first year in which age-adjusted rates to the US standard million population relative age distributions of both year 1940 and year 2000 enumerated population of the United States has been utilized. The reason to use both standard populations is that beginning with the 1999 data, the National Center for Health Statistics will require rates that are age-adjusted be adjusted to the US standard million population relative age distribution of the 2000 enumerated population of the United States, however, National data is still unavailable at this date.

From 1990 to 1999, Nevada was by far the fastest growing state in the nation and Las Vegas was the fastest growing metropolitan area in both Nevada and the nation. The 1990 Nevada population of 1,201,000 grew by over 64% to 1,967,000 in 1999 and is projected to surpass two million by 2000 (Year 2000 Nevada population: 2,034,010). The vast majority of growth has been by in-migration. The Las Vegas and Reno metropolitan areas contain more than four out of every five (85%) of the state's residents.

The age mix of Nevada's population varies from the nation as a whole by having a higher share of people in the age groups between 25 and 45 and a lower share of elderly persons. In 1999, about 70% of Nevada's population was White-Non Hispanic. Black-Non Hispanic, Native American-Non Hispanic, Asian-Non Hispanic, and Hispanic consist of 6.7%, 1.3%, 4.3%, and 17.2% respectively. Since 1990, the fastest growing ethnic groups in the state are Hispanic origin and Asian, which increased 172.9% and 136.4% respectively. Although growing relatively slower than Hispanic or Asian groups, Nevada's other race/ethnic groups also significantly increased in number -- Black, Native American, and White have increased 73.1%, 51.7%, and 46.1% respectively since 1990.

Figure 1. Population Pyramid in Nevada, 1999

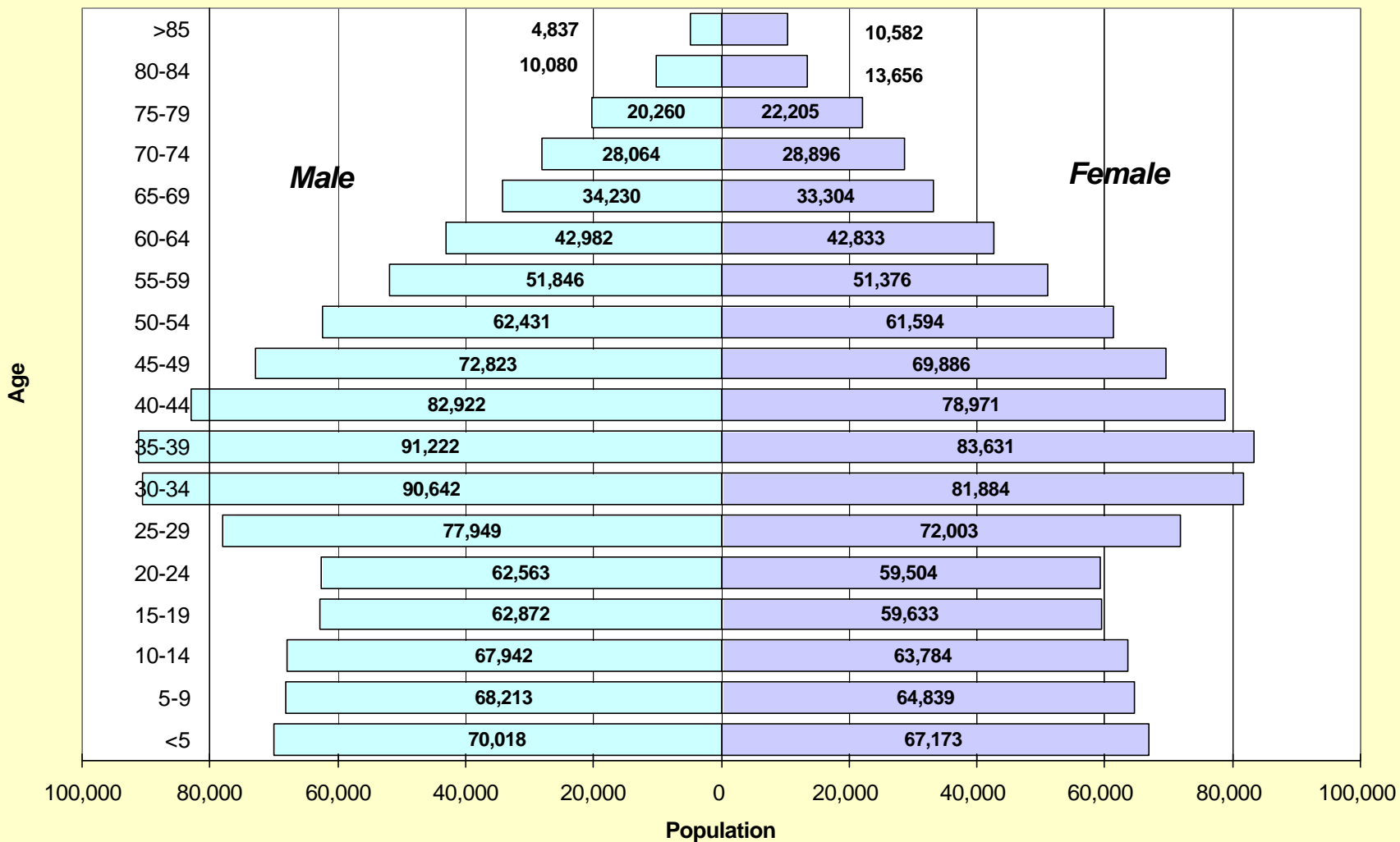


Figure 2. Population Growth by County of Residence in Nevada, 1980-2005

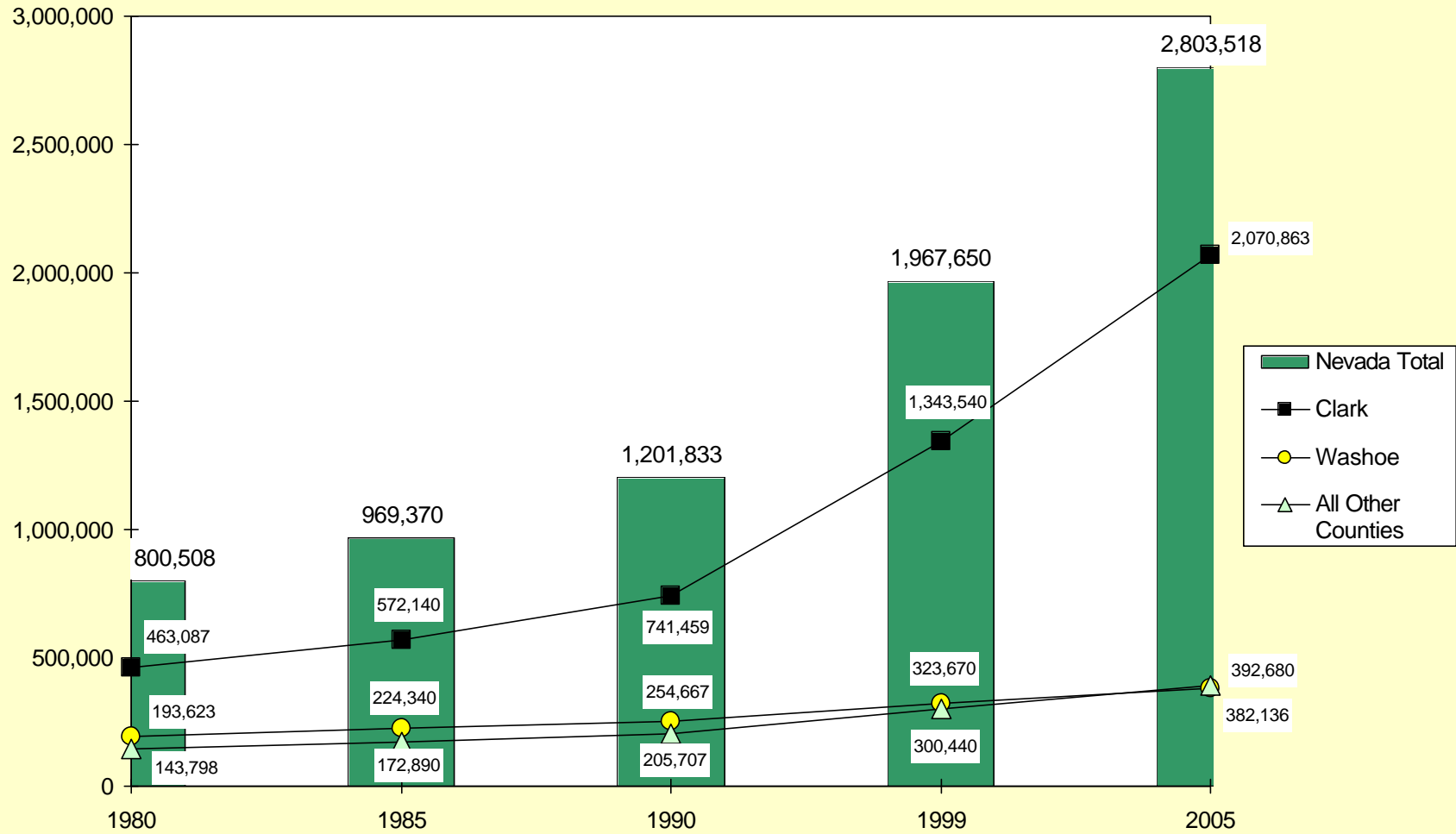

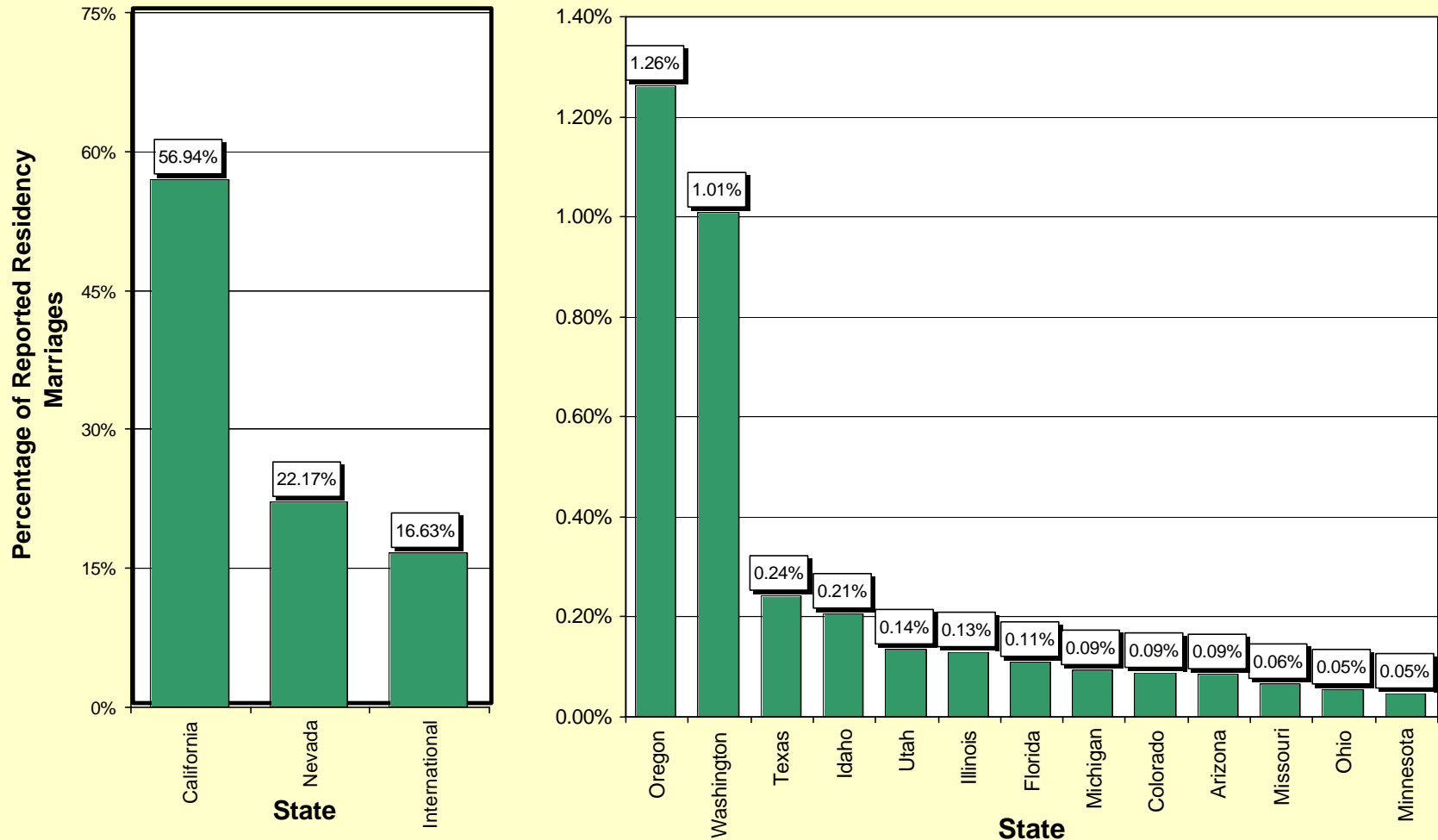

In 1999, 147,306 marriages were filed in Nevada. For those brides and grooms who reported their residency, the leading resident places were California (57%), Nevada (22%), and International Countries (17%), followed by border states, e.g. Oregon, Washington, and Idaho, and by states with large populations, e.g. Texas, Illinois, and Florida. More than 99% of marriages occurred in three heavy tourism oriented counties: Clark (91%), Washoe (7%), and Douglas (2%).

Divorces are only granted to Nevada residents who have resided in the state at least 6 weeks. In 1999, there were 14,152 divorces filed in Nevada and the divorce rate was 7.2 per 1,000 population, 71% higher than the national average (US 1998 = 4.2/1,000). Historically, Nevada's divorce rates have consistently been the highest in the nation, which may reflect relatively lenient state laws, combined with Nevada's small population base, resulting in disproportionately high rates. The counties with the highest divorce rates in Nevada were Douglas (27.4/1,000), Churchill (10.1/1,000), Carson City (9.0/1,000), Clark (7.1/1,000), and Washoe (6.5/1,000), again heavy tourism oriented counties.

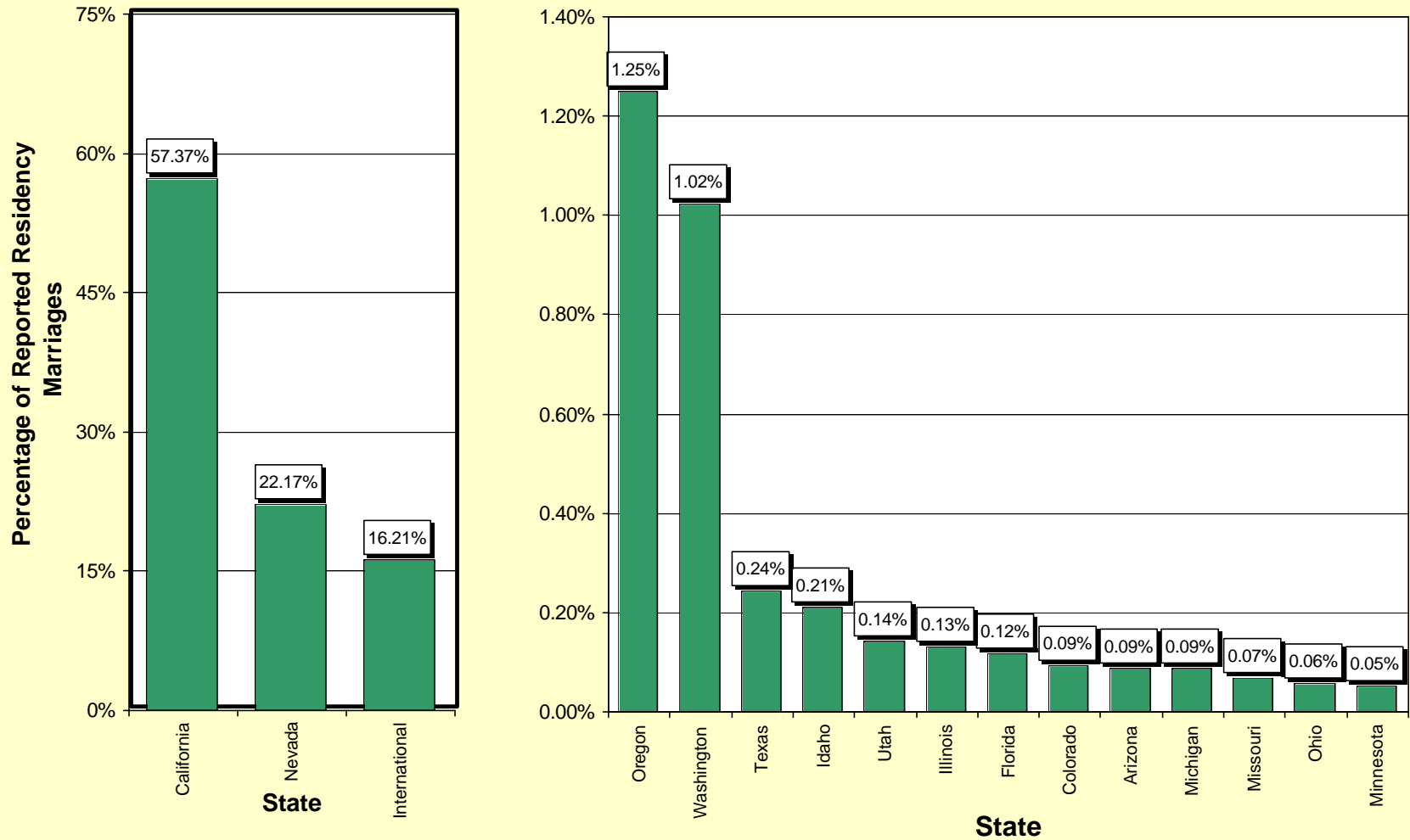

Figure 5. Divorce Rates (Per 1,000 Population) for Nevada and the US, Selected Years 1950-1999

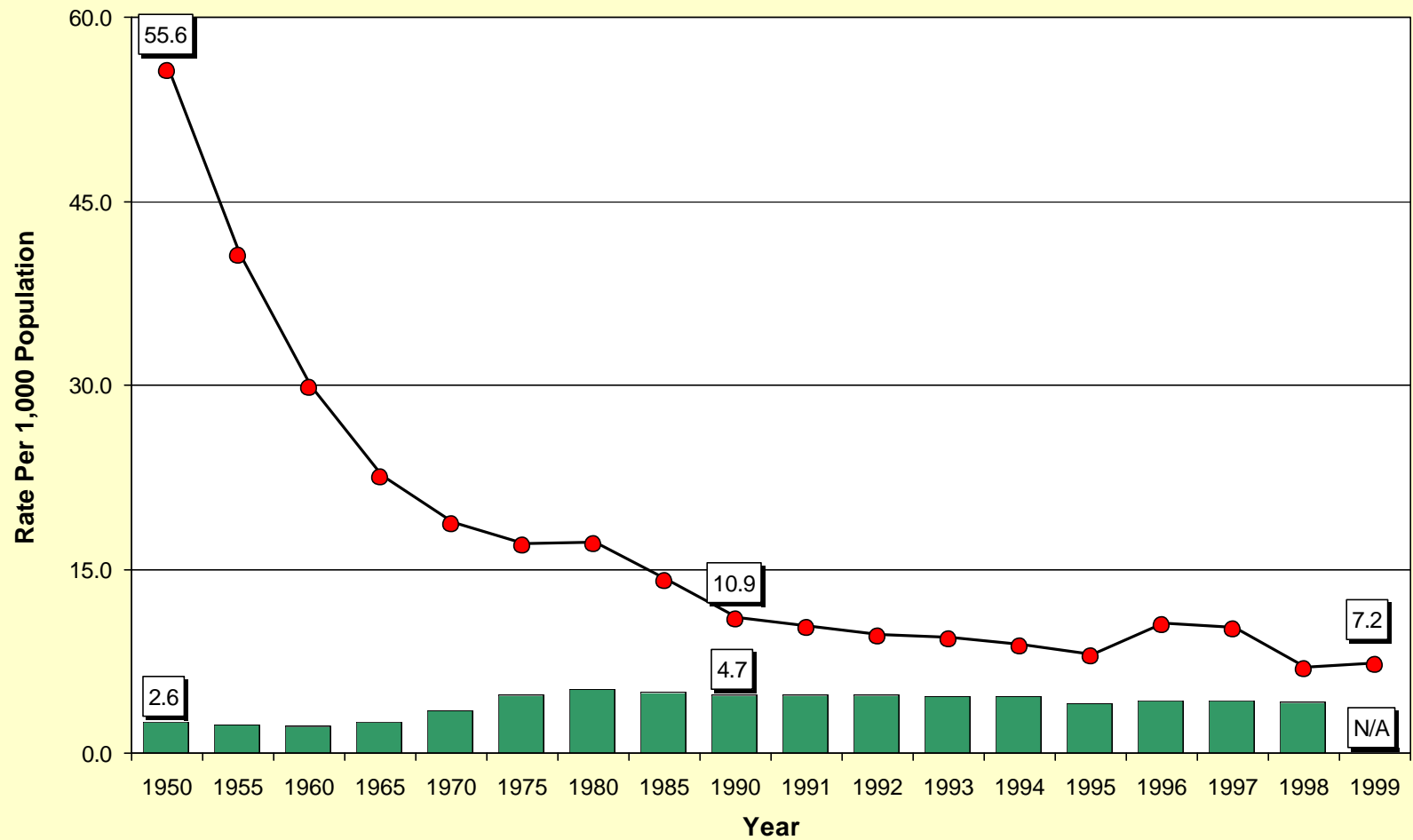


Figure 6. Divorce Rates in Nevada by County, Nevada Residents, 1999

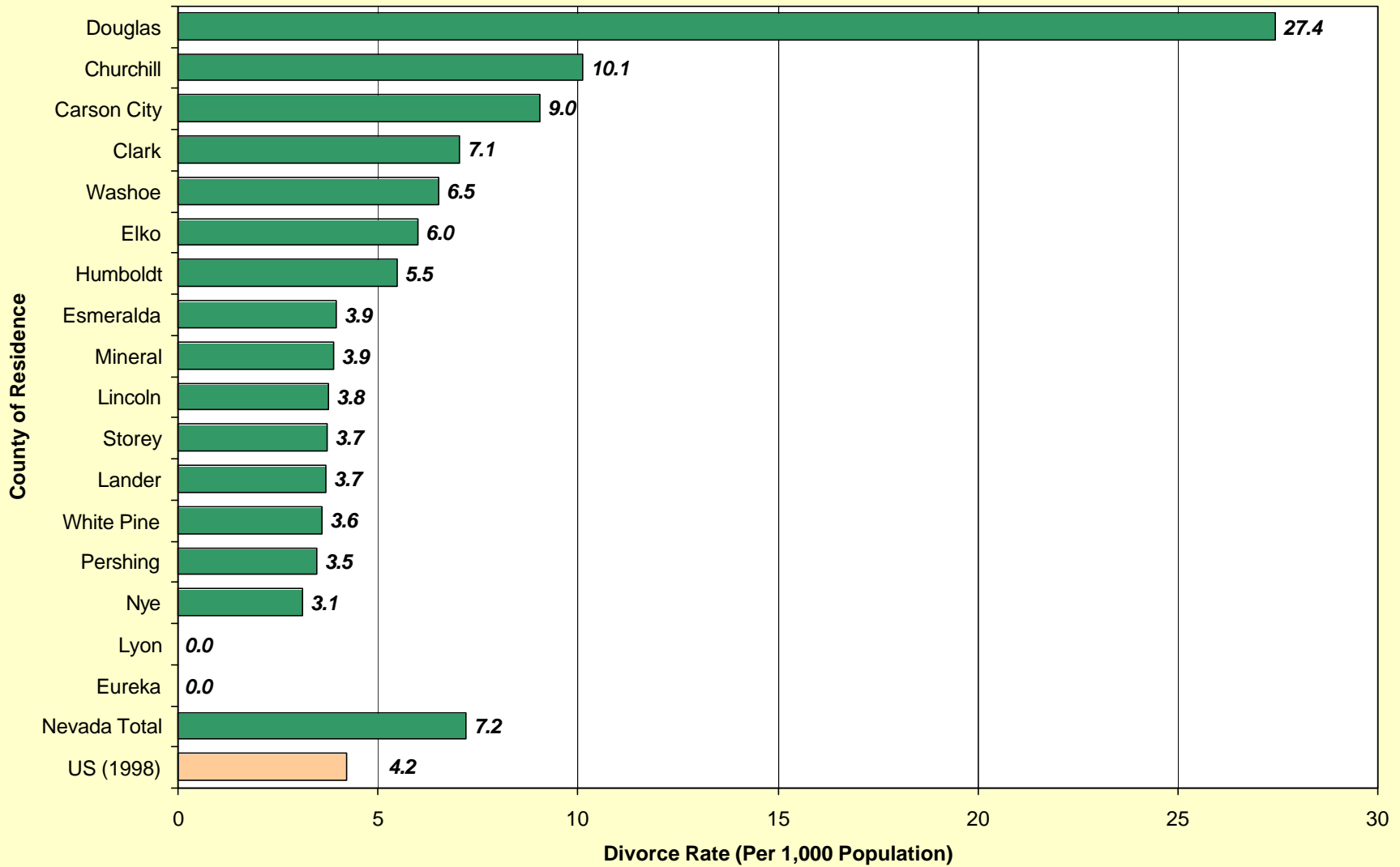

Nevada experienced an increasing birth rate from 1985 to 1990 followed by a moderate decrease in the rate through 1999 with a slight increase from 1996 to 1997. There were a total of 29,235 live births in Nevada in 1999, among them 28,911 births with the mother's residency of Nevada. The crude birth rate for Nevada residents was 14.7 per 1,000 population, while the Hispanic ethnic group had a crude birth rate of 27.4 per 1,000 population.

Figure 7. Crude Birth Rate by County/Region of Residence, Nevada, 1989-1999

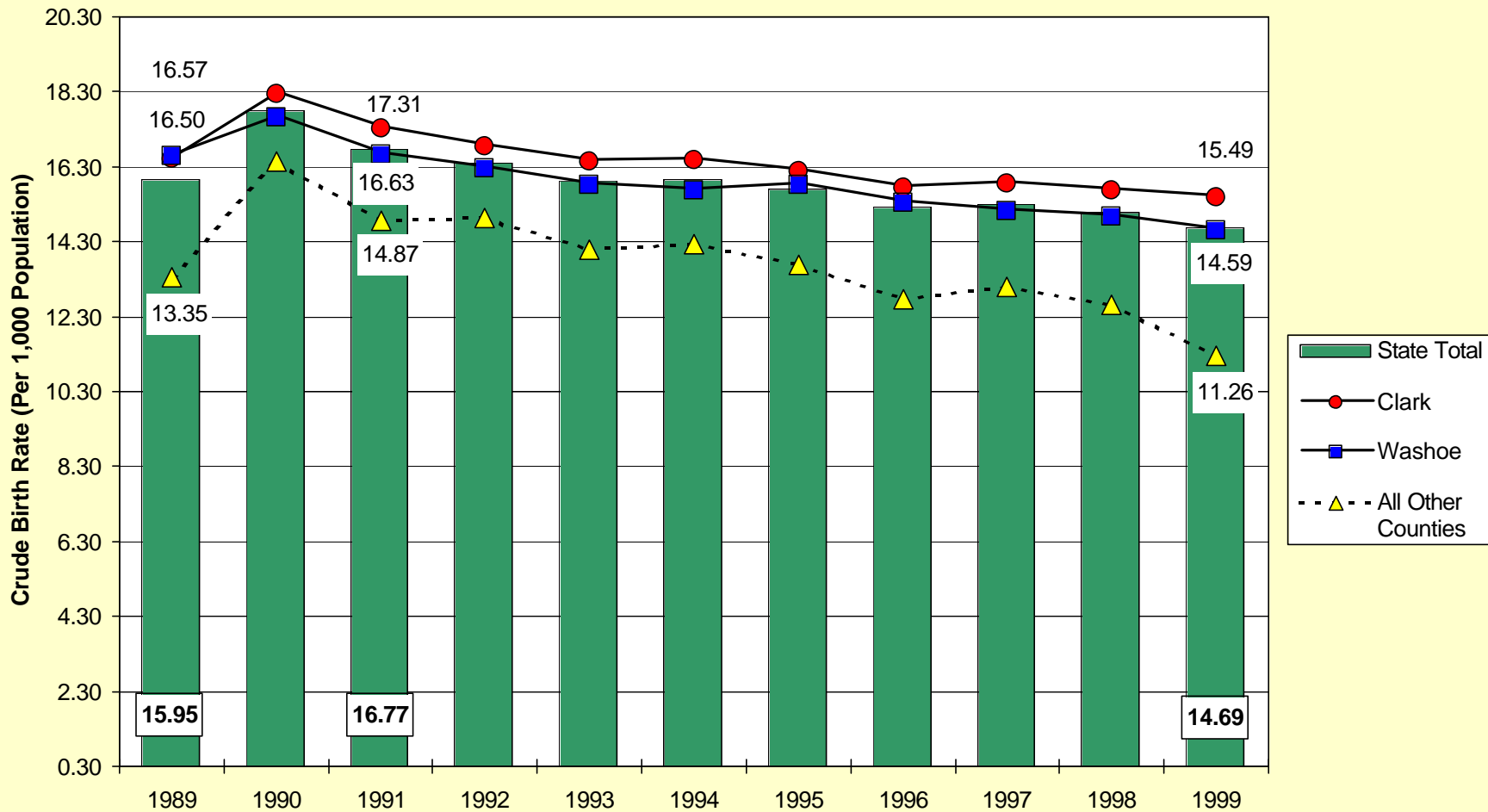
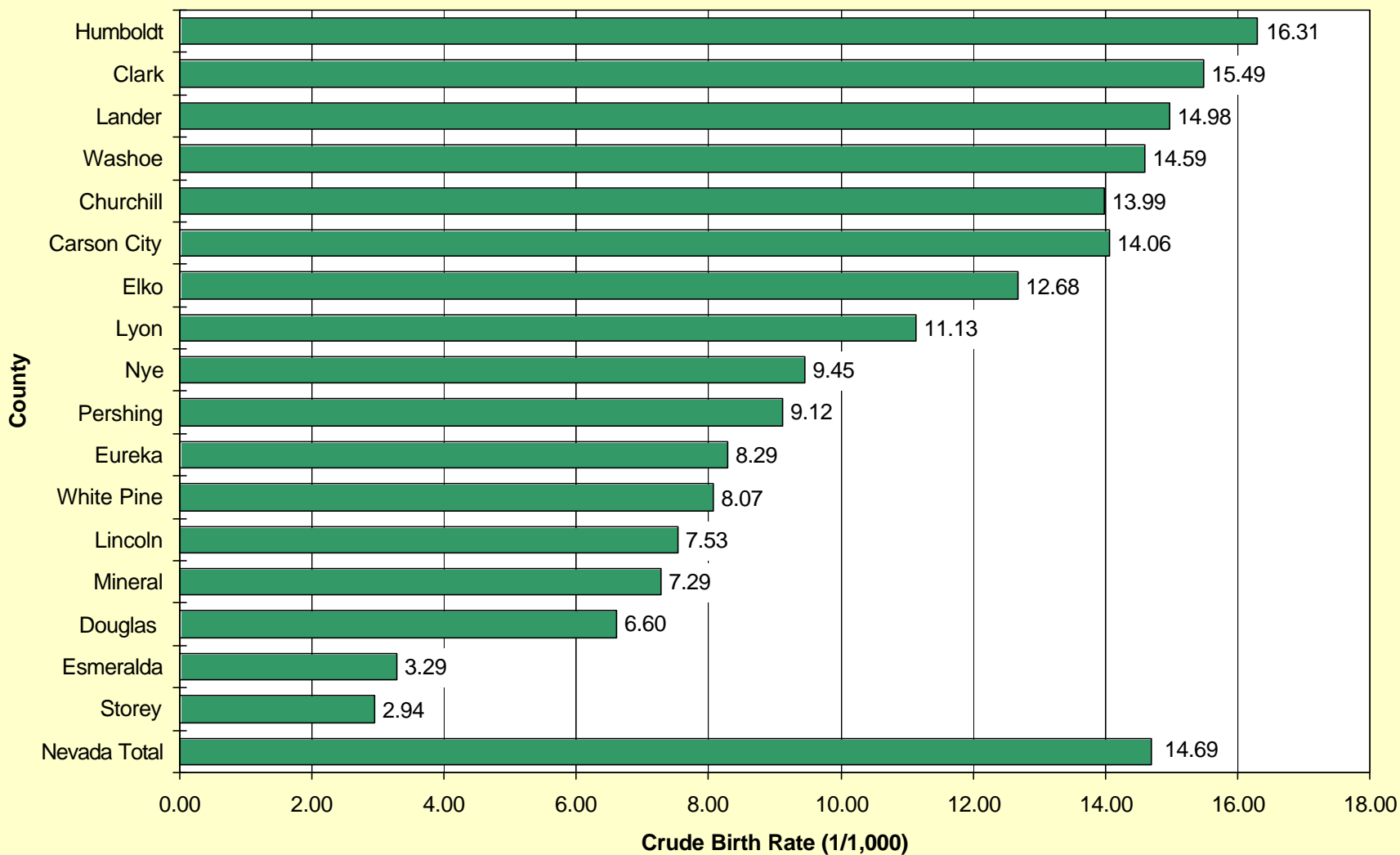


Figure 8. Crude Birth Rate by County of Residence, Nevada, 1999

Nevada Residents, 1999**

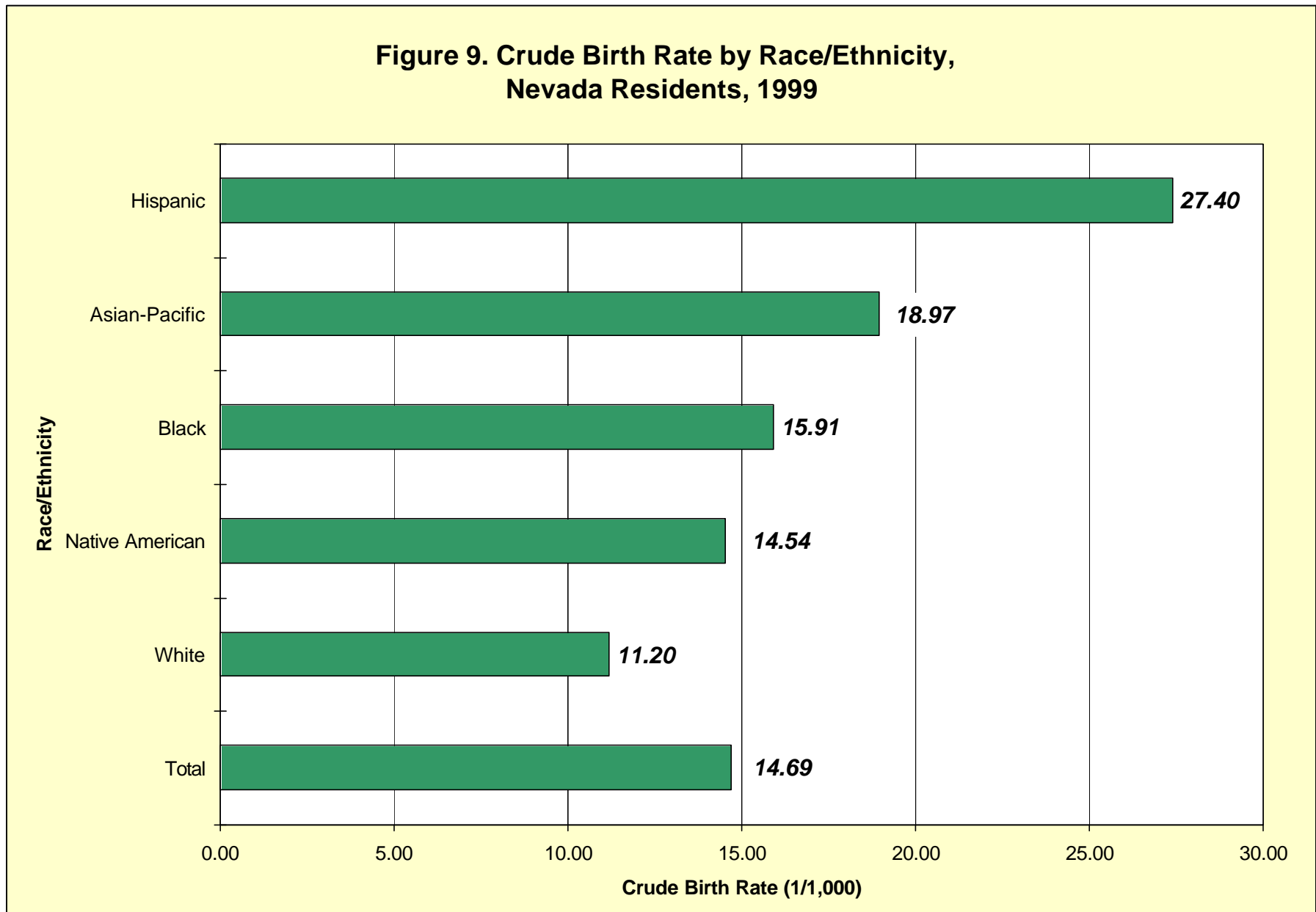
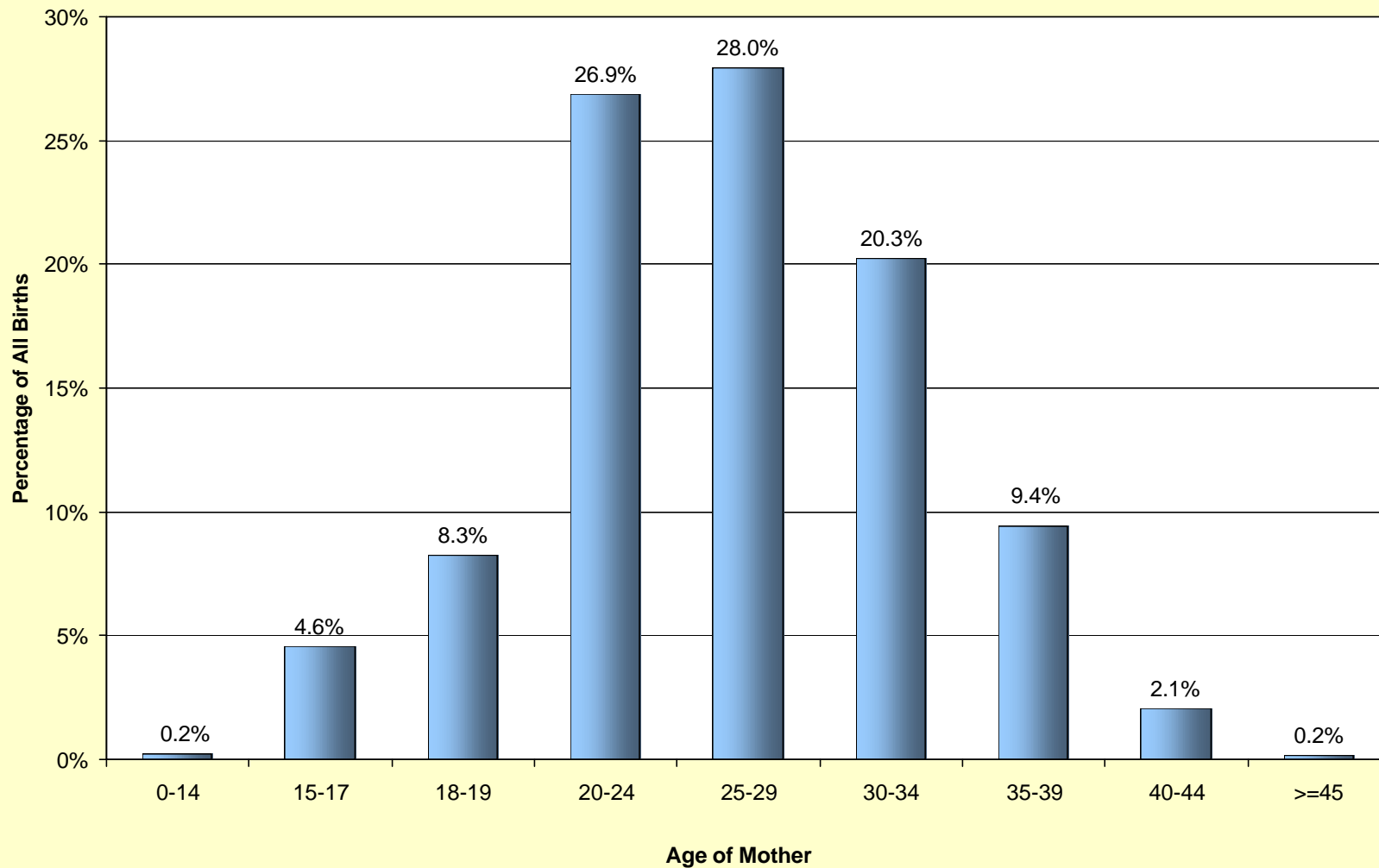


Figure 10. Percentage of All Births by Age of Mother, Nevada Residents, 1999

The rate of prenatal care in the first trimester increased from 71.6% in 1992 to 79.0% in 1996 followed by a decrease in rates in 1997 (77.8%) and 1998 (76.7%). The rate was slightly increased in 1999 at 77.3%. In 1999, among the racial/ethnic groups, Whites had the highest prenatal care rate at 84.8%, followed by Asians 81.2%, Blacks 72.2%, Native Americans 66.4% and Hispanics 64.8%.

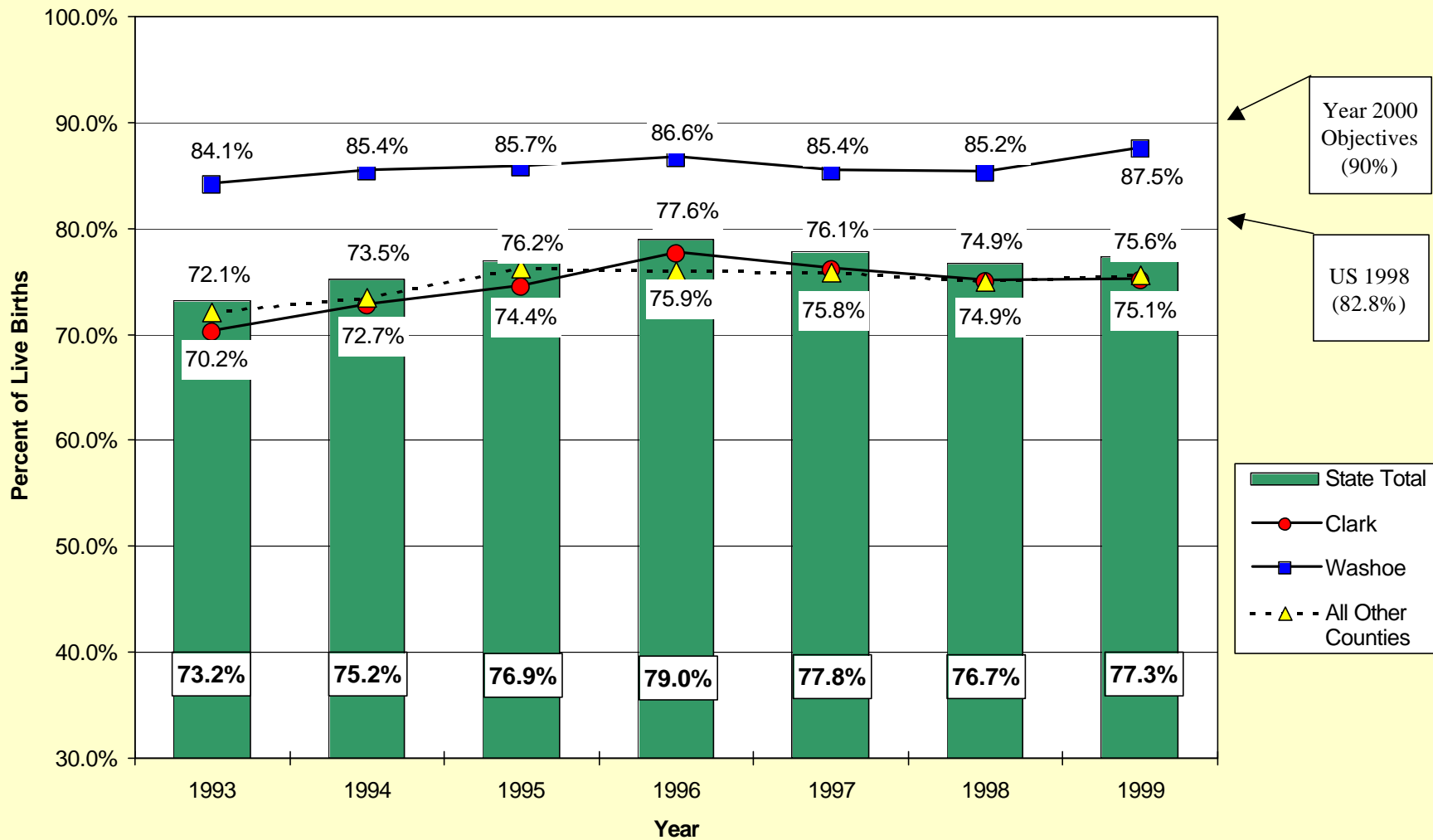
The incidence of low birthweight babies in Nevada was 7.6% in 1999, showing no change from the previous two years. Although the rate of Blacks improved from 14.1% in 1997 and 13.5% in 1998 to 12.8% in 1999, they still had the highest low birthweight rate among all racial/ethnic groups.

Teen pregnancy rates in Nevada continued the trend of decreasing during the past seven years for all three teen age groups. In 1992, the pregnancy rates for ages 10-14, 15-17 and 18-19 were 2.7, 62.4 and 158.9 per 1,000 population respectively, while in 1999, the rates decreased to 1.5, 48.0 and 124.4 per 1,000 respectively.

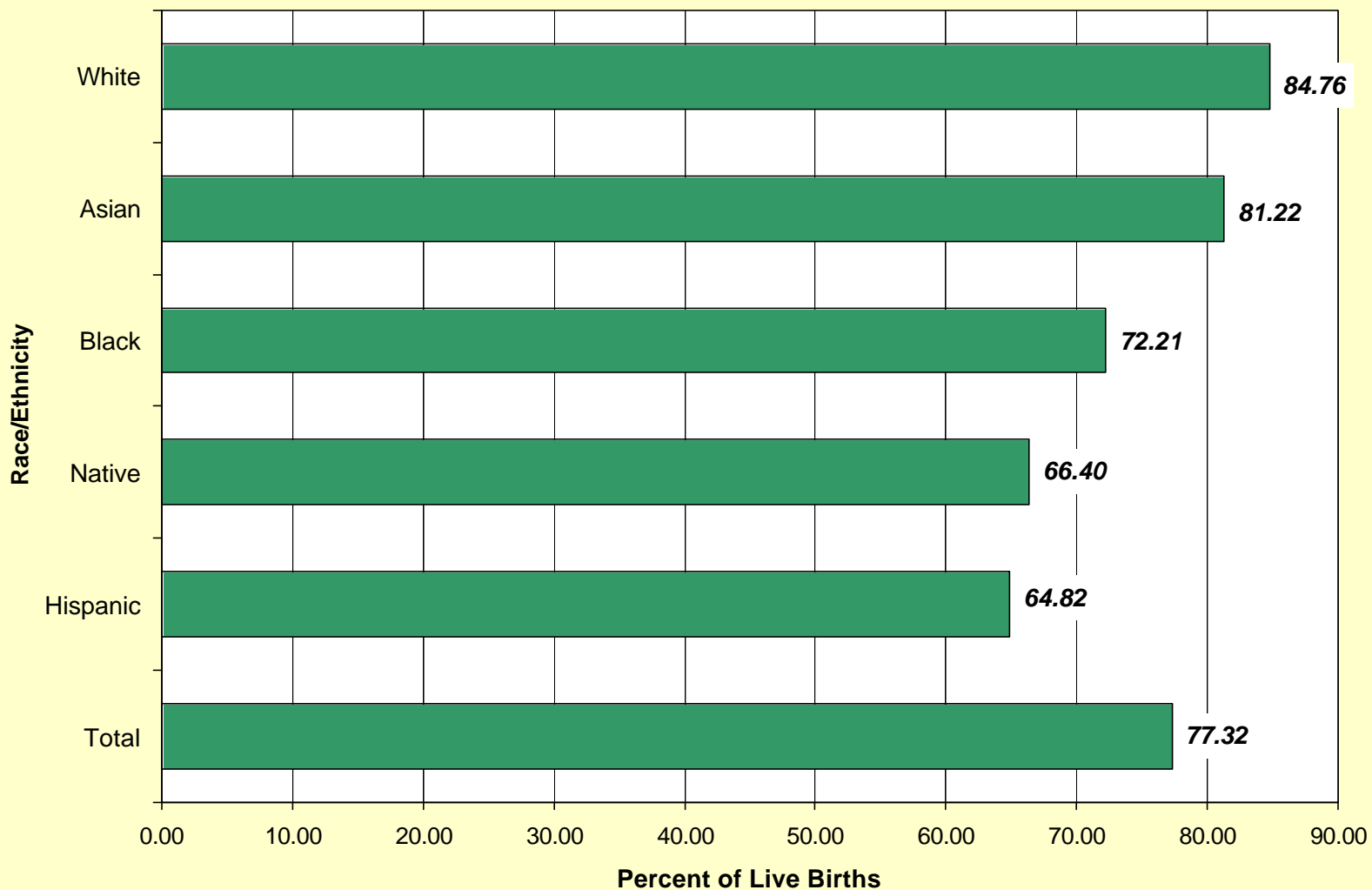

Nevada Residents, 1993-1999**

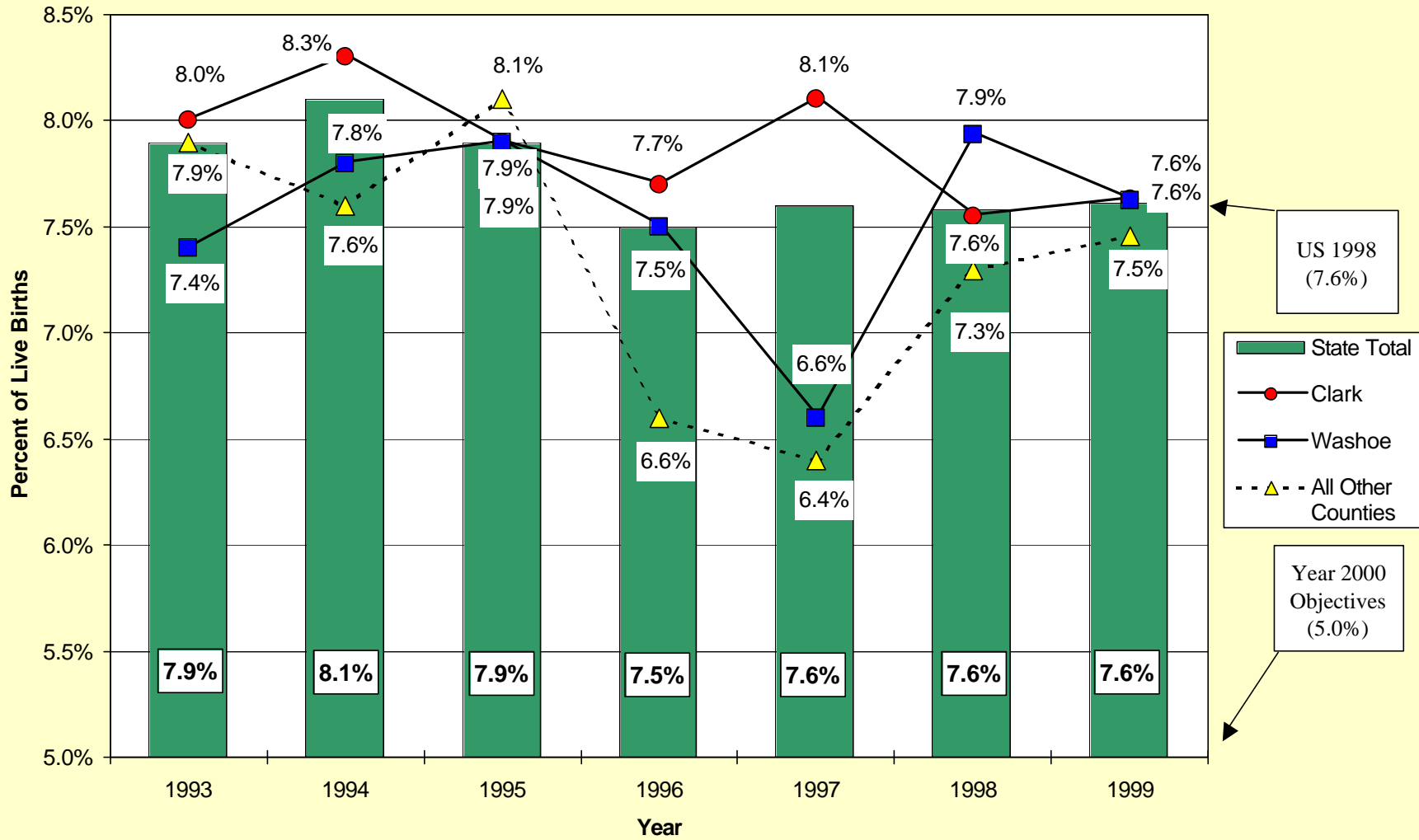


Figure 14. Low Birthweight (<2,500g) Percent by Race/Ethnicity, Nevada Residents, 1999

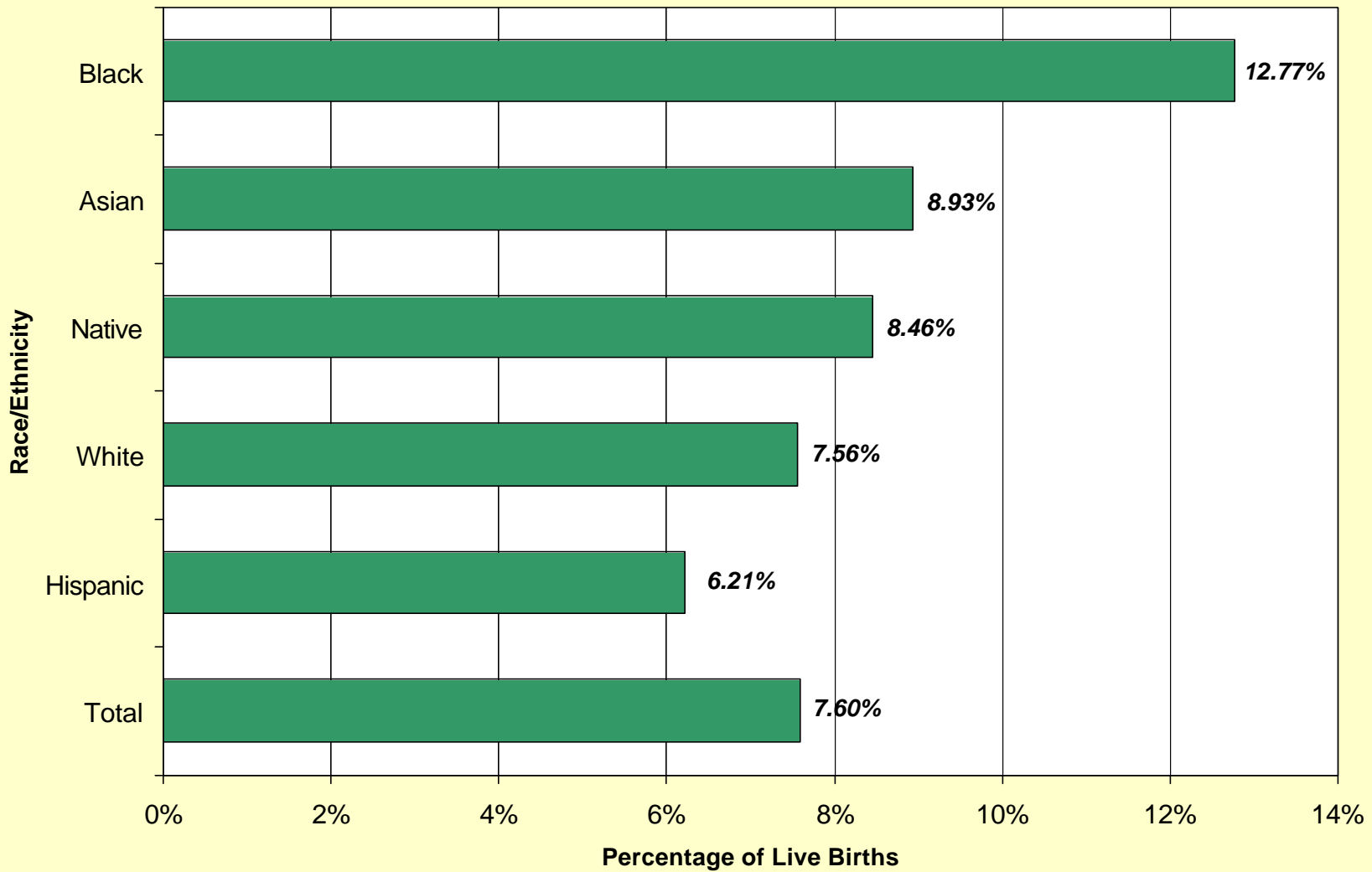


Figure 15. Teen Pregnancy (10-14yrs) Rate by Race/Ethnicity, Nevada Residents, 1993-1999

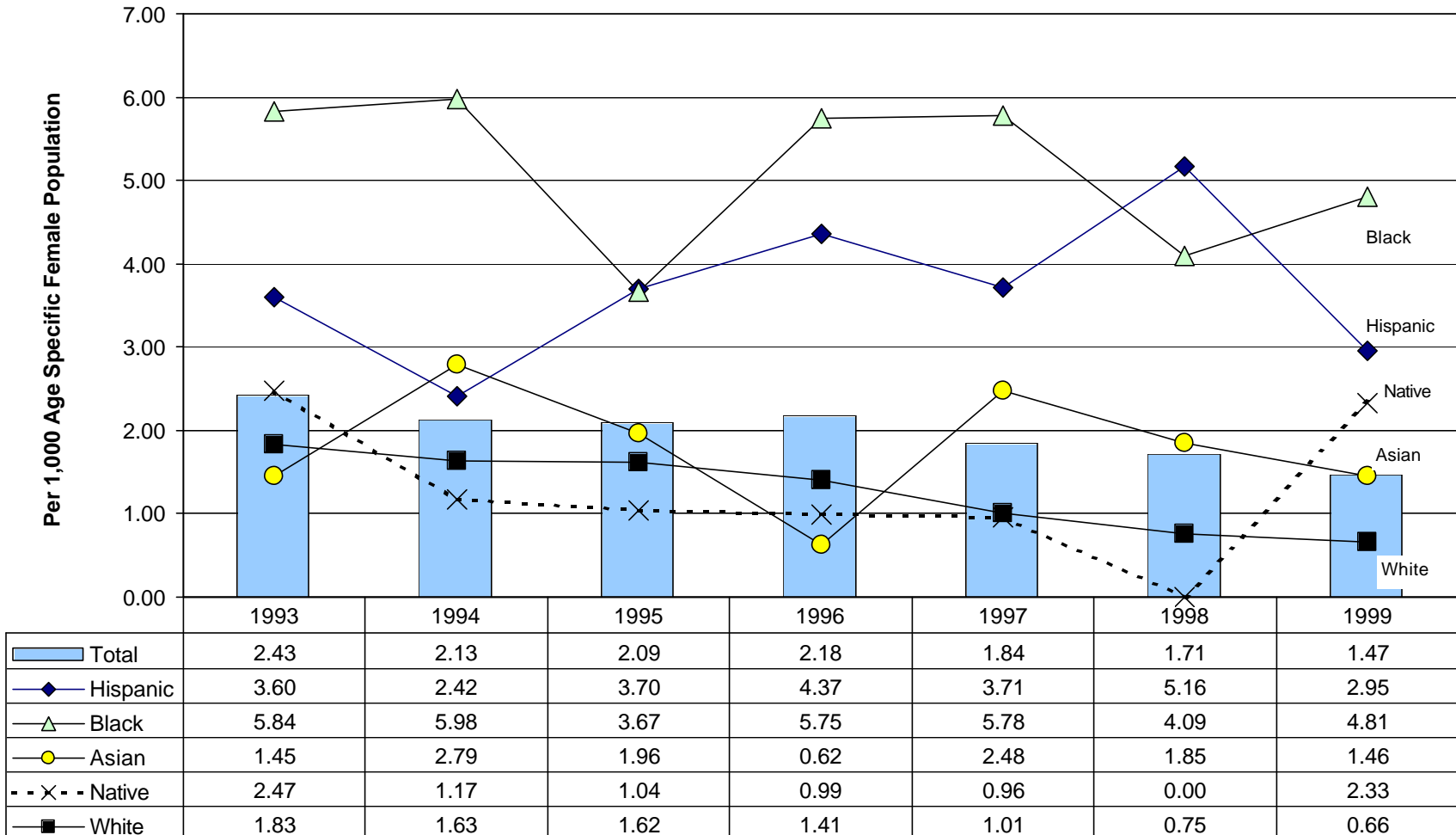
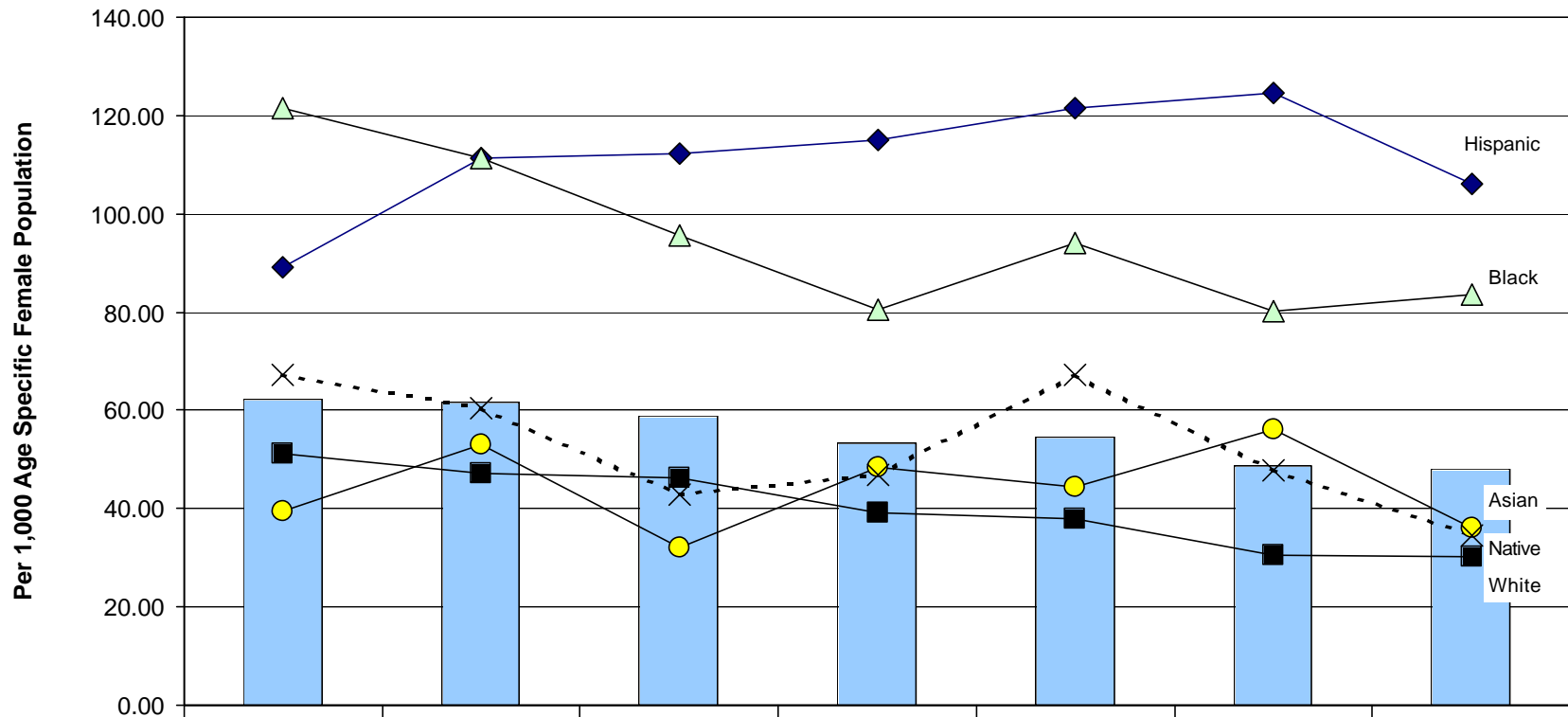
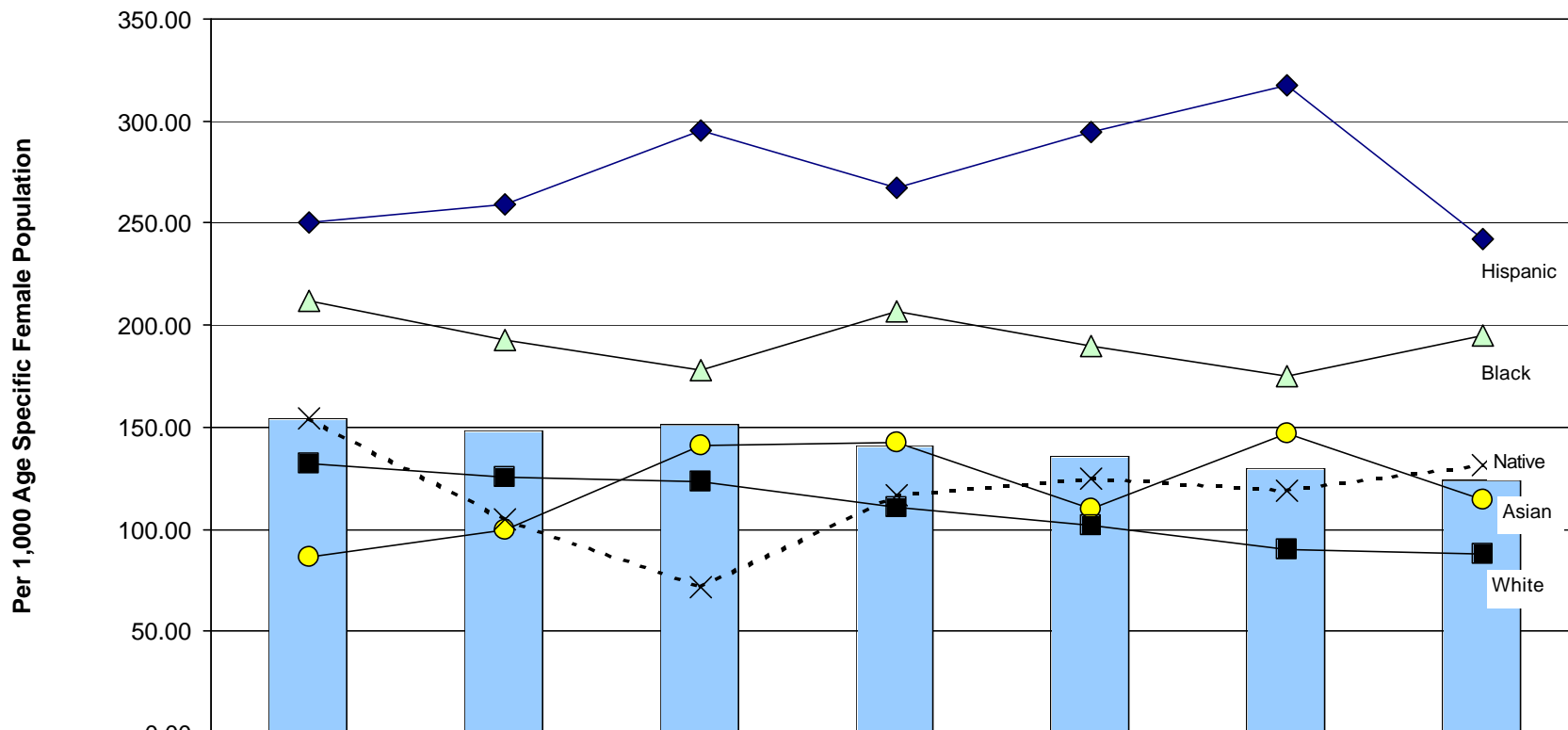


Figure 16. Teen Pregnancy (15-17yrs) Rate by Race/Ethnicity, Nevada Residents, 1993-1999



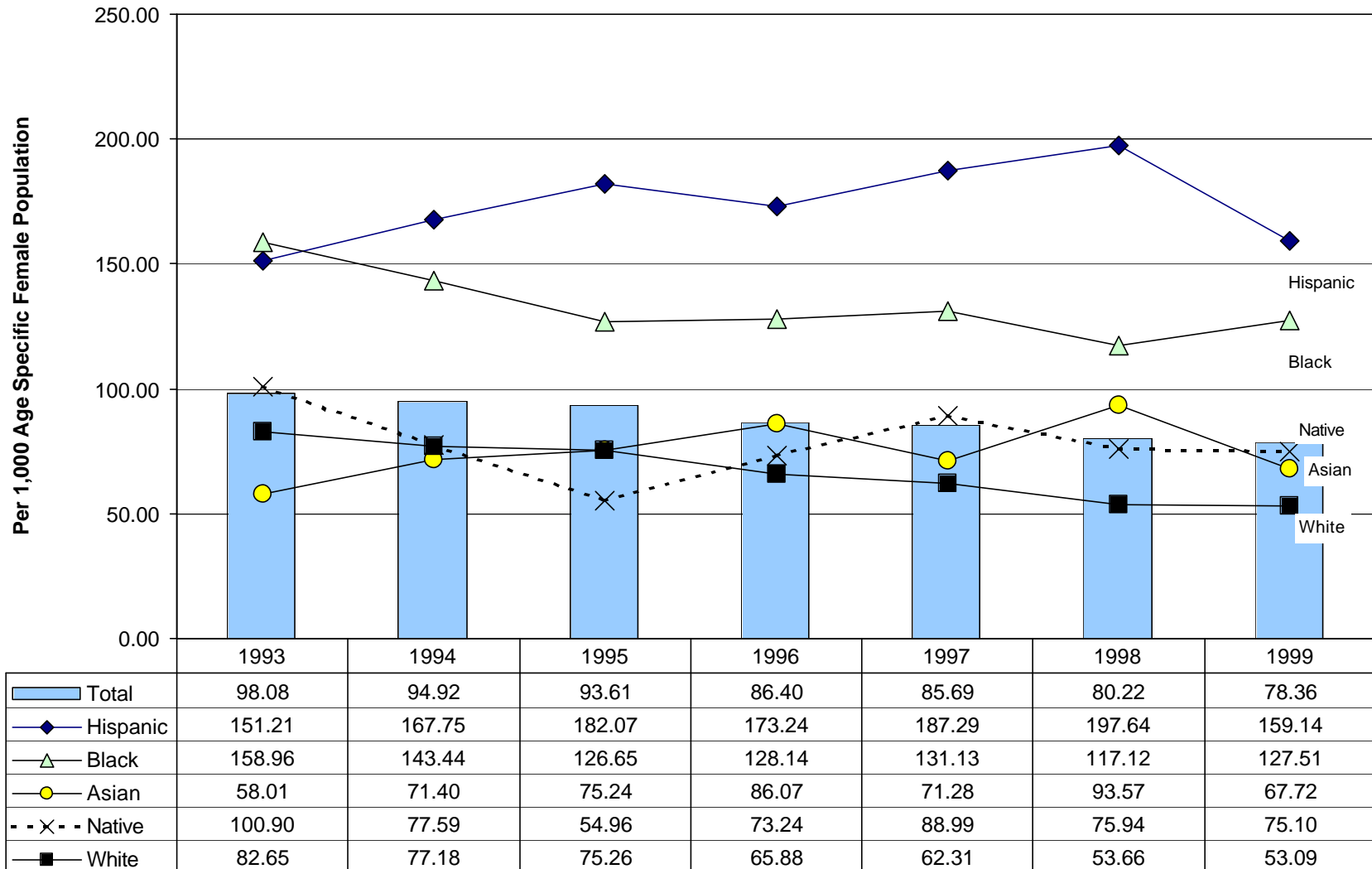

Recorded outcomes of pregnancies include live births, fetal deaths, and induced abortions. There were 34,262 total pregnancies among Nevada women in 1999, a slight increase from 1998's 34,233. Of these pregnancies, 28,911 were live births (increasing 2.2% from 1998's 28,275), 5,167 were induced abortions (a 10.5% decrease from 1998's 5,772), and 184 were fetal deaths (two cases less than in 1998).

In 1999, 15.1% of pregnancies among Nevada residents resulted in induced abortions, while 20.1% of teenagers ended their pregnancies by induced abortions.

Figure 19. Abortion Rate by County/Region of Residence, Nevada Residents, 1995-1999

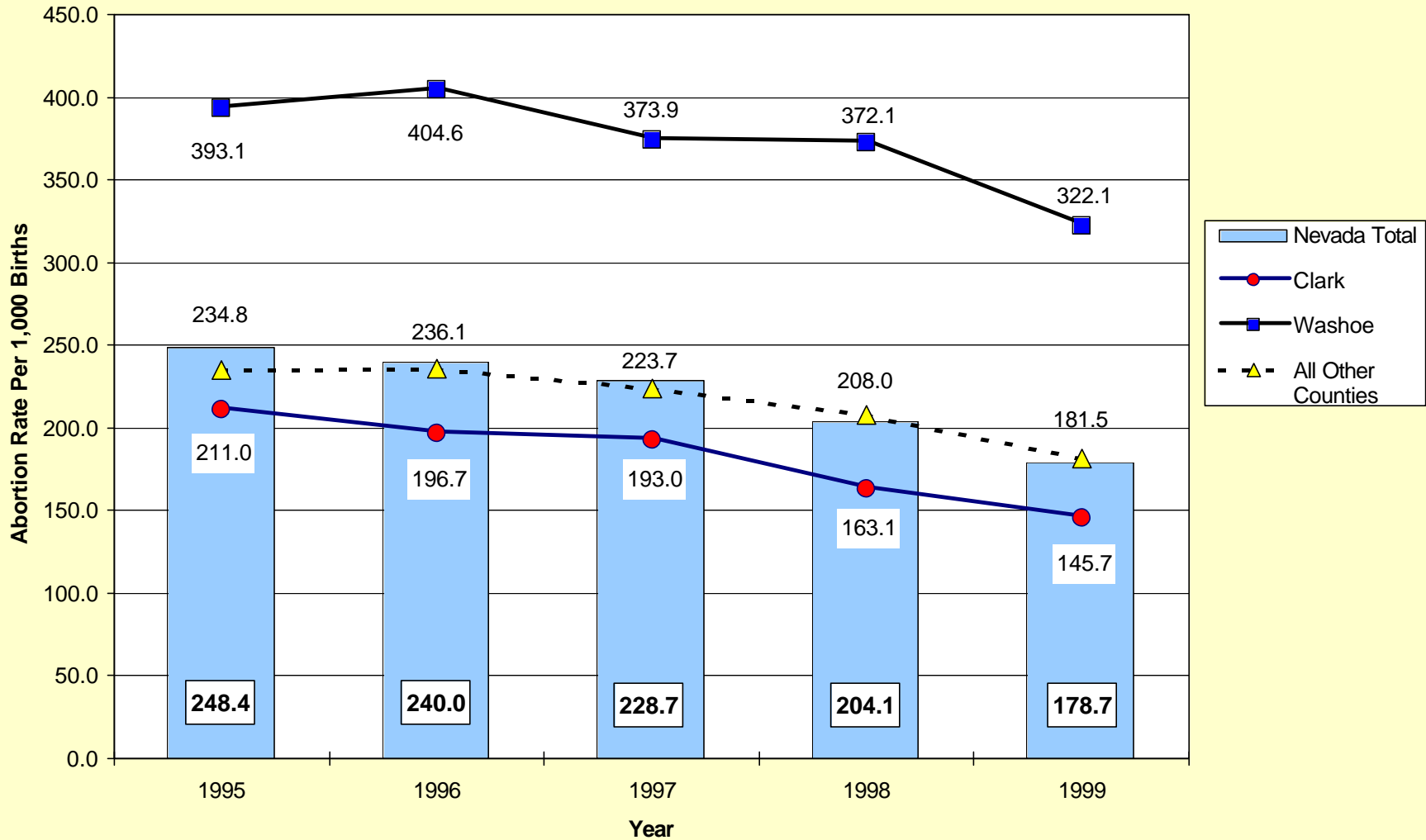


Figure 20. Percentage of All Abortions by Age of Mother, Nevada Residents, 1999

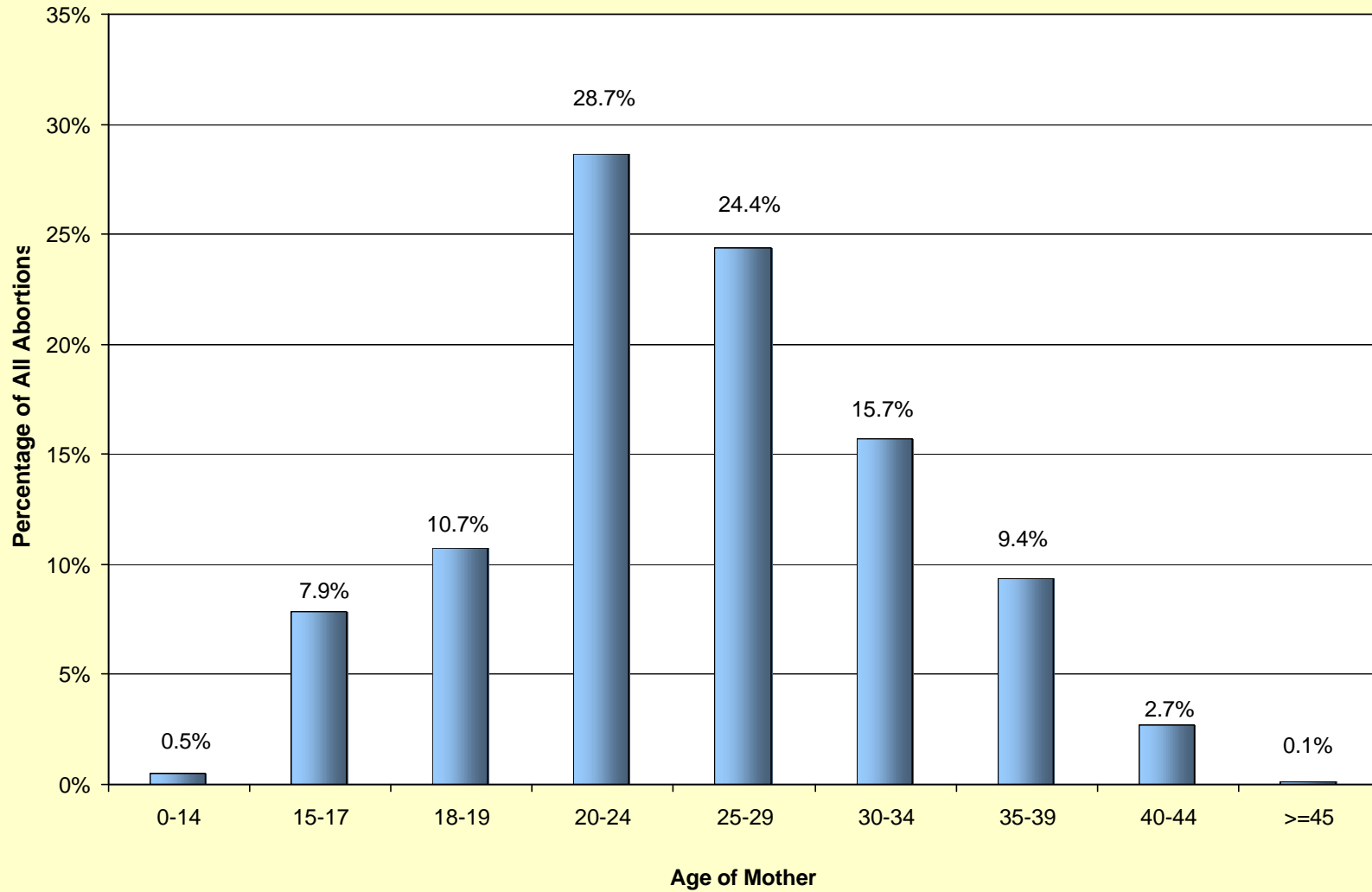


Figure 21. Percentage of All Induced Abortions by Number of Previous Abortions, Nevada Residents, 1999

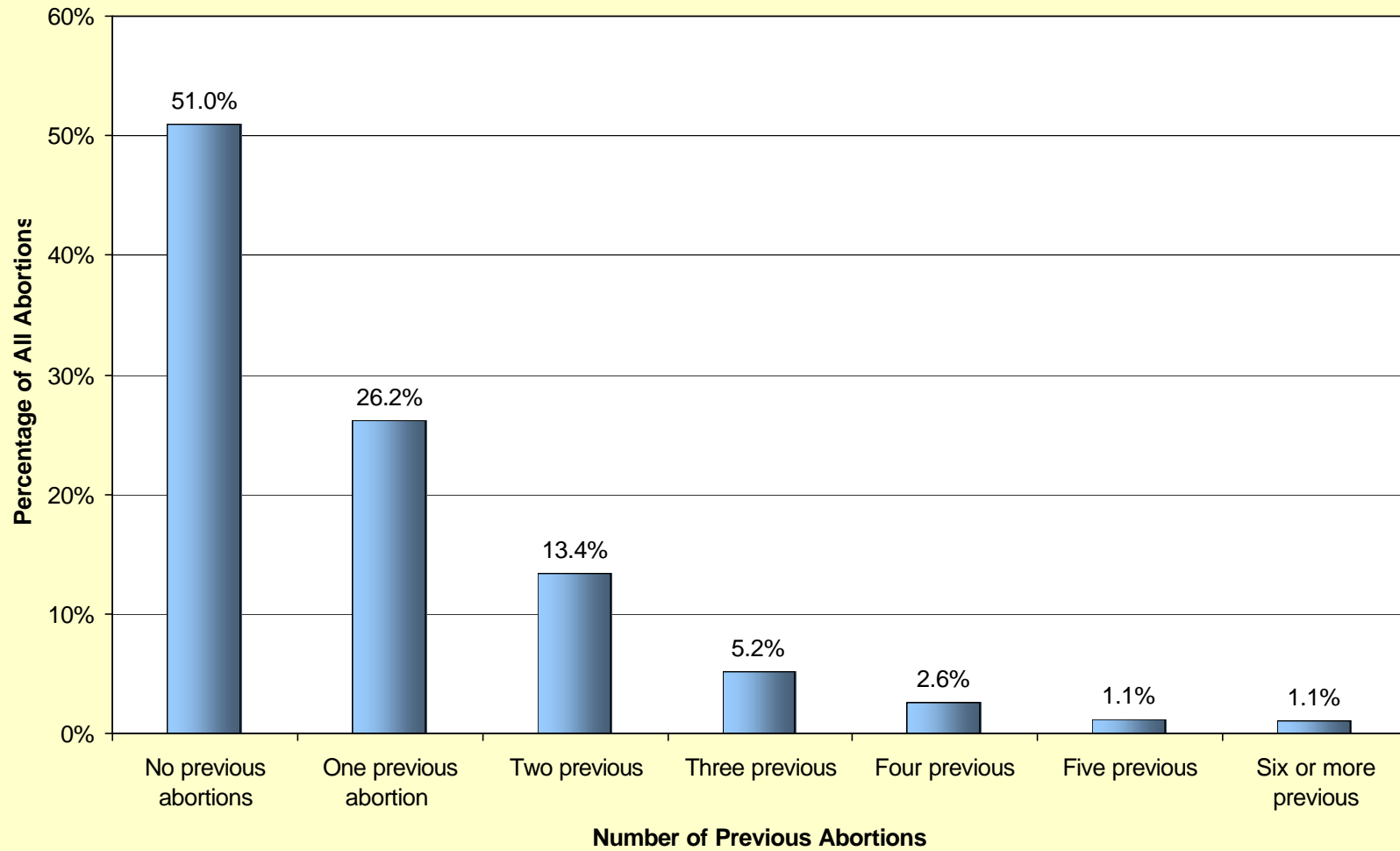

In 1999, Nevada's infant mortality rate was 6.6 per 1,000 live births, a slight decrease from Nevada's peak of the last seven years, 6.9 per 1,000 births, in 1998. Washoe County (from 9.2 to 6.8) as a region, and Blacks (from 17.0 to 12.8) as a race/ethnicity group contributed to this improvement in rate. Although improved significantly, Blacks still had the highest infant mortality rate (12.8) among race/ethnicity groups, followed by Native Americans at 10.4, while Asians had the lowest rate at 3.1 per 1,000 live births.

There were a total of 14,843 Nevada residents who died in 1999, 68% of them were age 65 or older. Diseases of the heart and malignant neoplasms (i.e. cancers) ranked one and two respectively for the leading causes of death in Nevada. In 1999 these two diseases were responsible for 7,644 deaths in Nevada, accounting for 51.5% of total deaths in the State. When age-adjusted comparisons were made, Nevada's diseases of the heart mortality rate was higher than the national average, while the cancer rate was slightly lower.

After age-adjustment, race/ethnicity group comparisons indicate that Blacks had the highest death rates for both diseases of the heart and malignant neoplasms.

Figure 22. Infant Mortality, Nevada Residents, 1993-1999

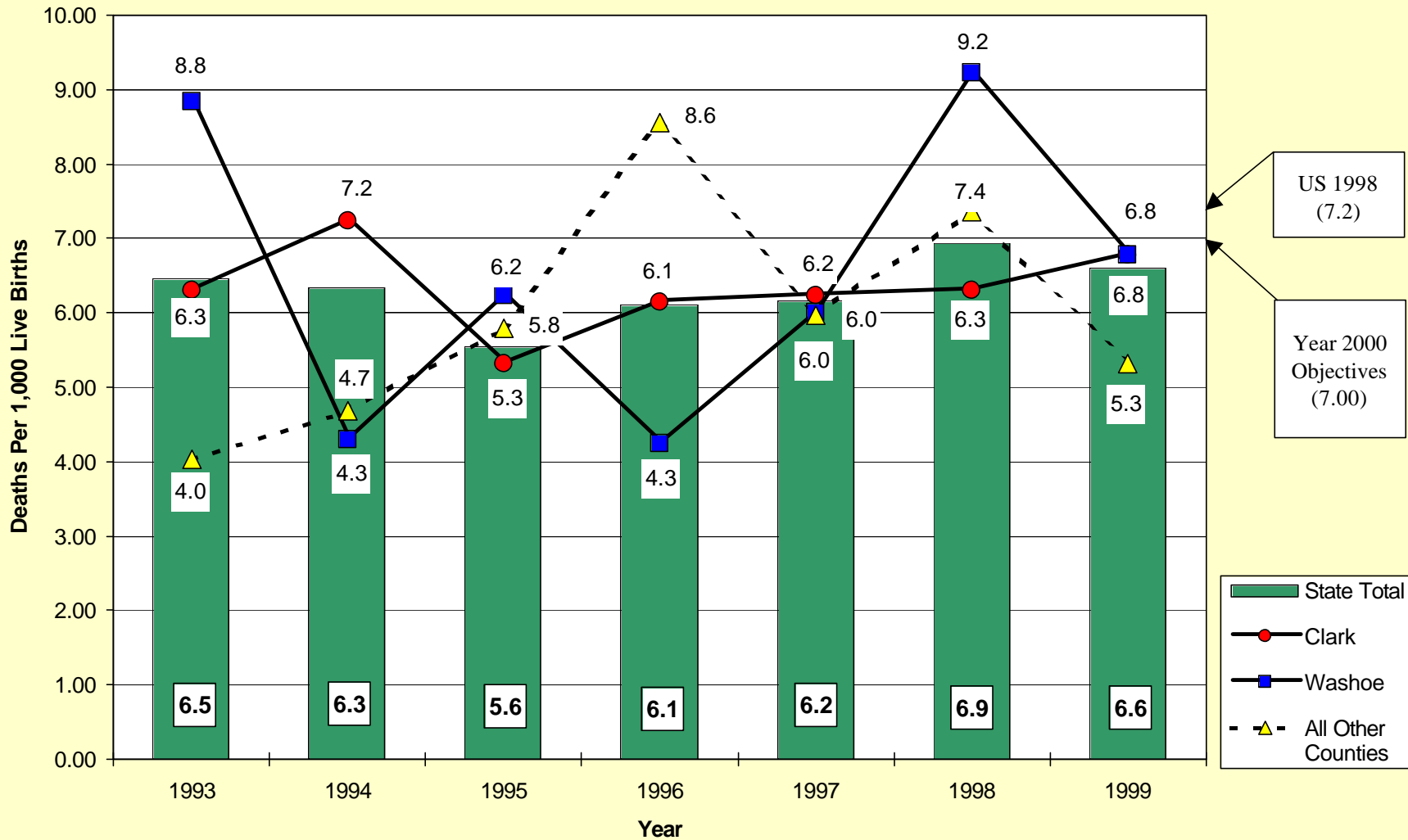


Figure 23. Infant Mortality by County/Region of Residence, Nevada, 1999

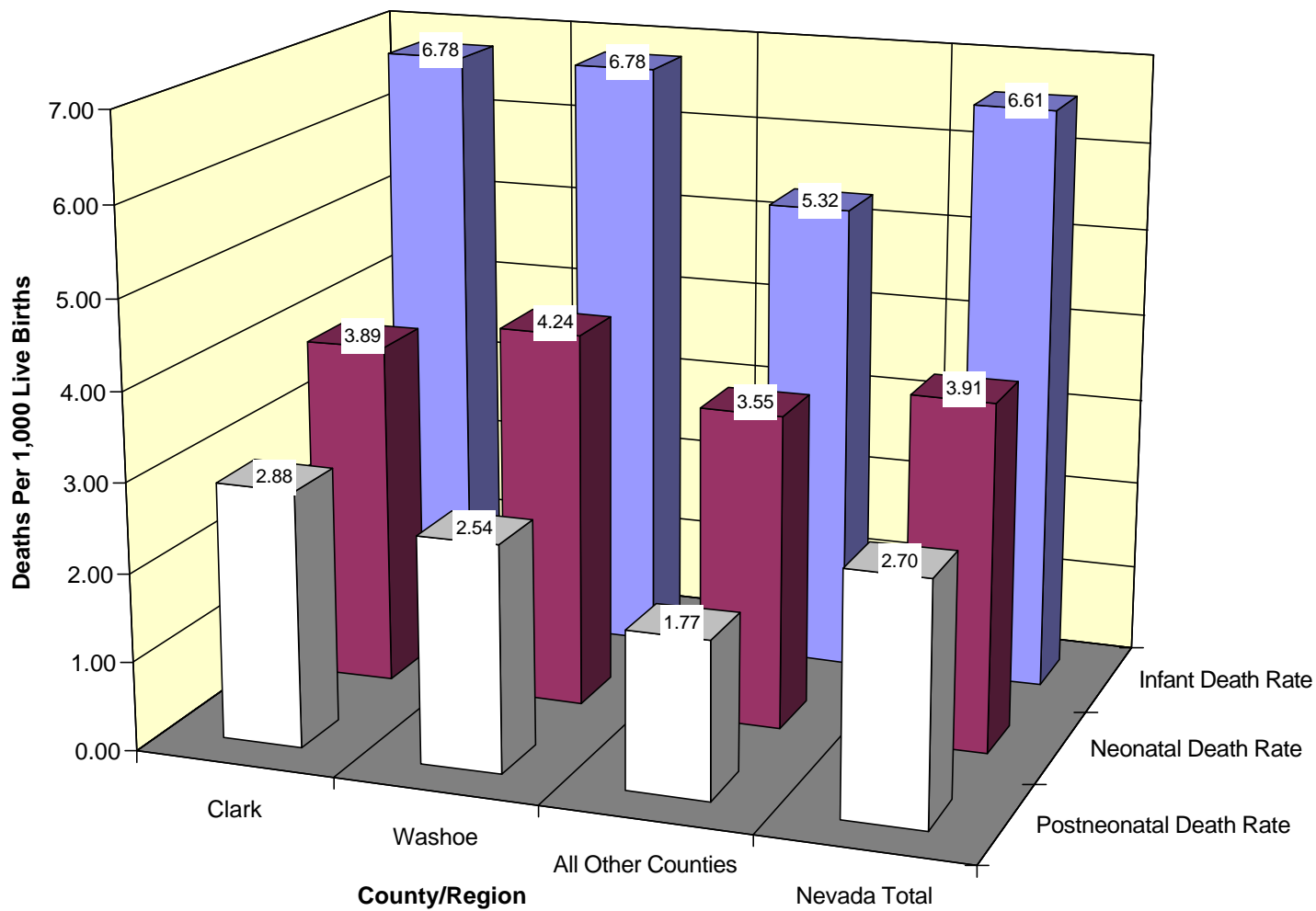


Figure 24. Infant Mortality by Race/Ethnicity, Nevada, 1999

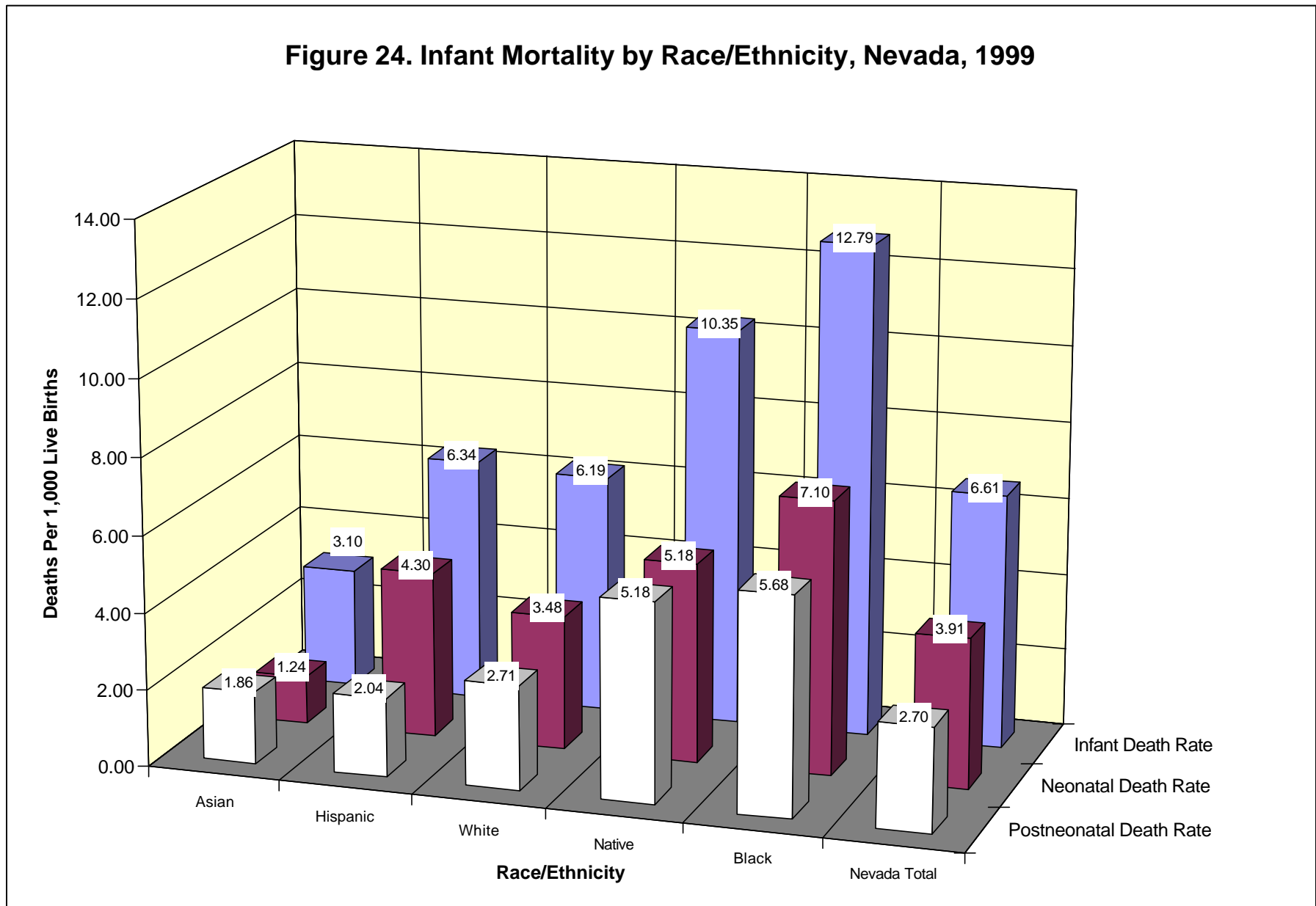


Figure 25. Fetal Deaths (>20 weeks), Nevada Residents, 1993-1999

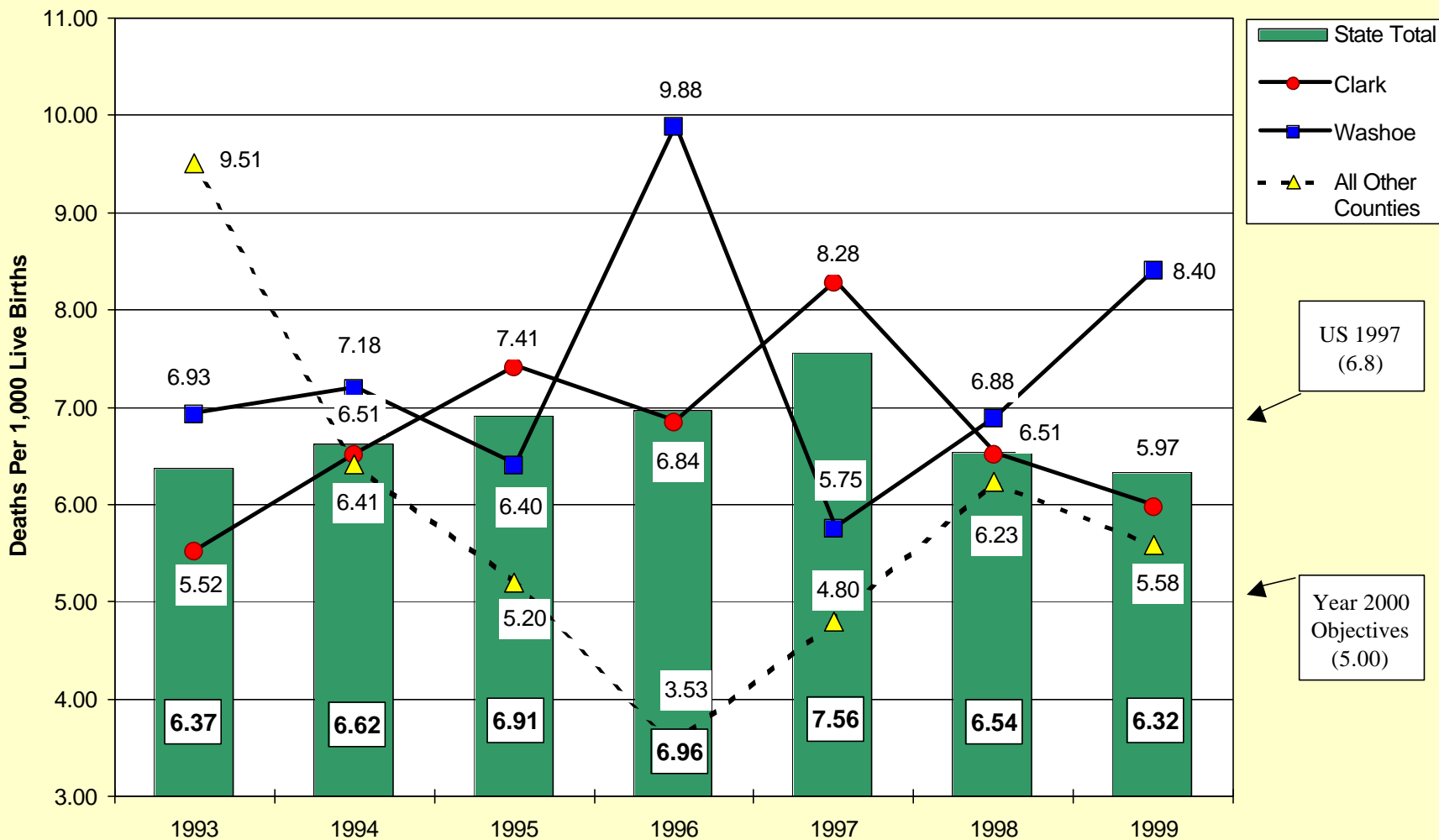


Figure 26. Leading Causes of Death as a Percentage of All Deaths, Nevada Residents, 1999

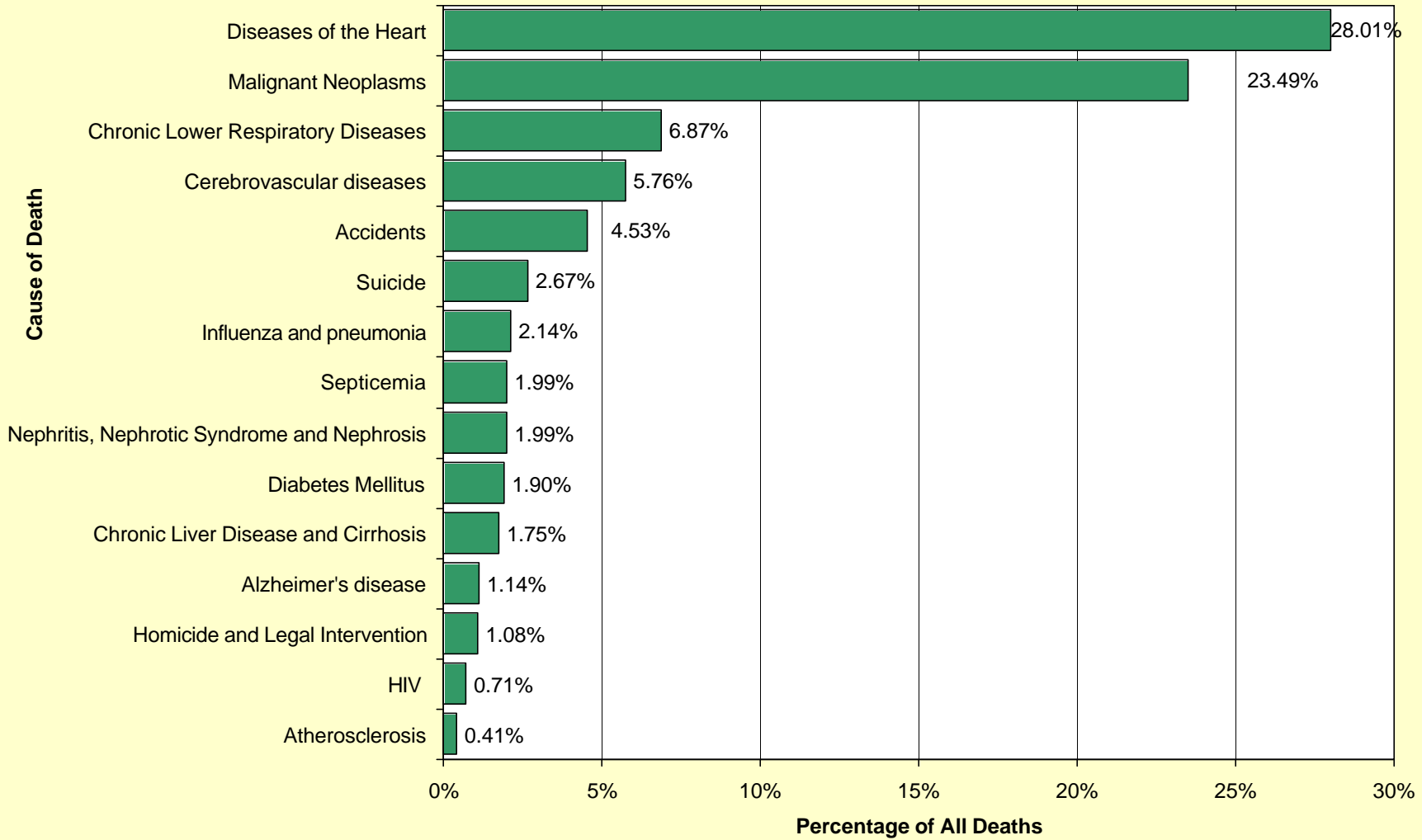


Figure 27. Death Rates for Diseases of the Heart by County/Region of Residence, Nevada, 1999

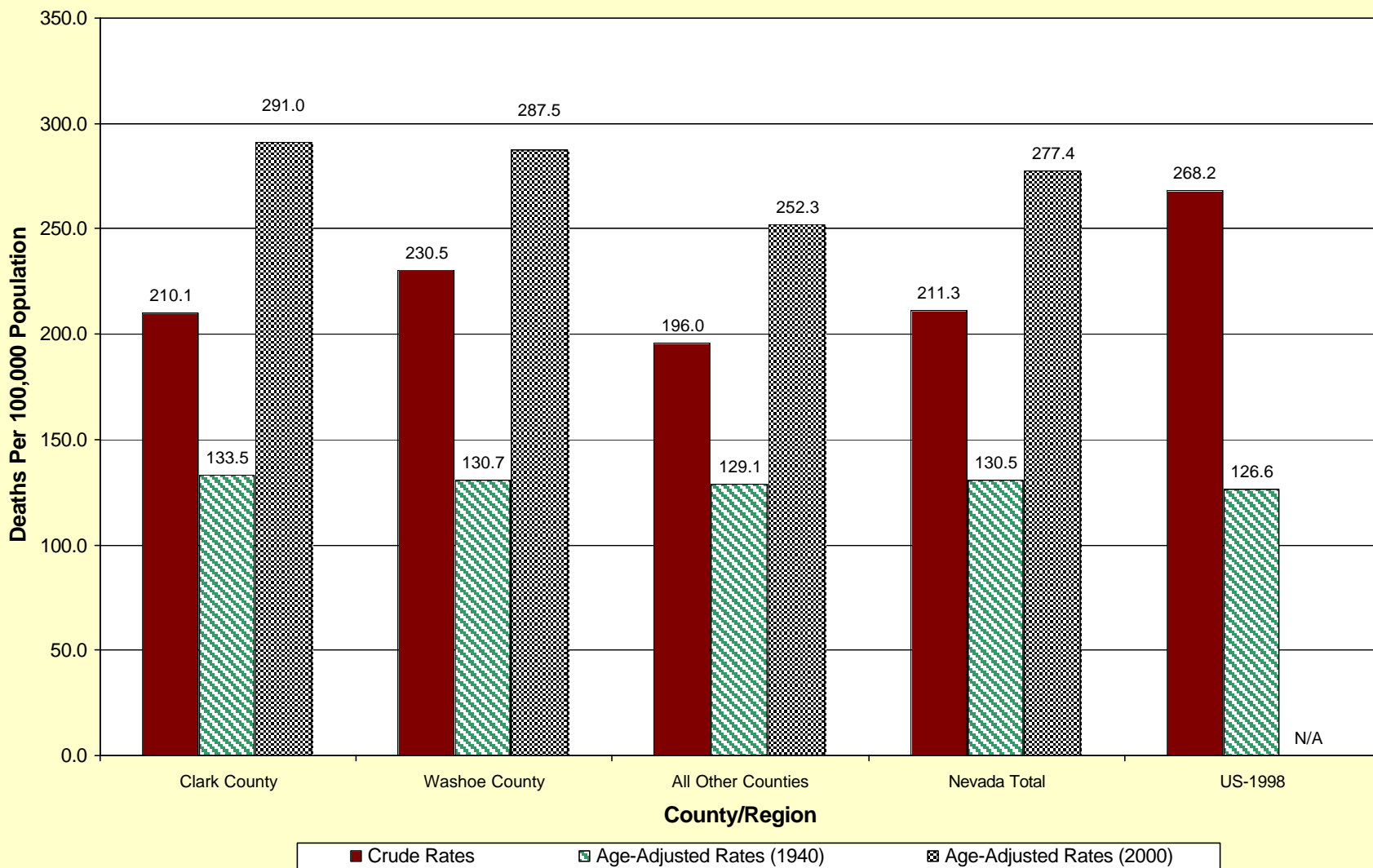


Figure 28. Death Rates for Diseases of the Heart by Race/Ethnicity, Nevada Residents, 1999

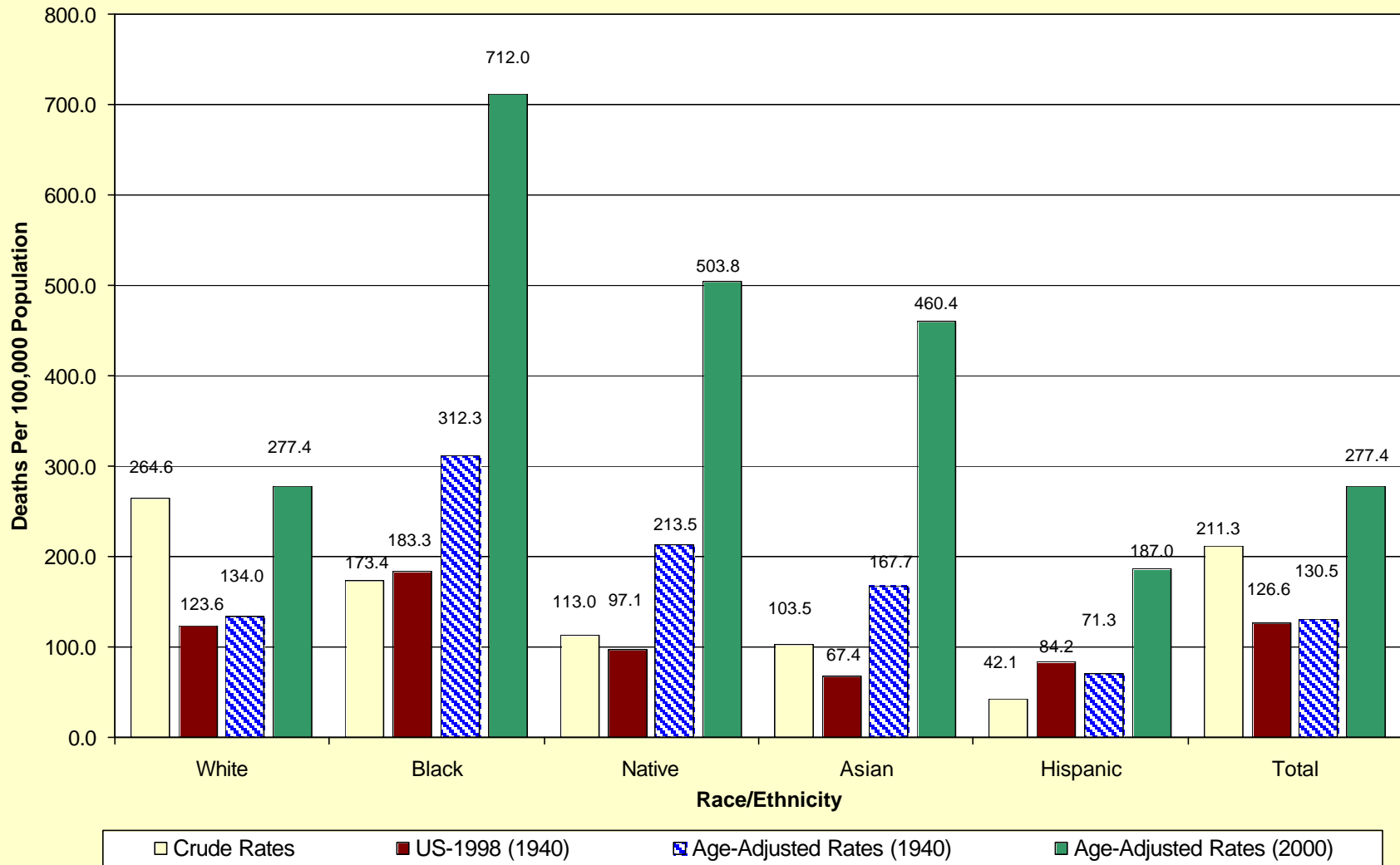


Figure 29. Death Rates for Cancer by County/Region of Residence, Nevada, 1999

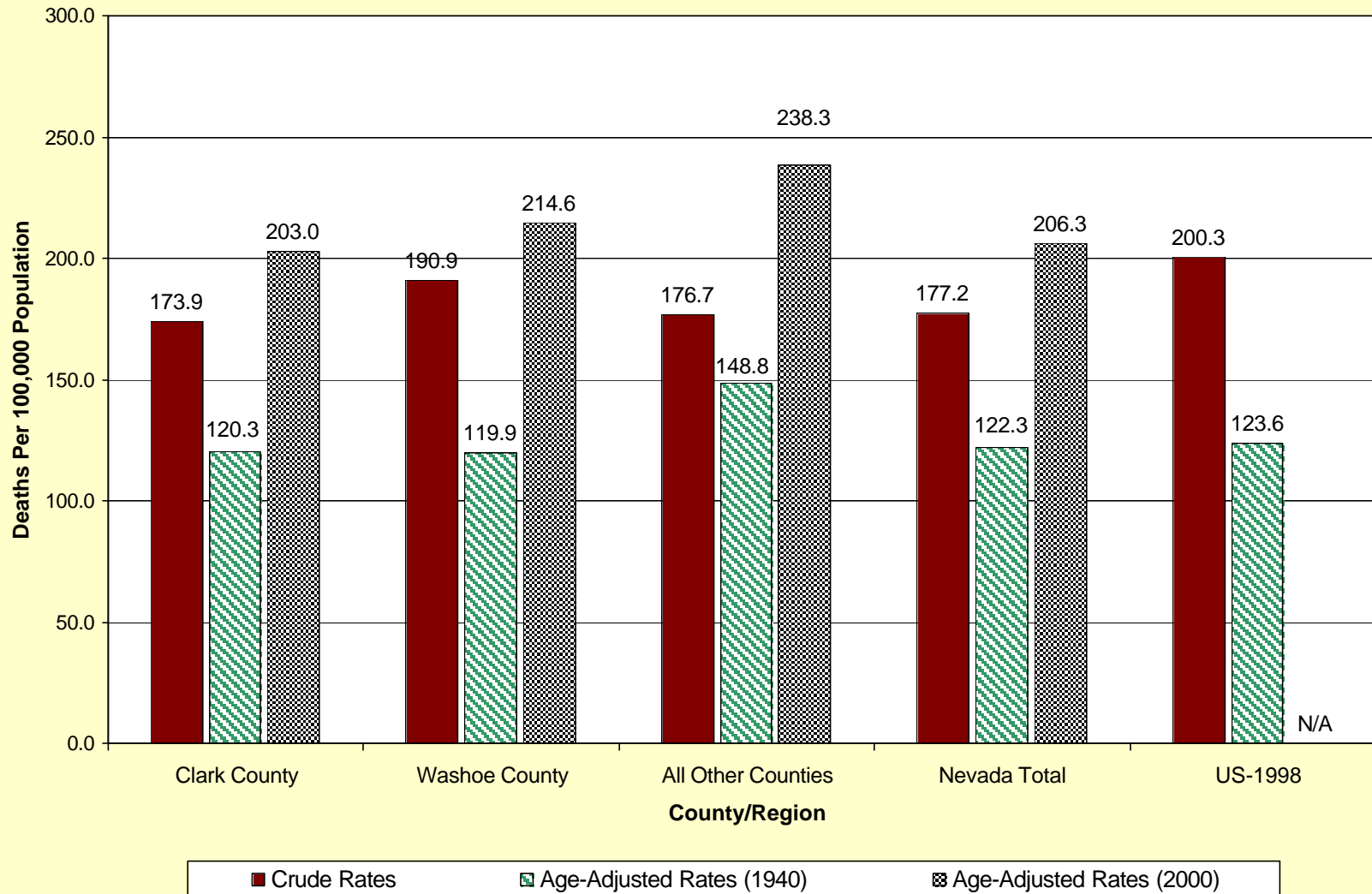


Figure 30. Death Rates for Cancer by Race/Ethnicity, Nevada Residents, 1999

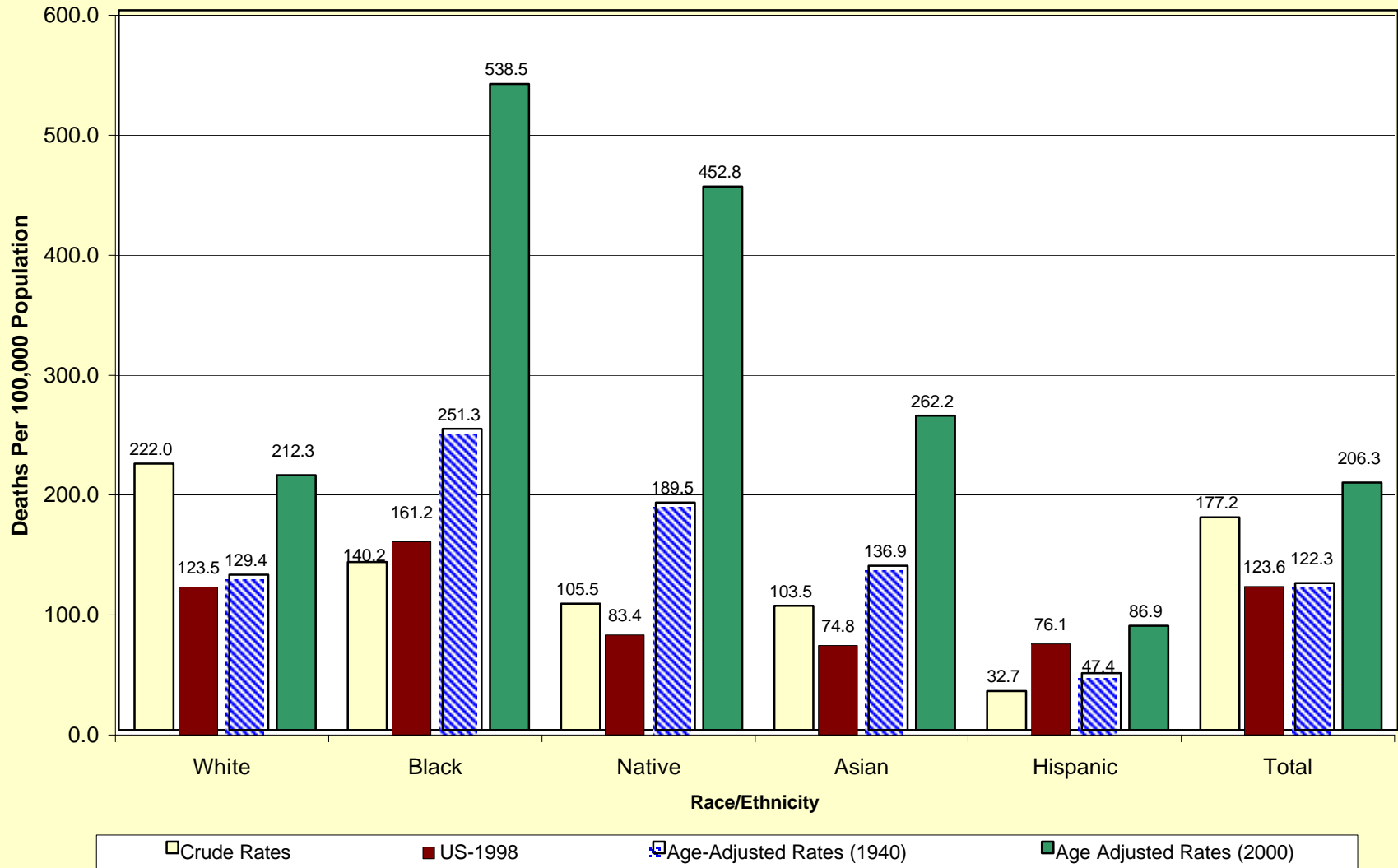

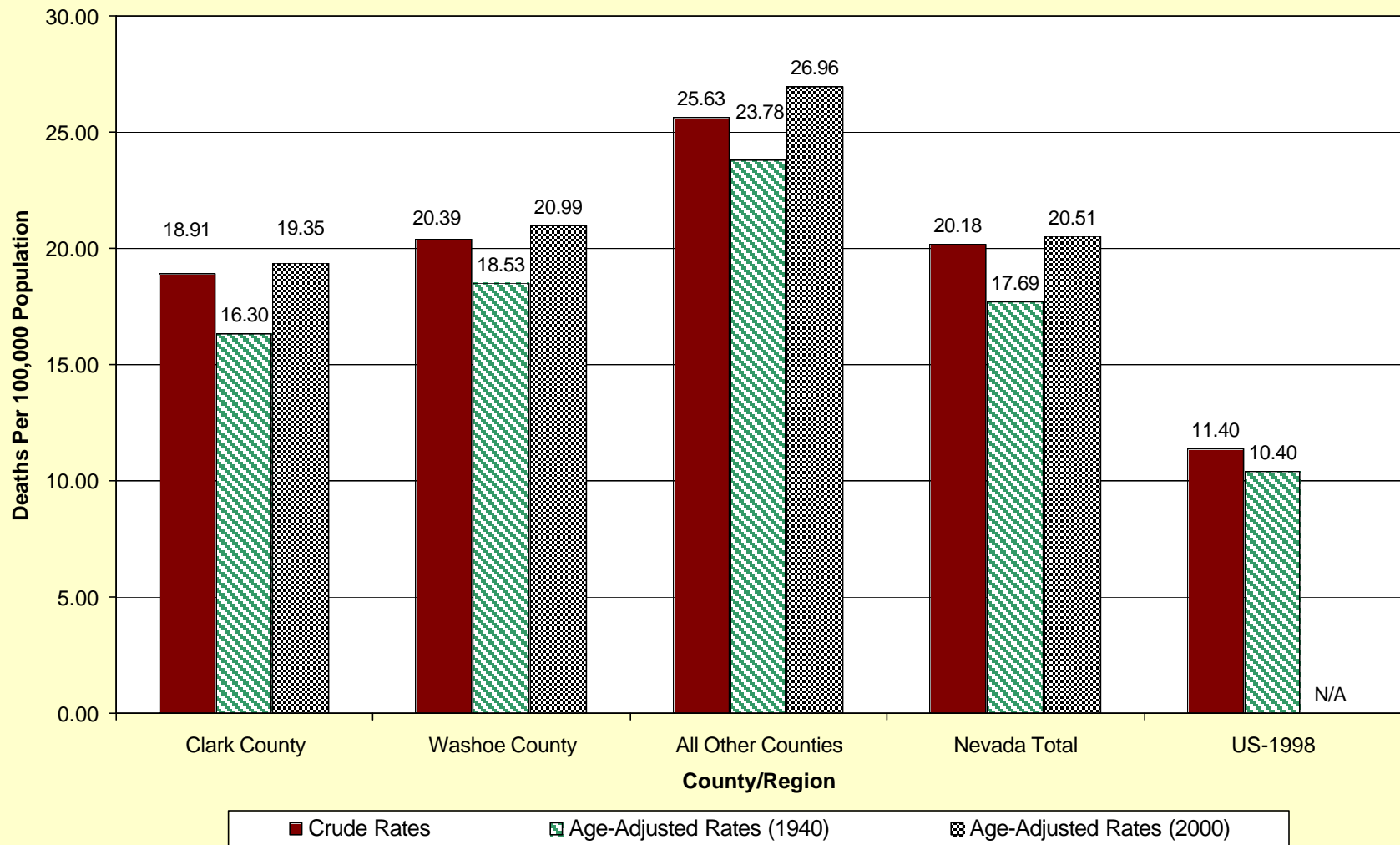

In 1999, Nevada's crude suicide death rate was almost twice the national average at 20.2/100,000 (NV99) vs 11.4/100,000 (US98). Nevada has continually ranked highest in the nation during the past 10 years. Regional, race/ethnicity, and age analysis showed the highest suicide death rates were among All Other Counties, Native Americans, and the age group 75-84 year olds.

In 1999, Nevada's crude death rate of motor vehicle crashes, 14.69 per 100,000, was slightly lower than the US average, 16.10 per 100,000 (1998). The highest groups were All Other Counties, two race/ethnicity groups: Asians and Native Americans, and two age groups: 75-84 and 15-24 year olds.

(Per 100,000 Race/Ethnic Specific Population)

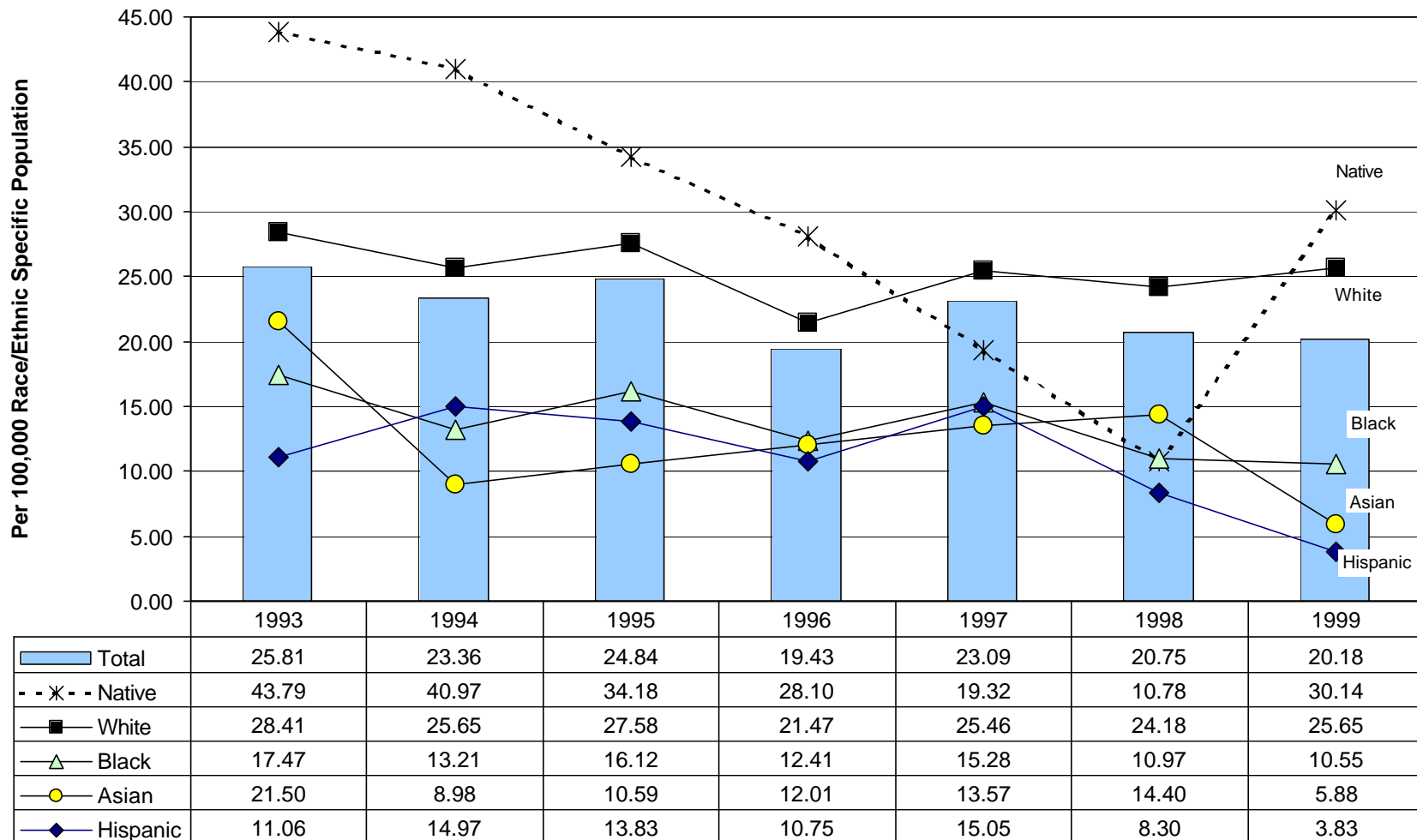
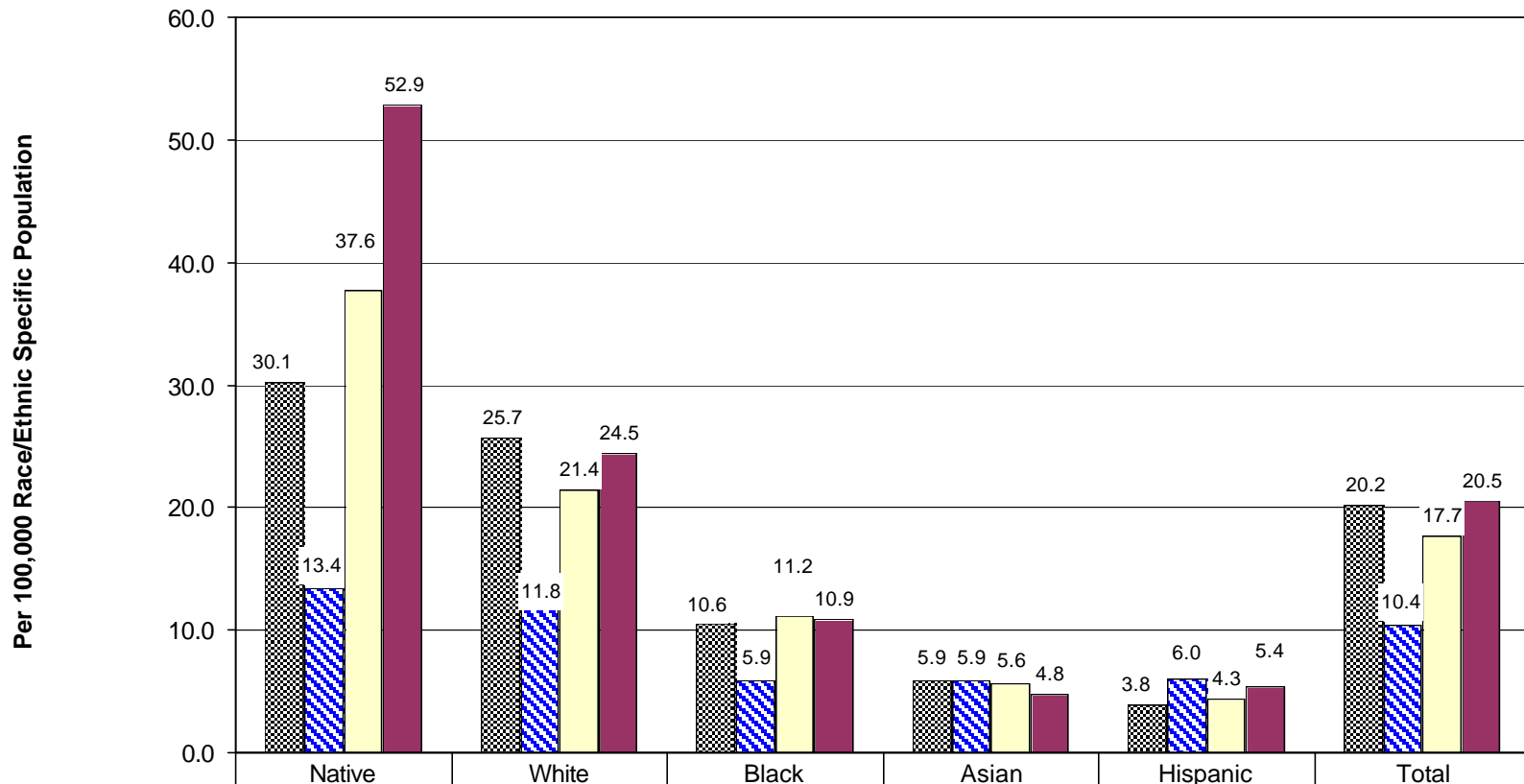


Figure 33. Comparisons between US (1998) and Nevada (1999) Suicide Mortality Rates by Race/Ethnicity

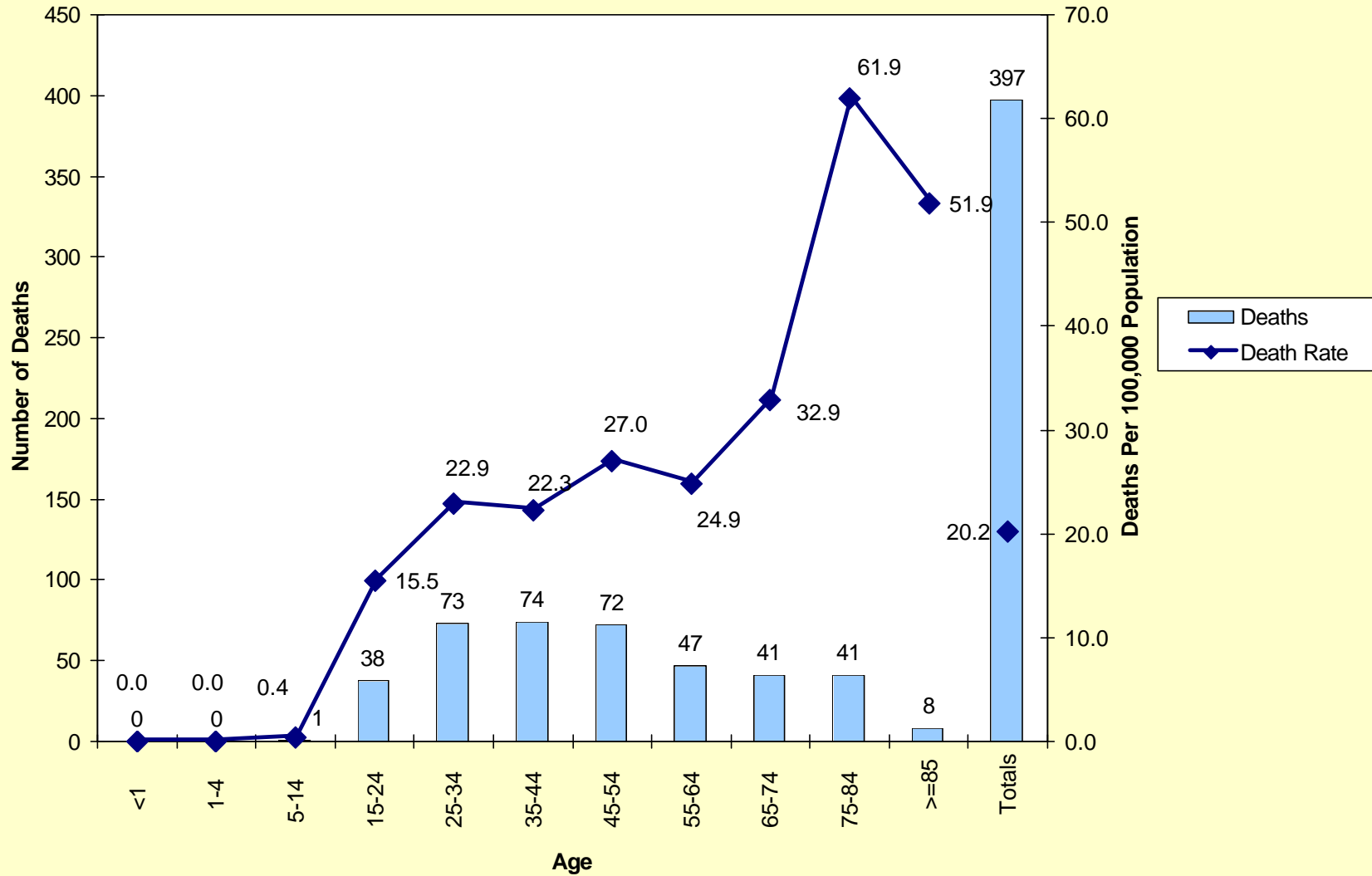
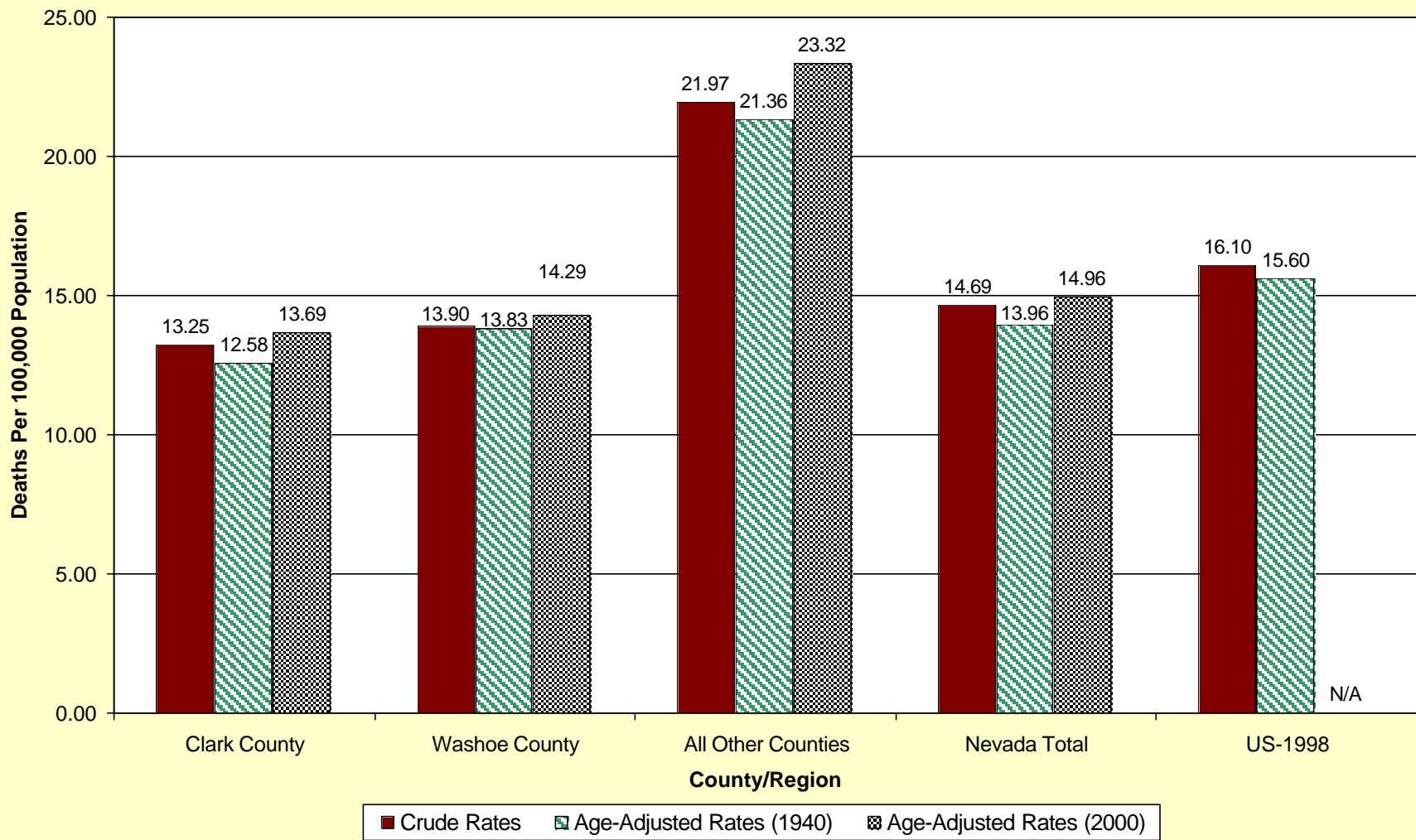
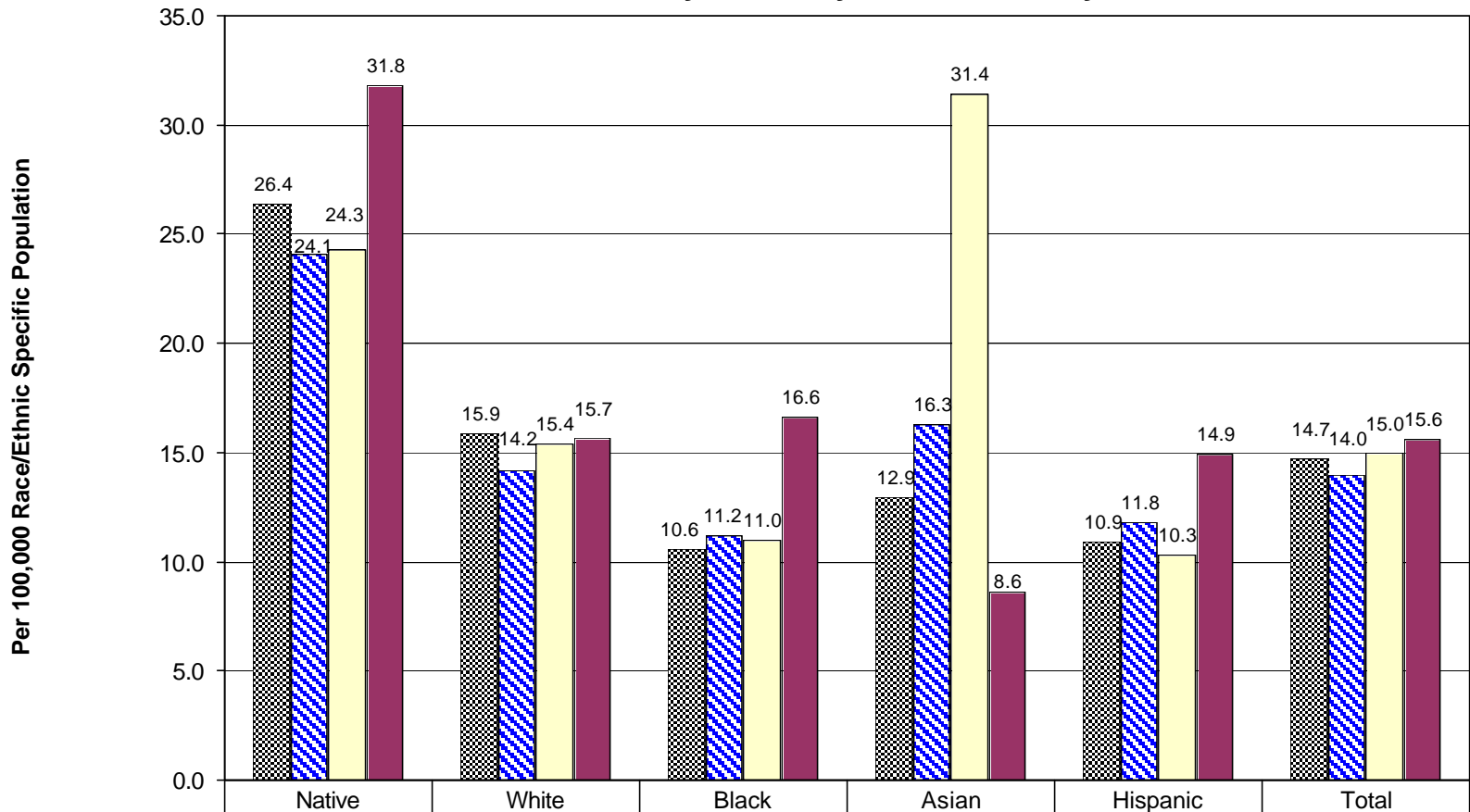


Figure 35. Death Rates for Motor Vehicle Crashes by County/Region of Residence, Nevada, 1999

Figure 37. Motor Vehicle Crash Deaths by Age, Nevada Residents, 1999

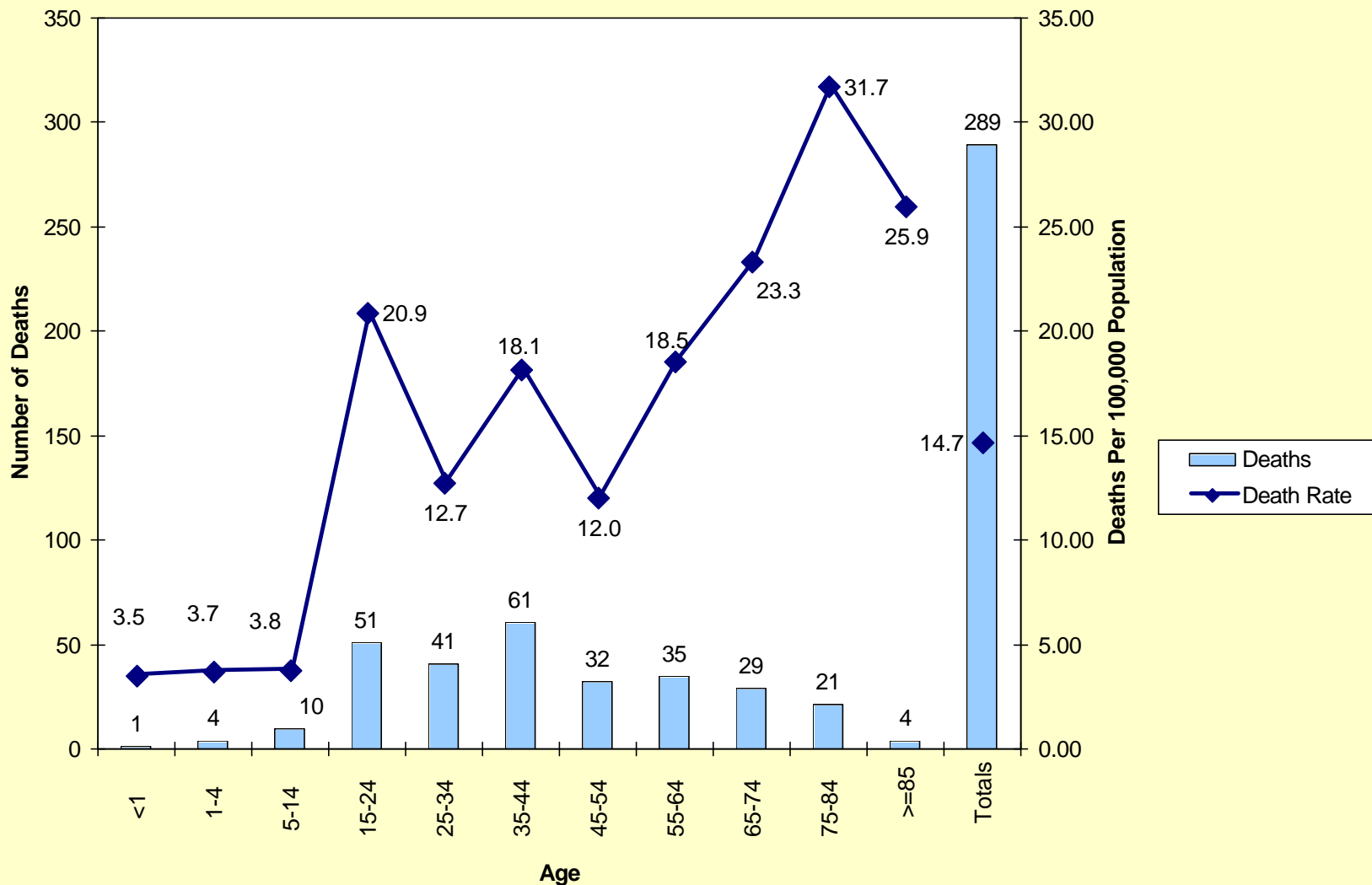
