THE NEVADA REGISTRATION SYSTEM

The Bureau of Health Planning and Statistics is the official government entity that collects, processes, analyzes, and maintains the State of Nevada's Vital Records. These responsibilities are delegated to the Office of Vital Records and the Center for Health Data and Research within the Bureau, of which each section's primary responsibilities, as related to the State's Vital Records, are as follows:

The Office of Vital Records has two distinct components:

- The Vital Records Section where records from local entities are filed and public requests for certified copies and amendments of said copies are processed.
- The Quality Control/Data Entry Section where the records are checked for completeness and accuracy and then entered into databases on the State mainframe computer system.

The Center for Health Data and Research analyzes, prepares and publishes reports based on statistics from the Vital Statistics databases and also provides technical assistance to users of these data.

Births in all counties are recorded electronically, directly with the State Registrar; except in Clark and Washoe Counties, where they are initially processed and then transmitted to the State Registrar. Responsibility for the filing of the **birth certificate** lies with the hospital medical records, nursing personnel, the physician, midwife, or other attendant.

The vital events of deaths, marriages and divorces are first recorded at the county level before being forwarded to the State Registrar. Funeral Directors, or persons acting as such, are legally charged with filing **death certificates** and **fetal death certificates**. County Recorders are responsible for forwarding the original **marriage certificates**, or computerized tapes containing marriage data, to the Office of Vital Records for maintenance of a data file. The County Clerk of each county is required to submit a **report of decree of divorce/annulment** to the Office of Vital Records within a month of the occurrence.

Abortions are reported directly to the Office of Vital Records for encoding and entering into the State's database. **Induced abortion reports** are completed and sent in directly to the Office of Vital Records by the physician, hospital or clinic.

All records are checked for completeness and accuracy, and then given a State file number before they are encoded and entered into the State's databases. Birth and death records are kept on permanent file for certification use and amendment when necessary by the public and various government agencies. Marriage, divorce, and abortion records are not maintained as separate records after entry into the State's database.

When a certificate is found to be inaccurate or incomplete, personnel follow up with the providing entity in accordance with NRS 440.150 to make the necessary corrections and/or improvements to make the record complete and satisfactory. It should be noted that the quality of data presented in this report is directly related to the completeness and accuracy of the information contained on the certificates.

This report summarizes data compiled from original birth, death, stillbirth and induced abortion, marriage and divorce records filed with the Office of Vital Records as discussed in NRS 440. Standard forms recommended by the National Center for Health Statistics are used for all records, with the exception of marriage and divorce.

DEFINITIONS

ABORTION:	The termination of a human pregnancy with an intention other than to produce a live birth or to remove a dead fetus. (NRS 442.240)
DEATH:	A person who has sustained irreversible cessation of all functioning of the brain, including the brain stem, is considered dead. (National Center for Health Statistics (NCHS))
DIVORCE:	Legal termination of a marriage. (NCHS)
FETAL DEATH:	A birth that occurs after at least 20 weeks gestation in which the child shows no evidence of life after complete birth. (NRS 440.070)
INFANT DEATH:	Deaths occurring to individuals of less than one year of age. (NCHS)
LIVE BIRTH:	A birth in which the child shows evidence of life after complete birth. A birth is complete when the child is entirely outside the mother, even if the cord is uncut and the placenta is still attached. Evidence of life includes heart action, breathing, or coordinated movement of voluntary muscles. (NRS 440.030)
LOW BIRTH WEIGHT:	A birth wherein the birth weight is less than 2,500 grams (5 lbs 8 oz). (NCHS)
MARRIAGE:	A formal mutual relation of husband and wife that is filed with the County Recorder in the county where the license was issued. (NCHS)
NEONATAL DEATH:	Death occurring to infants in the first 27 days of life. (NCHS)

OCCURRENCE

(COUNTY OF): Data allocated by the location of where the event actually occurred. (NCHS)

PERINATAL DEATH: Death occurring to a fetus of 20 weeks gestation or more, including infant deaths occurring within 27 days of life. (NCHS)

PRENATAL CARE: The care received by the mother from a health professional or midwife during the length of the pregnancy. (NCHS)

**POST-NEONATAL
DEATH:**

Death occurring to infants less than one year of age, but older than 27 days. (NCHS)

**RESIDENCE
(COUNTY OF):** The usual residence of the individual. For deaths, this is defined as the usual residence of decedent as indicated on the certificate. For births and fetal deaths, the residence is defined as the usual place of residence of the mother. (NCHS)

S.I.D.S.: Death due to Sudden Infant Death Syndrome. (NCHS)

TEEN PREGNANCY: The number of live births, abortions and fetal deaths to women 19 years old and younger. (NCHS)

UNDERLYING CAUSE

OF DEATH: The disease or condition which gave rise to the chain of morbid events leading to death, including the circumstances of an accident or violent event that produced a fatal injury. (NCHS)

VERY LOW

BIRTH WEIGHT: A birth wherein the birth weight is less than 1,500 grams (3 lbs 4 oz). (NCHS)

TECHNICAL NOTES

POPULATION DATA:

The Nevada population data used in this report are based on the database established by the Nevada State Demographer's Office and the Nevada Department of Taxation, as well as 2000 Census data from the US Bureau of the Census. Due to these changes in methodology, rates for subgroups published in this edition may not match or be directly comparable to past years, and should be used with caution when compared to other published rates. Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

MARRIAGE AND DIVORCE DATA:

Marriage and Divorce data for the year 2001 were not available for this report due to incomplete reporting. Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

ABORTION DATA:

This report contains a special section on year 2000 abortion data, which were not available for the 2000 edition of the Nevada Vital Statistics Report. Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

RACE AND ETHNICITY:

In conjunction with the US Bureau of the Census and the National Center for Health Statistics definition, Hispanics are an ethnic group, not a race, and may include all races within their ethnic classification. In this report, Asian-Pacific Islander, Black, Native-American, and White exclude Hispanics; therefore, no duplicate counting exists. However, when National data are used for comparison, methodologies may differ by including Hispanic and Non-Hispanic populations within separate racial groups, as well as including different racial groups within the Hispanic ethnic group. Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

COUNTY COMPARISONS:

The population size of the counties in Nevada is widely varied, from one thousand to over one million. Because of these differences, caution should be used when interpreting rate comparisons for counties in Nevada. Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

REGIONAL COMPARISONS:

Approximately eighty-seven percent (87%) of Nevada's population resides in the urban areas of Clark (Greater Las Vegas area) and Washoe (Greater Reno/Sparks area) counties. In this report, data are frequently stratified into three regions within the state as follows: Clark County, Washoe County, and All Other Counties (all remaining 15 counties). Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

AGE ADJUSTMENT METHODS AND STATISTICAL ANALYSIS OF MORTALITY RATES:

In order to make meaningful comparisons between mortality rates for residents from different regions or different racial/ethnic groups, differences in the age characteristics of each population should be taken into account. For example, one would expect that the mortality rate for heart disease would be high in a population that has a high proportion of older individuals. Table cells with counts less than 5 have been suppressed to protect individual privacy and confidentiality. Further, rates for groups with less than 5 observations were not calculated.

Age-adjustment is the application of the age-specific rates in a population of interest to a standardized age distribution. This method is used to eliminate the differences in observed rates that result from age differences in the populations being compared. This adjustment is usually done when comparing two or more populations at one point in time or one population at two or more points in time.

In this report, the death rates are age-adjusted to the 2000 US Standard distribution population (relative age distribution of the 2000 enumerated population of the United States totaling 1,000,000). This method produces the rate that would be expected if the population of interest had the same population age distribution as the standard population.


Adjusted rates were calculated in the following manner:

- The expected number of deaths in each age group was determined by multiplying the age-specific rates (N_i/P_i) by the corresponding age-specific standard population total (S_i).
- Age adjusted rates (AAR) per 100,000 population were calculated by dividing the expected total number of deaths (E_i) by the total standard population and multiplying by 100,000.

Nevada continues to see an increase in the total number of births and divorces that occurred in 2004. However, Nevada's Birth Rate (per 1,000 population) decreased slightly (0.34%) from 14.67 in 2003 to 14.62 in 2004. Nevada's Crude Death Rate (per 100,000 population) dropped from 771.2 in 2003 to 734.3 in 2004, a 4.8% decrease. Once age-adjusted comparisons were made, the Mortality Rate (per 100,000 – 2000 US Standard population) for Nevada decreased 5.6% from 2003 (912.5) to 2004 (861.4). The Divorce Rate (per 1,000 population) did experience a decline from 2003 (7.2) to 2004 (7.1). Nevada still remains among the highest in the nation for Divorce Rates. This standing may reflect Nevada's relatively lenient state laws, combined with the state's small population base, resulting in disproportionately high rates.



In 2004, Nevada was again the fastest growing state in the nation for the 19th consecutive year (US Census Bureau News). In 2003, Nevada's population was estimated at 2,290,855. The population grew to 2,404,191 in 2004. The state's population is projected to surpass 3,609,486 by 2024. Clark and Washoe Counties accounted for more than 87% of the state's residents in 2004.

The three age groups with the largest populations were 35-44, 25-34 and 15-24 in 2004. The population was almost evenly split between males and females; however, there was a slight increase in the female population over the age of 79.

The White Non-Hispanic population continues to be the majority in Nevada with 63.7% in 2003 and 62.8% in 2004. The Hispanic population continued to grow from 22.0% in 2003 to 22.7% in 2004. The Asian Non-Hispanic population grew steadily from 6.0% (2003) to 6.2% (2004). Black Non-Hispanic remained constant at 6.9% between 2003 to 2004. Native America Non-Hispanic slightly decreased from 1.4% in 2003 to 1.3% in 2004, respectively.


Figure 3. Population Pyramid in Nevada, 2004


Figure 4. Population Growth by County of Residence in Nevada, 1994-2014

In 2004, 147,825 marriages were recorded in Nevada. For those brides and grooms who reported their residency, most came from California (52% Brides and 52% Grooms), Nevada (19% Brides and 19% Grooms) and International Countries (16% Brides and 17% Grooms), followed by the States bordering Nevada: Oregon, Washington, and Idaho. Interestingly, more than 99% of marriages occurred in one of the three largest tourism based counties in Nevada during 2004, Clark (84%), Washoe (12%), and Douglas (3%).

Divorces are granted to Nevada residents who have resided in the state at least 6 weeks. There were 17,126 divorces filed in 2004 and the divorce rate was 7.1 (per 1,000 population). The national average for 2004 was 3.7, (US Provisional Data). Historically, Nevada's divorce rates have consistently been the highest in the nation, which may reflect relatively lenient state laws, combined with Nevada's small population base, resulting in disproportionately high rates. Nye County had the highest divorce rate in both 2003 and 2004 (15.5).







Nevada, 2004**





Figure 7. Divorce Rates (Per 1,000 Population) for Nevada and the US, Selected Years 1995-2004



Nevada continues to see a steady increase in the number of births in the state. However, the birth rate continues to decrease because the population is increasing faster than the number of births. In 2004, there were a total of 35,541 live births in Nevada. Of those, 35,146 were to mothers who were Nevada residents. Nevada's birth rate went from 14.91 (per 1,000 population) in 1999 to 14.62 (per 1,000 population) in 2004.

In 2004, 73.5% of the total births in Nevada were to Clark County Residents. Washoe County Residents accounted for 15.5% of all births and All Other Counties, as a whole, had 9.9%. Clark County had the highest crude birth rate at 15.2, followed by Washoe County with 14.3 and Lincoln County 14.0.





Nevada, 1994-2004**







Figure 12. Crude Birth Rate by County of Residence, Nevada Residents, 2004

In 2004, the overall rate of prenatal care in the first trimester was 74.4%. Among all racial/ethnic groups, Whites had the highest prenatal care rate, followed by Asians, Blacks, Native Americans and Hispanics, respectively.

The incidence of low birth weight babies in Nevada was 8.0% in 2004. Among Blacks, 13.8% of all births weighed less than 2,500 grams. This racial group continued to have the highest rate of low birth weight births in Nevada.

Nevada's teen birth rate continued, to follow the decreasing trend of the past 10 years for all teen age groups. The birth rate for females ages 15-19 in 2004 was 46.6 per 1,000 female age-specific population.



Nevada Residents, 2004**






Figure 17. Percentage of Mothers Receiving Prenatal Care in the First Trimester by Race/Ethnicity, Nevada Residents, 2004





Nevada Residents, 2004**





Nevada Residents, 2004**







Figure 22. Teen Pregnancy (10-14 yrs) Rates by County/Region of Residence, Nevada Residents, 1999-2004




**Figure 23. Teen Pregnancy (15-17 yrs) Rates by County/Region of Residence,

Nevada Residents, 1999-2004**




**Figure 25. Teen Pregnancy (15-19 yrs) Rates by County/Region of Residence,


**Figure 26. Teen Pregnancy (10-14 yrs) Rates by Race/Ethnicity,


**Figure 27. Teen Pregnancy (15-17 yrs) Rates by Rate/Ethnicity,


**Figure 28. Teen Pregnancy (18-19 yrs) Rates by Race/Ethnicity,


The induced abortion rate spiked to 298.1 (per 1,000 live births) in 2001 from 265.4 (per 1,000 live births) in 2000. Rates have declined slightly from the 2001 level in the last three years. During 2004, the rate was 260.2 (per 1,000 live births). During 2004, the highest percentage of induced abortions occurred in the 20-24 year old age group. In 2004, Washoe County residents had the highest rate at 304.5 (per 1,000 live births).

There were a total of 44,539 reported pregnancies (live births, fetal deaths, and induced abortions) among Nevada Residents during 2004. Of that, 78.9% were live births, 20.5% were induced abortions and 0.6% were fetal deaths.



Nevada Residents, 1999-2004**




**Figure 31. Percentage of All Induced Abortions by Age Groups of Women,




In the last seven years, Nevada's infant mortality rate has declined from a peak of 6.93 (per 1,000 live births) in 1998 to a low of 5.62 (per 1,000 live births) in 2003. That rate rose slightly to 6.23 (per 1,000 live births) in 2004. Blacks continue to have the highest rate of infant mortality in Nevada with a rate of 18.8 (per 1,000 live births) in 2004.


The number of resident deaths has remained steady with 17,666 in 2003 and 17,655 in 2004. Age-adjusted death rates in the state were 861.4 (per 100,000 – 2000 US Standard population) in 2004. People ages 65 and older represented 67.4% of all Nevada resident deaths in 2004.

Diseases of the Heart and Malignant Neoplasms (i.e. Cancers) ranked as the first and second leading causes of death in Nevada for 2004. These two diseases were responsible for 8,680 deaths or 49.2% of total deaths in the state. Trachea, Bronchus and Lung Cancer, as a group, continued to be the leading cause of cancer deaths for 2004 with age-adjusted death rates (per 100,000 – 2000 US Standard population) of 55.1.


After age-adjustment, racial/ethnic group comparisons indicate that Blacks had the highest death rate for Diseases of the Heart and Cancer in 2004.

Nevada Residents, 1997-2004**




**Figure 35. Infant Mortality Rates,
Nevada Residents, 1997-2004**



Nevada Residents, 1992-2004**




**Figure 37. Mortality Rates by County/Region of Residence,

Nevada Residents, 2004**






Figure 40. Death Rates for Diseases of the Heart by County/Region of Residence, Nevada Residents, 2004; US 2004






**Figure 41. Death Rates for Diseases of the Heart by Race/Ethnicity,
Nevada Residents, 2004; US 2004**




**Figure 42. Death Rates for Cancer by County/Region of Residence,



Nevada's age-adjusted (2000 US Standard population) Suicide death rate continued to be almost twice the national average in 2004. The age-adjusted rates for Nevada residents were 18.2 (per 100,000 – 2000 US Standard population) in 2004; compared to the national age-adjusted rates of 10.9 in 2004. Nevada is ranked 3rd in 2003, based on age-adjusted rates (National Vital Statistics Reports: Deaths: Final Data for, 2003). The highest suicide death rates in Nevada were among residents of “All Other Counties.” Whites experienced an unusually high age-adjusted rate of 21.8. The crude suicide rate for the 85 and older age group experienced a drop in 2004; falling to 54.4 from 83.7 in 2003.

In 2004, the age-adjusted death rate for motor vehicle crashes among Nevada Residents was 16.2 (per 100,000 – 2000 US Standard population). This was slightly higher than the national average of 15.3. The two groups with the highest rates of motor vehicle accidents were residents of “All Other Counties” and Native Americans. The age group with the highest motor vehicle death rate was 75-84 years old.

Males continued to have far higher rates than females in both suicide and motor vehicle crash deaths during 2004.

Figure 46. Death Rates (Per 100,000) for Suicide by County/Region of Residence, Nevada Residents, 2004; US 2004






Figure 47. Crude Suicide Mortality Rates (Per 100,000) by Race/Ethnicity, Nevada Residents, 1995-2004

Nevada Residents, 2004**







Figure 50. Mortality Rates for Motor Vehicle Crashes by County/Region of Residence, Nevada Residents, 2004; US 2004
