Gerald Ackerman asks if we are in a new J-1 cycle. Tarryn Emmerich-Choi states that we are still in the 2024 cycle, and that we have 23 J-1 doctors, the most the Nevada PCO has had, and they are in the process of accepting a new one. She goes to state that there are 7, almost 6 slots left for the year, and the cycle ends in September. Nancy Bowen states that that is great news. Gerald Ackerman commends the PCO staff. Nancy Bowen mentions that she likes the selection of applications that have been coming in. Gerald Ackerman states that it is great that we have accepting a Family Medicine physician as they are unique to the USA and Canada. Dr. VanBeuge mentions that each application represents a tremendous amount of work and Nevada has gained a variety and breadth and depth of people and different specialties. She continues to say that it is great to have people who have trained within Nevada, staying here to work. Dr. VanBeuge asks if the PCO is going to be able to fill all 30 slots this year, and how it has not previously been done before. Tarryn Emmerich-Choi says that they are hopeful.
