10 Core CCBHC Services

- Crisis Behavioral Services
- Screening, Assessment, and Diagnosis
- Person Centered and Family-Centered Treatment Planning
- Outpatient Mental Health and Substance Use Services (medication management, children, adolescent and adults) (not residential)
- Outpatient Clinic Primary Care Screening and Monitoring
- Targeted Case Management Services
- Psychiatric Rehabilitation Services
- Peer Support, Peer Counseling and Family/Caregiver Supports
- Intensive, Community-Based Mental Health Care for Members of the Armed Forces and Veterans
- Assertive Community Treatment Teams



- Staffing Plans in compliance with Medicaid policies and various board of examiners
- Care Coordination
- Ongoing Needs Assessment
- Continuous Quality Improvement
- Board Governance
- Training Plan

- Request for additional budget authority for CCBHCs under the Medicaid Plan to the Legislature 2023
 - o If approved a procurement process will be utilized to determine what CCBHCs not currently included under the PT 17-188 would be added.
