Following up to the SAPTA Board Meeting held on 4/24/24, New Life USA-Nevada, Substance Abuse Recovery program would like to introduce ourselves with the hopes of future collaboration.

NEW LIFE USA – is a non-profit corporation, 501(c)(3) that carries out a free of charge, long term, residential, substance abuse recovery program. New Life was founded in 1995, and over the last 30 years over 5000 people have successfully completed the program and live a sober, fulfilled life. New Life USA is a faith-based ministry, non-denominational, welcoming anyone regardless of race, color, religion, national origin, ancestry, age, gender, physical or mental disability, sexual orientation, gender identity or HIV status.

New Life offers a recovery program based on BIO-PSYCHO-SOCIO-SPIRITUAL components. By New Life Definition, addiction is the Bio-Psycho-Socio-Spiritual problem, and during the 20 months long-term recovery program our staff team works with program participants through these four components. The New Life belief is that a short-term program brings a brief result, whereas a long-term program brings predominantly life-long results.

The Program is based on the absolute voluntary desire, during which a program participant gets rid of chemical addiction. This includes physical restoration, bad habits changes, emotional and moral recovery, relationships recovery, healthy lifestyle, obtaining the basic life and trade skills, building communication and leadership skills. 3. Social status restoration;
4. Complex training for the future employment;
5. Address health issues, prior to arrival medical and physical exam test results, as well as during the program.
