



## **Nevada Ryan White Parts ABCD Common Guidance Document Eligibility & Enrollment 2017 Federal Poverty Guidelines**

### **Scope of Coverage**

Directly applicable to all consumers, clients, or members of the Ryan White HIV/AIDS Programs in Nevada; all potential consumers, clients, or members; and all Eligibility & Enrollment Specialists for the Ryan White HIV/AIDS Programs in Nevada. Indirectly related to all other Ryan White service providers.

### **Purpose of Policy & Background**

The Ryan White HIV/AIDS Program required the primary recipient of federal funds to define the threshold of low-income for service eligibility. The Ryan White HIV/AIDS Programs in Nevada has defined low-income to be 400% of the Federal Poverty Level. Each year, the Federal Government released the new calculations of the Federal Poverty Level. In 2017, the United States Department of Health and Human Services published in the Federal Register the new calculations (82 FR 8831). These calculations are for Calendar Year 2017.

### **Implementation**

The Nevada Ryan White HIV/AIDS Program has adopted the 2017 Federal Poverty Levels guidelines. Some State programs including Welfare delay adoption until April 1. Clients close to 138% of the FPL should still be directed to Welfare to apply for eligibility determination. Please ensure that whenever there is a change in health insurance or medical benefits that it is communicated back to the ADAP Provider.

CAREWare has not yet been updated to the new 2017 Federal Poverty Levels. Please ensure that the client is under the dollar amount limit in CAREWare rather than the percentage listed in CAREWare.
