Items to consider would be anything tied to COVID, specific outreach, awareness initiatives or data support. There is strategic prevalence needed since COVID has caused more online gambling and with our prevalence study can foresee a nexus. There are some important points to make and Mr. Hartwell and Chair Goodman will put something together that can be put in front of the



Governor for a one-pager and go from there.
