

State Board of Health Public Comment

I would just like to point out that, all of the vaccines are under the EUA, including the FDA approved Pfizer vaccine. That means that the pharmaceutical companies that make the vaccines cannot be sued in case of bodily harm or death from the vaccine because it is up to the individual to decide whether or not to take the vaccine(s). Voluntary injection of a vaccine does not allow for litigation due to adverse effects of it. Any person, organization or department that mandates the EUA vaccine is legally assuming liability for any bodily harm or death caused by a negative reaction to the emergency use vaccine(s). I need not point out the financial hardship that such litigation would put on the State of Nevada if an employee died from a reaction to a mandated vaccine. It would be much more damaging than having a few employees getting sick. Let me also point out that, when you threaten an employee's livelihood for not taking the vaccine that is called "duress" which is illegal in every state.

The state's Chief Medical Officer, Ishan Azzam, does not even have a license to practice medicine in this country and should be exempt from all medical opinions on these matters.


