Dear Mr. Filippi:

I understand that Faculty Alliance is seeking to FORCE university, community college and state college students to take a jab of an experimental drug. Aren't the Faculty the grown-ups here? If anyone in the Faculty, or indeed students, are health impaired with pre-existing conditions or immune deficient, they have the RIGHT to take the jab. No one is stopping anyone from taking the vaccine if they want one? Since July, the fully vaccinated people in Carson City has gone from 52% to 58% and that increase was achieved without a mandate.

Science tells us that the vaccine is not immunity. It cannot prove immunity. The vaccine reduces the severity of the disease and IS NOT in the same class of other proven vaccines used for immunization practices over the years. How many years did we have the flu vaccines? Is it mandated? Has it stopped deaths due to the flu each year? In fact, Science tells us that the vaccine reduces the immune response in our bodies with a 20X increase in certain cancers over the last 20 months.

The so called Covid vaccines are authorized for emergency use only by the FDA. Do you have any updates from the FDA? No. The FDA has no good news on the use of mRNA drugs (Pfizer and Moderna) after one year of experimentation on human subjects? You are the lab rat for this human experimentation without full disclosure of health risks by any health agencies.

Dr. Fauci says that booster shots will be needed for people who take the vaccine – within 8 months. This is a risk versus benefit analysis for each individual. Each individual owns their health analysis. It is Your body, Your choice. The Faculty does not have the right to force decisions on their students. Isn't the Faculty teaching our students to be free and rational thinkers? How does this mandate fit that teaching philosophy? It does not.

Does the Faculty know about the Nuremberg Code which established research ethics for human experimentation at the end of the second World War during the Nuremberg trials? They should. No human experimentation without consent which means no vaccination mandates.

Who has disclosed that there have been over 6,000 deaths after taking this emergency vaccine? Who disclosed that perfectly healthy people had inflammation of the heart and blood clots in their limbs or died. I personally know two people in Carson City whose future is quite uncertain after taking the vaccine. All vaccines have warning labels now but who is talking about this? This Board cannot and should not require people to take a jab of this unproven vaccine. It should be voluntary as it is now.

Will the academic institutions or this Health Board take responsibility for adverse medical effects after everyone takes this mandated jab? Insurance companies can, and will refuse treatment to adverse conditions. Is the Health Board willing to be the subject of multiple medical class action suits or wrongful death suits?

I request this Board to reject mandated vaccines unanimously. Our intellectuals should not follow blindly and emotionally after unreason. People have the right to make their own decisions and so should the faculty and students who want to take the vaccine. No tyranny of vaccination mandates or passports.
