

Hello. I am Jessica Flack. I am a concerned parent and citizen. I am in opposition of mandating vaccines for anyone or anything. Therefore, I am in opposition of having to show any proof of such. Mandating a medical product is anti-freedom, anti-american, and unconstitutional. The vaccinated are getting the delta strain 7 times more than those who are naturally immune. This will always be around. The vaccine won't solve anything. Natural immunity will. This has been shown throughout history with many viruses, it's immunology 101. Experts are shouting for natural immunity and we are ignoring it!
