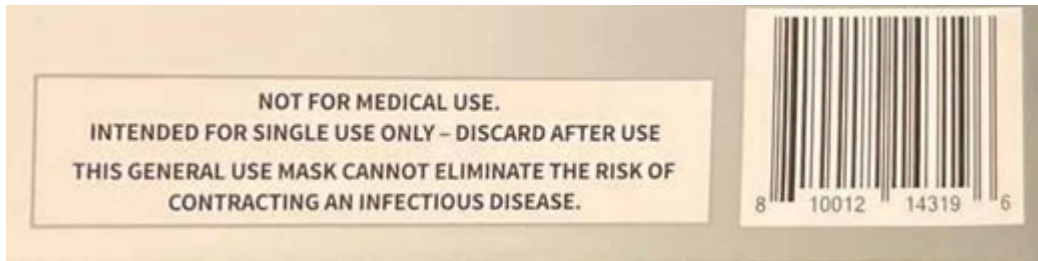



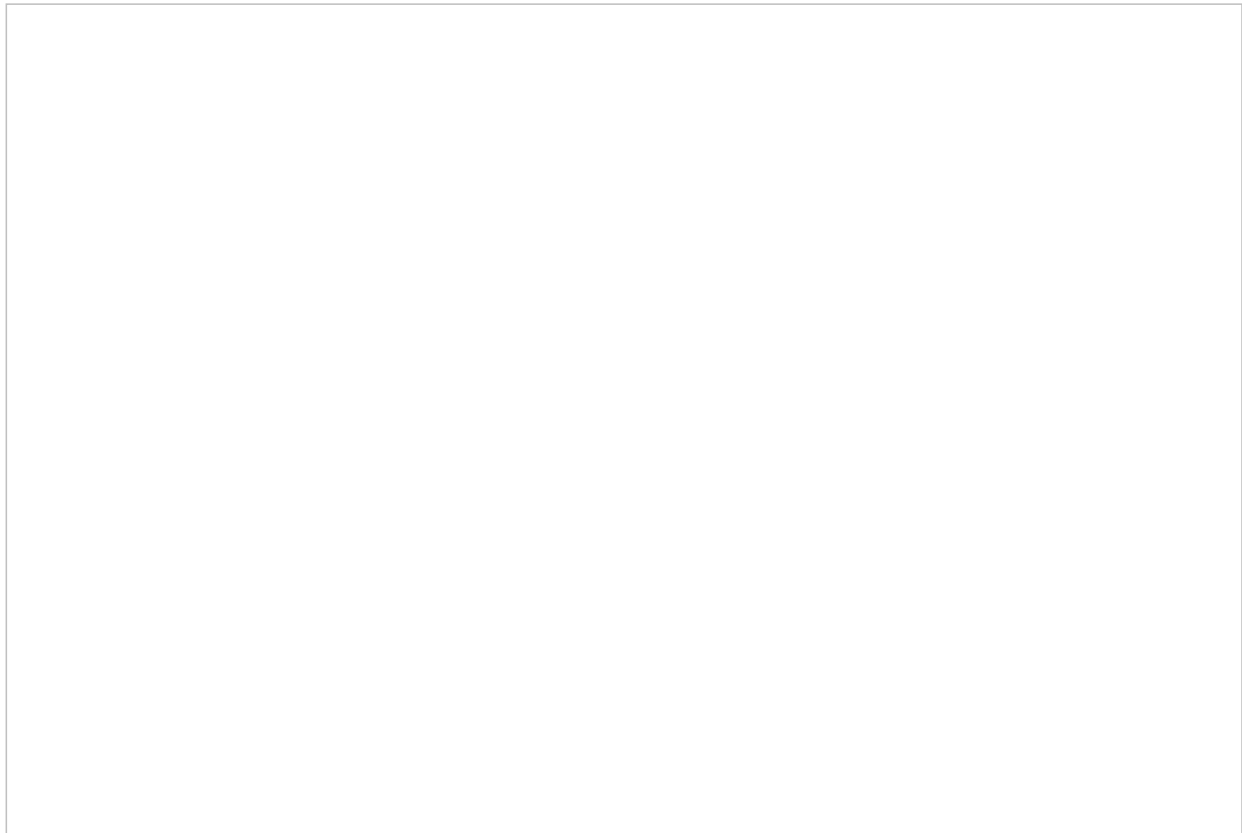

Thank you for reading my comment, I appreciate you for listening to us parents on how we feel. I love the public school my children attend hear in NV, Carson City to be exact. I watched the a lot of the CDCs vaccine advisory hearing as it pertained to weather or not to open up covid vaccines to 5 to 12 yr olds, I'll link it below, and most of the time they were saying the studies are inconclusive and they will be watching very closely to see how this age group reacts but they must release it for the sake of the few that have underlying conditions or are around the elderly. Staff who conducted quality control checks were overwhelmed by the volume of problems they were finding.
