



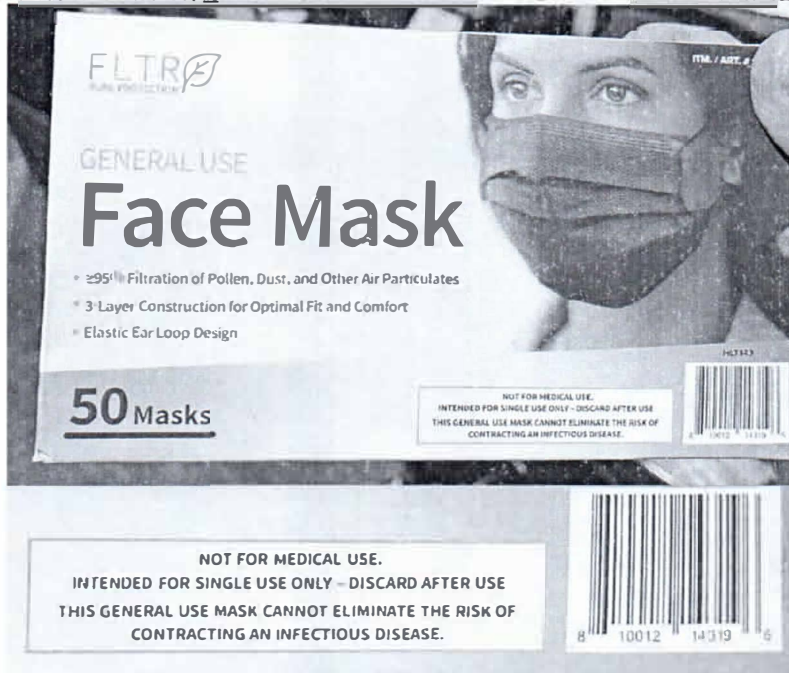

Sec. 8A. Rights of victims. 1. Each person who is the victim of a crime is entitled to the following rights:

A person may maintain an action to compel a public officer or employee to carry out any duty required by this section or any statute enacted by the Legislature pursuant thereto.
