A need exists in the State of Nevada for Certified Nursing Assistants and students enrolled in an accredited school of professional nursing or a graduate of such a school pending the results of the first licensing examination scheduled by the State Board of Nursing following graduation to be able to perform only glucose testing that has been categorized by the Federal Drug Administration (FDA) as a Waived laboratory test. To address this need, Sunrise Hospital & Medical Center-POC Testing Lab, will be permitted to have a Certified Nursing Assistant or a student enrolled in an accredited school of professional nursing or a graduate of such a school pending the results of the first licensing examination scheduled by the State Board of Nursing following graduation licensed in the State of Nevada, be qualified to apply for and obtain a Point-of-Care analyst license and perform Waived glucose testing in their healthcare facility.
