NOTICE OF OPPOSITION TO PETITION
FOR POSSIBLE DISCIPLINARY ACTION**

WE the undersigned citizens of the state of Nevada oppose the Initiative *Petition for Safe NSHE Campuses* which was filed by The Nevada Faculty Alliance. Our opposition is based upon and supported by the NSHE CODE and referenced Nevada statutes below; the ~~declarations~~ and demands made by the *Petition for Safe NSHE Campuses* has no standing.

TITLE 2 - Nevada System of Higher Education CODE CHAPTER 12 STATES

"Limited Purpose and Scope This Chapter is an emergency and temporary amendment to the CodeC that is limited to the issue of employee COVID-19 vaccinations. Its purpose is to ensure that allC employees within the Nevada System of Higher Education are fully vaccinated against the COVID-19C virus by December 1, 2021. No provision in this Chapter shall be used, cited, or relied upon to amend orC impact any other policy, procedure, promise, right, or agreement that is outside of its express purpose andC scope. "

MOVE TO REPEAL THE CODE

We ~~oppose~~ the initiative for the following reasons:

"Today, the Nevada State Board of Health voted to require COVID-19 vaccinations for all Nevada college students who wish to register for Spring 2022 classes, with a few, limited exceptions." (August 20, 2021, Federico Zaragoza, President of CSN)

This statement indicates to us, the undersigned, that the System's faculty is aware that the protected class of medically vulnerable individuals who can not receive the COVID vaccine, will be limited in exception availability.

There is an absolute misrepresentation of the approval of the Comirnaty COVID-19 Vaccine, by Pfizer-BioNTech COVID-19 Vaccine, which has been approved by the FDA ONLY as follows:

1) Under this license, you are approved to manufacture COVID-19 Vaccine. (MANUFACTURING LOCATIONS)

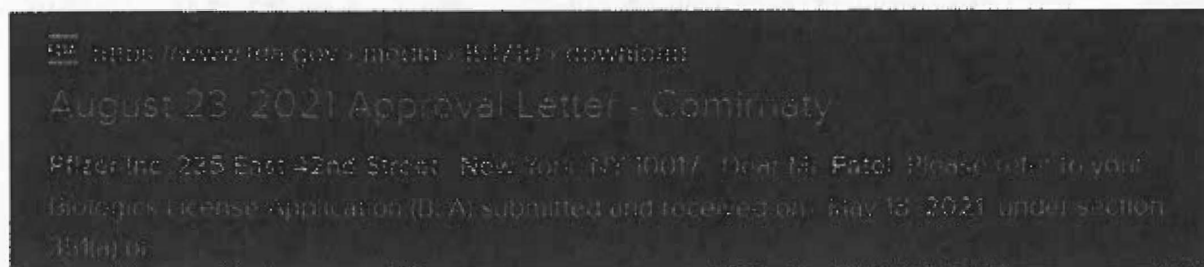
2) We have approved the stability protocols in your license application for the purpose of extending the expiration dating period of your drug substance and drug product... (DATING PERIOD)

3) We hereby approve the draft content of labeling including Package Insert, submitted under amendment 74, dated August 21, 2021, and the draft carton and container labels submitted under amendment 63, dated August 19, 2021. (LABELING)

4) We have determined that an analysis of spontaneous postmarketing adverse events reported under section 505(k)(1) of the FDCA will not be sufficient to assess known serious risks of myocarditis and pericarditis and identify an unexpected serious risk of subclinical myocarditis. Furthermore, the pharmacovigilance system that the FDA is required to maintain under section 505(k)(3) of the FDCA is not sufficient to assess these serious risks. (POSTMARKETING REQUIREMENTS)

Expectations

Impartial judgment can not occur on educational campuses, this is included but not limited to discrimination of age, race, gender, or private health information; that which is not the liability of NSHE. There are no mechanisms put into place to account for adverse or allergic reactions; nor a form of financial obligation on the institution that is which is forcing oxygen restriction. In order to teach and learn in a healthy environment, our teachers and students need to breathe freely, and not be subject to health discrimination.

We demand, through petition or other legal routes, that a vote to **REJECT** the recommendations of the Board of Health until there is evidence provided asserting the following:

(ADA 29 C.F.R. §1630.14(c)(1))

a complete list of my certain and absolute risks in taking the vaccine; and/or

any certain and absolute benefits that the vaccine is guaranteed to provide me;

whether or not my institution has classified my immune system as naturally deficient in providing defense against COVID-19 (any variant); and/or

If my institution has classified my immune system as naturally deficient in providing defense against COVID-19, I have not received any certified information on how my institution decided that my immune system was naturally deficient in this way; and/or

whether or not my institution has an insurable risk in providing me health insurance coverage, and if so, whether that insurable risk covers any injuries or harms I may receive from the vaccine; and/or

If I have had COVID-19, my institution has not provided me with any information that details how the vaccine will affect, either negatively or positively, my naturally developed immune response; and/or

If I am injured by the vaccine, whether or not my institution assumes any liability or provides any insurance coverage for any and all injuries I may sustain by receiving the vaccine.
