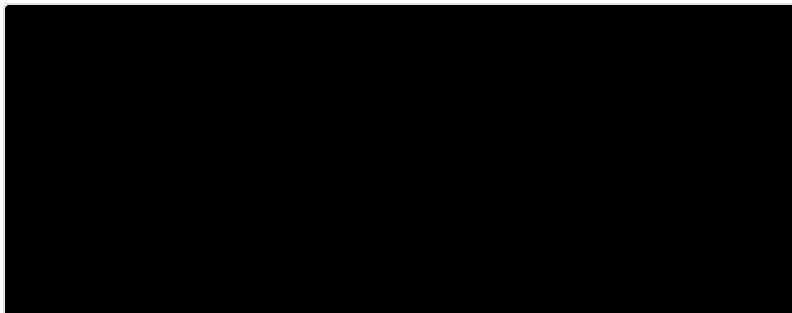

I am contacting you today about any current or future consideration by the Nevada Board of Health to require that children receive COVID vaccines as a requirement for school enrollment and attendance in the state of Nevada. I strongly oppose any such measure and remind you that these vaccines are currently not approved for uptake in children ages 5-17 by the United States Food and Drug Administration (FDA); rather they have been authorized by the FDA under an Emergency Use Authorization (EUA). Per federal law as referenced below, any product licensed under an EUA requires that citizens and therefore in the case of minor children, their parents/legal guardians, have the option to accept or refuse the product. Under the Nevada Open Records Act 239 *et seq.* I am requesting an opportunity to inspect or obtain copies of public records documenting the evidence of misinformation as it pertains to coronavirus, covid-19/ SARS COV2. Further that you have evidence of all the information listed below to back up your statements of the need to the drastic measures that have been forced upon the people of the State of Nevada.

Which are stated below as follows:

Evidence that the coronavirus has been isolated.

Evidence that SARS COV2 has been isolated.

Evidence that COVID 19 has been isolated.

Evidence that all three listed above actually exist.

Evidence that the CDC the NIH and/or the WHO have provided informed consent to those participating in the Emergency Use Authorized vaccination process.

Evidence that the vaccine administering companies namely: Pfizer-BioNTech, Moderna and Janssen have provided informed consent to their patients prior to receiving the coronavirus vaccine, or SARS COV2 vaccine, and/or COVID 19 vaccine.

Evidence that the companies stated above are currently as of this date: December 9th 2021, are FDA approved? To include the list the FDA approval dates.

Evidence that the CDC did not change or try to change the definition of vaccination in the past two years.

Evidence of the date when the CDC change the name of the word vaccination and its meaning/ context.

Evidence that the coronavirus, SARS CoV 2 and/or Covid 19 vaccination is more robust then natural immunity.

Evidence that gene therapy outweighs natural immunity against the coronavirus, SARS COV2 and/ or Covid 19.

Evidence that the word vaccine was not changed to accommodate the coronavirus vaccine.

Evidence that other therapeutics do not exist in the United States as a prophylaxis as well as a cure for the coronavirus if used early.

Please provide this information by email in electronic form.

If there are any fees for searching or copying these records, please inform me if the cost will exceed 100.00. However, I would also like to request a wavier of all these fees in that the discloser of the requested information is in the public interest and will contribute significantly to the publics understanding of the administration stance as per the Board of Health's interpretation of misinformation when it comes to the public's knowledge as well as the Board of Health's decision-making practices for the people of the State of Nevada.

Also, if you would like an individual list of each request feel free to let me know as I await your evidence to this matter.

To conclude, if access to the records I am requesting will take longer than a 'reasonable' amount of time, please contact me with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.

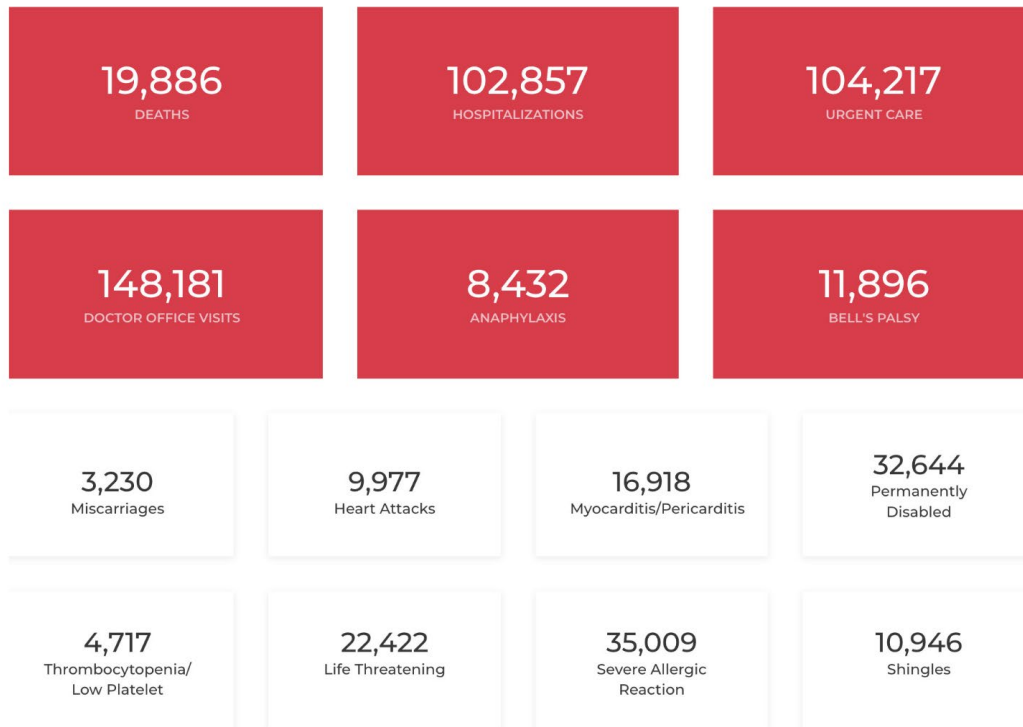

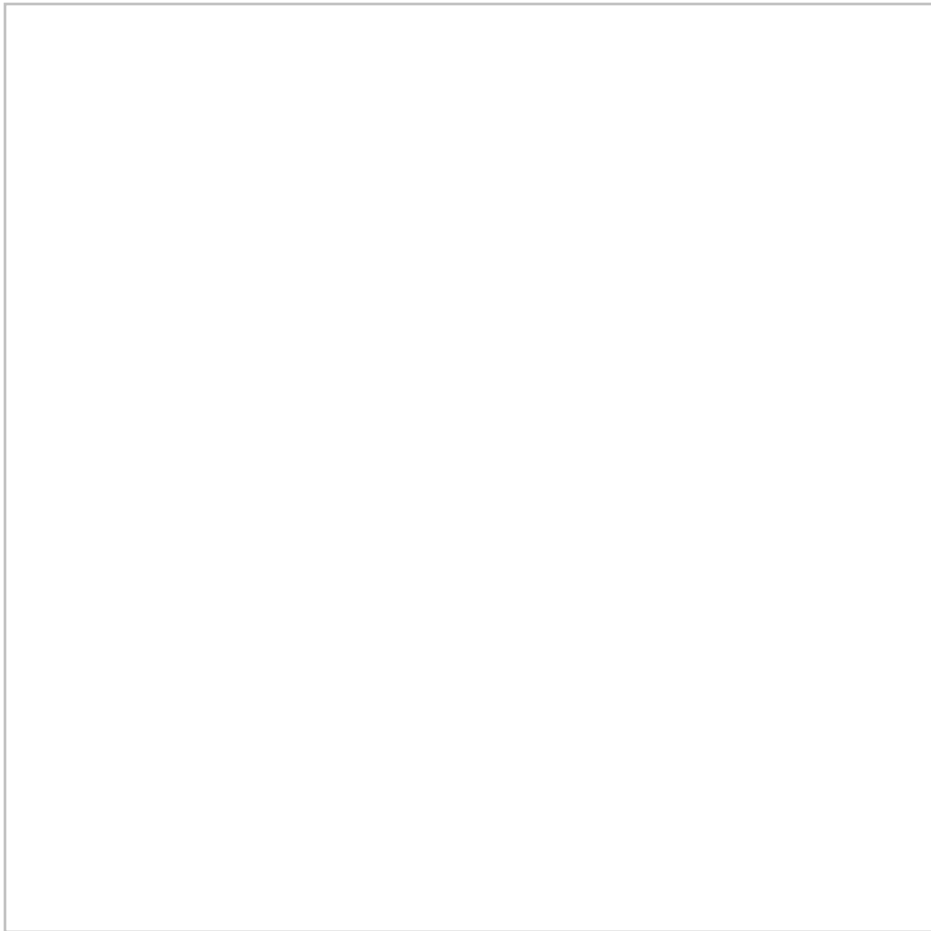
