

My educational background includes a Bachelor's of Science in Nutrition and Dietetics and Master's in Public Health from University of Nevada, Las Vegas. Much of my professional experience and expertise has been through successful federal nutrition program implementation, advocacy, evaluation and education.

Many of these programs have served low-income families, schools with high percentage of students receiving free or reduced-price lunch, women and children with unique nutritional needs, incarcerated youth and women, rural communities, older adults, and families experiencing food insecurity, poverty, and homelessness. There is a national crisis of steadily increasing maternal mortality rates that has brought unwanted but undoubtedly warranted attention to the medical and government bodies. As many ideas circulate about why. A popular thought, with growing evidence, is that the Covid-19 pandemic has had a direct causal effect, where the maternal mortality rates are now equivalent and possibly surpassing the maternal mortality rates of 1965. How can that be? How can the US now be rated as number one of developed countries for having the highest maternal mortality rates, especially considering over the last five or so decades the US has been heavily involved in global MCH efforts?

When we have some of the highest costs per capita for medical care, many people wonder why so many women are still dying during the perinatal period in the US? When we offer some of the most modern and technologically advanced healthcare, how are these dismal outcomes possible at such alarming rates? This is the United States of America.

As a board-certified pediatrician with decades of experience, with both the professional and personal passion and lengthy demonstrable career dedicated to providing, enlightening, and assisting families in attaining optimal healthcare, it would be an honor and obligation to serve as a member of the Maternal and Child Health Advisory Board. It's an obligation professionally, ethically, and morally. While many are left aghast and dumbfounded, some are mentally catatonic about serious MCH matters, whereas others are simply participating in intellectual banter about the problem. I am categorically in the group of those who welcome challenges and anticipate active participation particularly in solving this problem. Considering that the inconceivable extreme maternal morbidity and mortality proportions have become a social and humanity wound for this country, development of innovative and unconventional effective ideas will be required to solve this dire and pressing community health issue. Unquestionably, it will take a distinctive approach, one that includes a conglomerate of perspectives offering a variety of lenses, to develop practical and implementable solutions.

Albeit it would be very easy to sit on the periphery and expect others to fix these problems, I welcome the idea of jumping in and serving on a team that devotes their time, efforts, and intellectual energy to developing services and programs to structure better healthcare benefitting the community at large, with special emphasis on the most vulnerable.
