I am writing in support of recertifying Victoria Perea's Advanced EMT license and granting her a variance for not having a drivers license. I am very familiar with the strong need for qualified, dedicated, trained individuals to serve in emergency medical services in communities like Ely and Baker, NV. While I now am retired, I served as Superintendent of Great Basin National Park for several years, oversaw emergency medical services at the Park, and became an EMT myself due to the dire need for EMT's in our communities and the difficulty finding people to serve. I return to Baker every year and keep in touch with many community members. I understand that Ms. Perea has already served successfully as an Advanced EMT. While I don't know details of this case, it seems to me that if the job has been performed well already, both the community and Ms. Perea will best be served by granting the variance for her to continue to provide emergency medical services that are so urgently needed.

I am not familiar with the details of this case, however I know that Victoria Perea has enthusiastically desired to be an EMT from a very early age. She was born with an eyesight condition which does not permit her to drive.

In our remote, rural area it is extremely difficult to have sufficient numbers of EMT's who are willing to undergo the extensive training process in order to serve White Pine County's needs for emergency medical help. Rural communities such as ours are practiced at effective work-arounds, because resources are limited and they understand that situations such as this may have a solution that is a little outside of the box. Perhaps Victoria's EMT team has a workaround to the the driver's license

requirement that would satisfy the reservations to certifying her?

I just know it's heartbreaking that such a dedicated and enthusiastic young woman, willing to sacrifice and make the extensive efforts required to help save lives, may be denied the opportunity to serve. I hope there is a solution to this issue that will allow Victoria to continue to do what she loves.

(The two school districts, White Pine and Millard, work together with the students in this small area.) Tori was one of my low vision students. She was a dedicated student who was able to complete and do all the work assigned to her with minimal help. She needed to have a few things enlarged when she was younger and sit at the front of the room to see things on the board. As she got older, she independently managed her vision needs on her own. I would just follow up and make sure she had the vision resources that she needed. Tori was always able to see things up close and near, distance was hard for her. If I was in an accident, I would hope that Tori would be the person on call responding to my needs because I have that much faith in her abilities. She would make a great addition to any response team she would be a part of.


To whom it may concern,

We recommend, without reservation, that the Nevada Department of Health and Human Services make a reasonable accommodation to recertify Victoria Perea's Advanced EMT license on the grounds that she has proven her skills and ability to perform the incumbent duties, separate from operating a vehicle.

During our tenure as volunteer EMT's in Baker, Nevada, we had frequent interactions working with Victoria within emergency medical services (EMS) during the years of 2016 to 2018. We observed her to be capable of performing any duty needed on EMS calls, aside from driving a vehicle. We had Driver Only volunteers to fill the need for an ambulance driver. Victoria was an asset to EMS calls, as she possessed the skills, abilities and knowledge to fully operate as a licensed EMT. She took it upon herself to become a certified EMT and to volunteer in a rural area where there is a declining number of people that are willing to volunteer. Victoria has proven her capability to be an EMT by passing the Nevada State license requirements, and we fully support her license being reinstated. People with a skill set such as Victoria's are an asset to the community.
