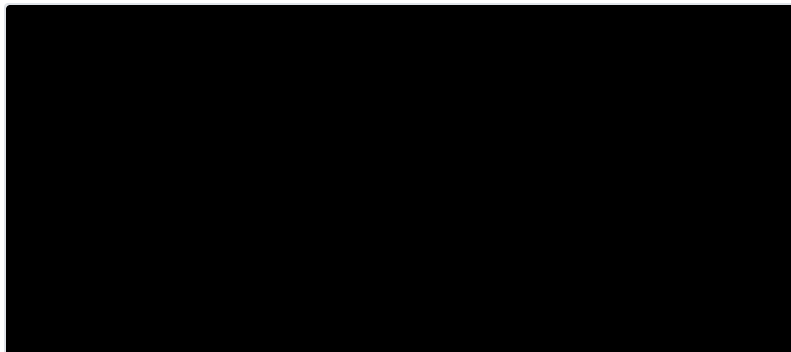

Dear Dr. Pennell and members of the Nevada State Board of Health,

As the Chair of the Rural Regional Behavioral Health Policy Board (Rural RBHPB) and the Rural Regional Behavioral Health Coordinator, we submit this letter in support of mechanisms to provide sustainable funding for 988 and other behavioral health crisis services, specifically the surcharge proposed for approval by the Board of Health in Agenda Item 3.

The lack of availability of appropriate crisis services to meet the need across the state has been a chronic issue, but has only become more urgent since 2020. In the “Rural Region”, served by the Rural RBHPB (Elko, Eureka, Humboldt, Lander, Pershing, and White Pine Counties), the ease of use for 988 provides a lifeline for many community members experiencing crises and other challenges rooted in mental illness, substance use, and co-occurring conditions. Securing sustainable funding streams to support the badly-needed expansion of Nevada’s crisis response systems is integral to bolstering services to ensure that persons with behavioral health challenges receive timely, appropriate, and high-quality treatment.

We appreciate this opportunity to offer our individual support for this strategy; we were not aware of this measure being up for approval in time to have a letter of support approved by the full Rural RBHPB. That being said, the surcharge and its direction to funding the crisis system aligns with the priorities of the Rural RBHPB and the needs of the communities it serves.
