# Overview of PHHS Block Grant

---



NEVADA DIVISION of PUBLIC  
and BEHAVIORAL HEALTH

- Flexible funding from the Centers for Disease Control and Prevention (CDC)
- Allows states to address unique public health needs through community-driven strategies
- Aligns with core priorities:
  - reducing chronic diseases
  - promoting healthy behaviors
  - achieving health equity
  - strengthening data surveillance systems
  - providing essential preventive health services

# Nevada's FY24 PHHS Block Grant Award

---



Nevada received \$611,898 for FY24  
Funding strategically allocated across key partners and initiatives

# Funded Partners and Initiatives for FY24

---



- Carson City Health and Human Services (CCHHS) - \$9,943 for education on overweight/obesity prevalence
- Central Nevada Health District (CNHD) - \$32,998 for community surveys and listening sessions
- Northern Nevada Public Health (NNPH) - \$30,319 for promoting physical activity initiatives
- Southern Nevada Health District (SNHD) - \$54,174 for diabetes prevention and management
- KPS3 - \$30,094.40 for the HEALNV site and Nevada 5210 programs
- Nevada Institute for Children's Research and Policy (NICRP) - \$44,997 for rape prevention education
- Bureau initiatives: Chronic Disease Dashboard, public education campaigns, workforce development

# Comprehensive Approach

---

- Evidence-based strategies across education, community engagement, policy/environmental changes, clinical services, surveillance, and evaluation
- Aligned with PHHS Block Grant goals

# Public Hearing and Feedback
