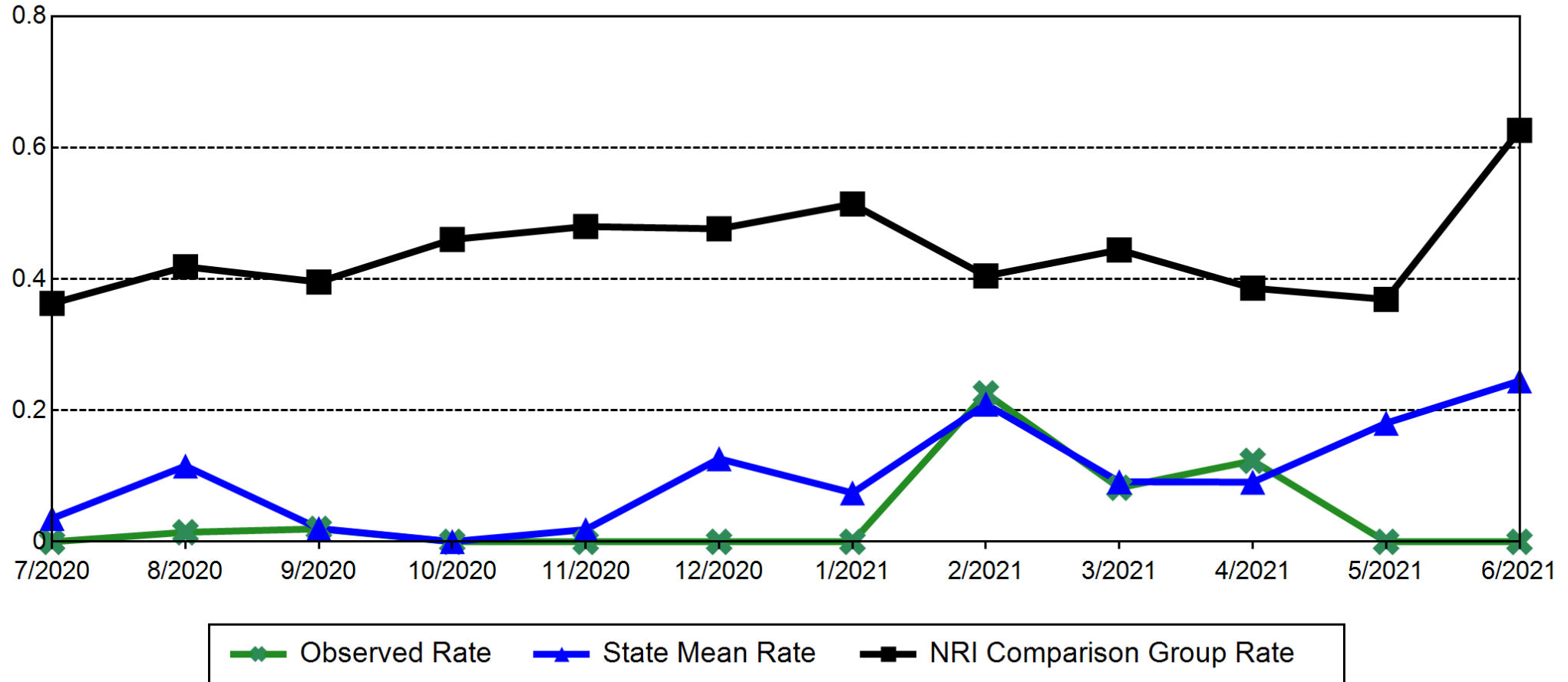

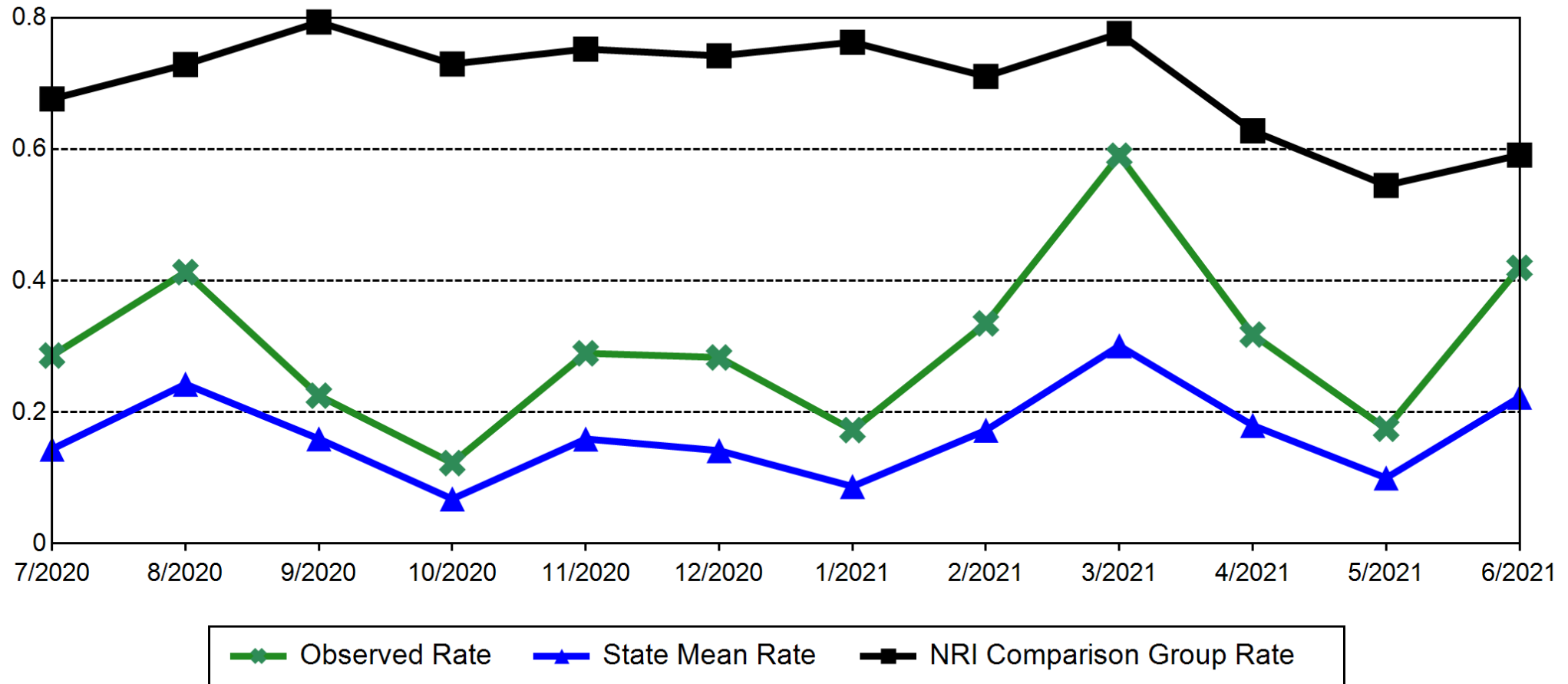

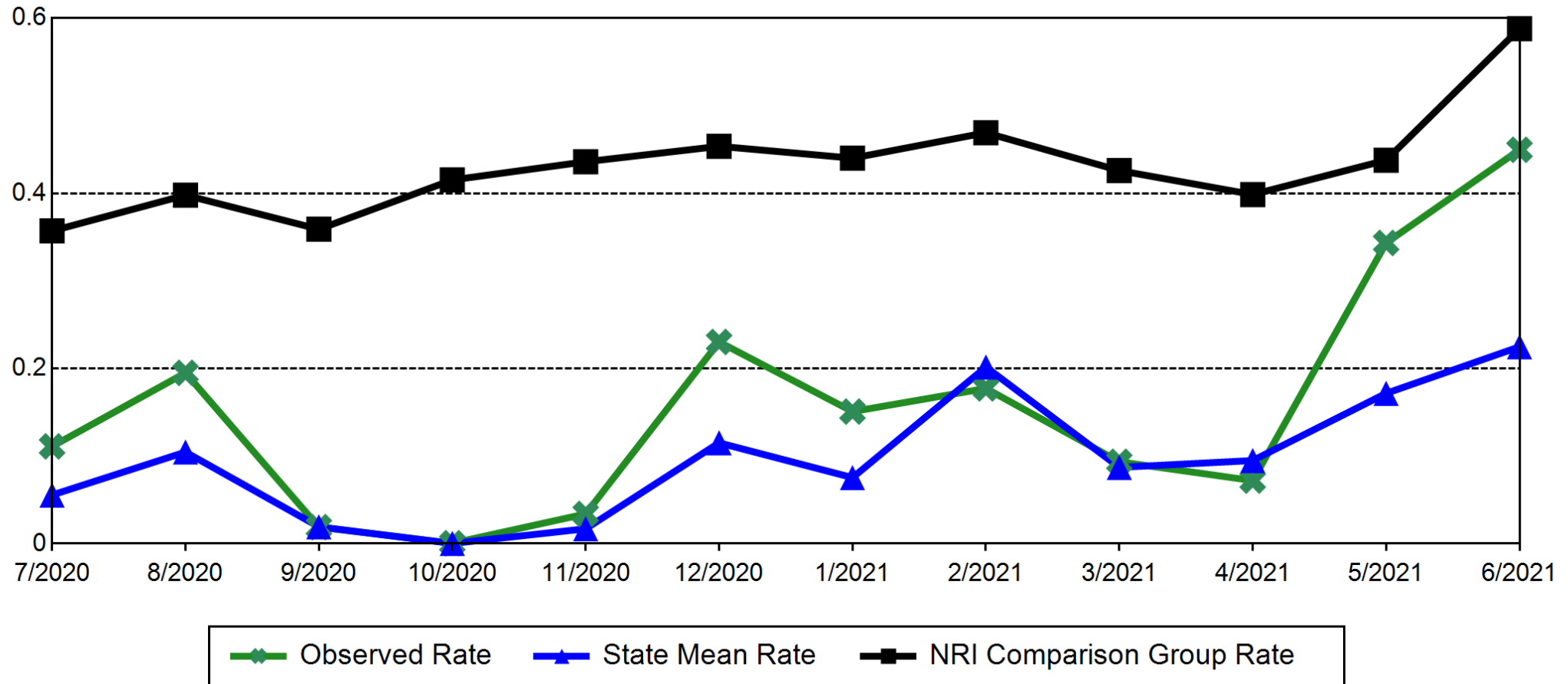

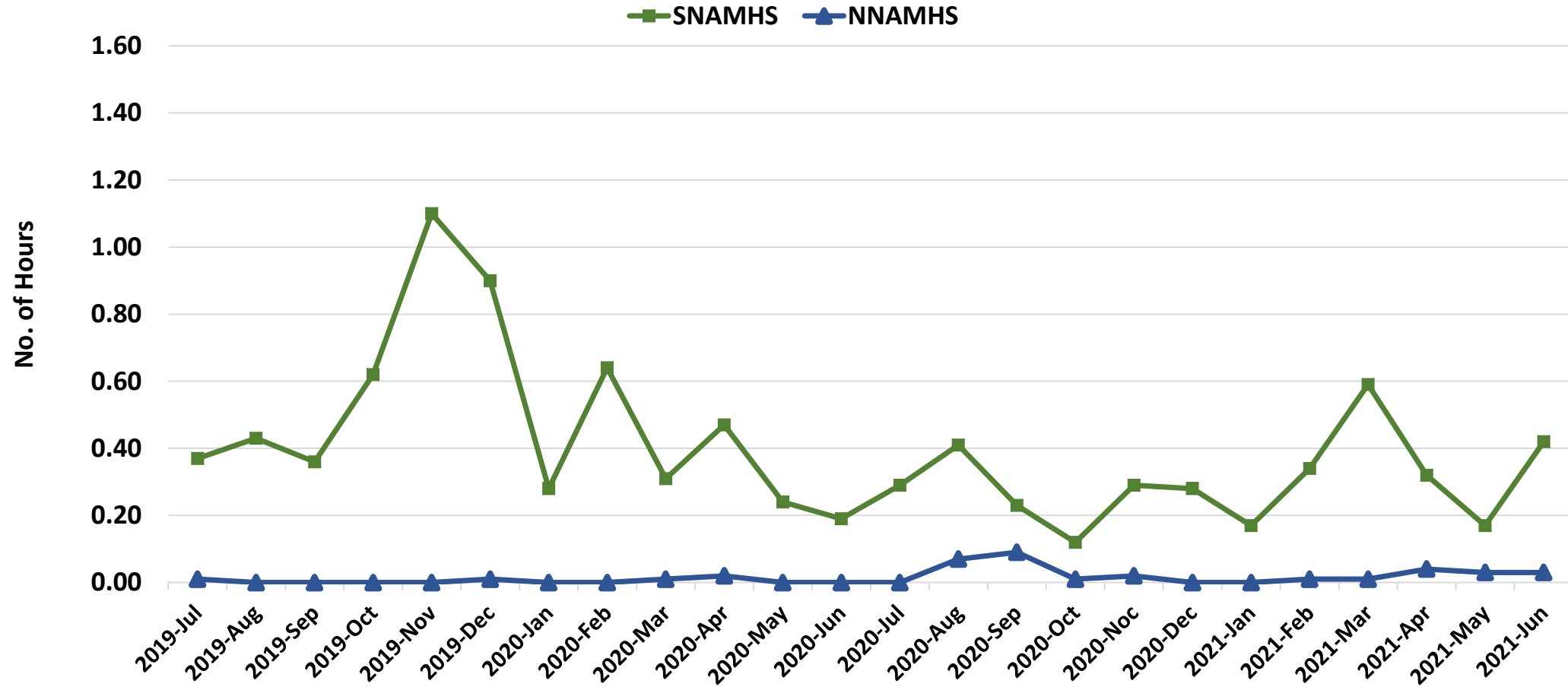

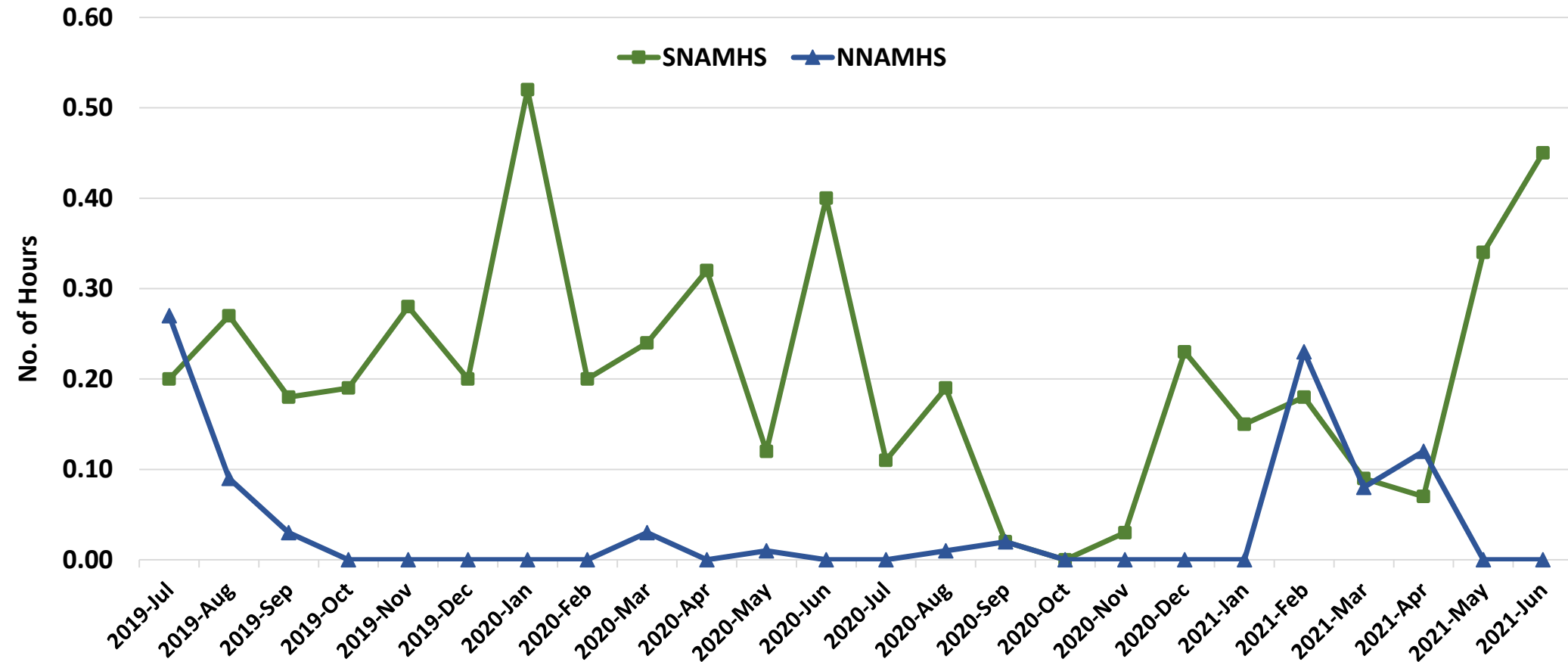
STATEWIDE - Overall Use of Restraints (number of hours clients spent in restraints for every 1000 inpatient hours)

STATEWIDE - Overall Use of Seclusion (number of hours clients spent in seclusion for every 1000 inpatient hours)

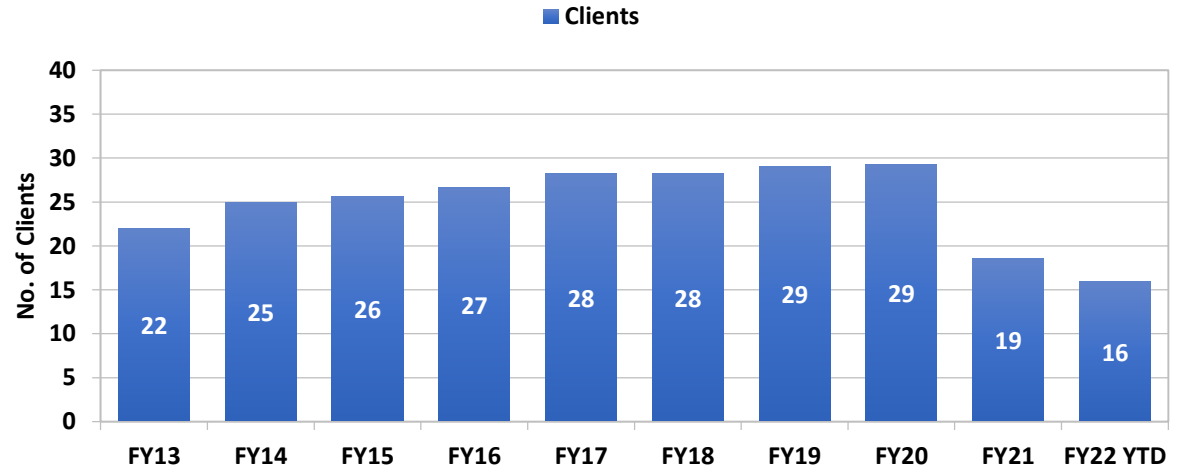

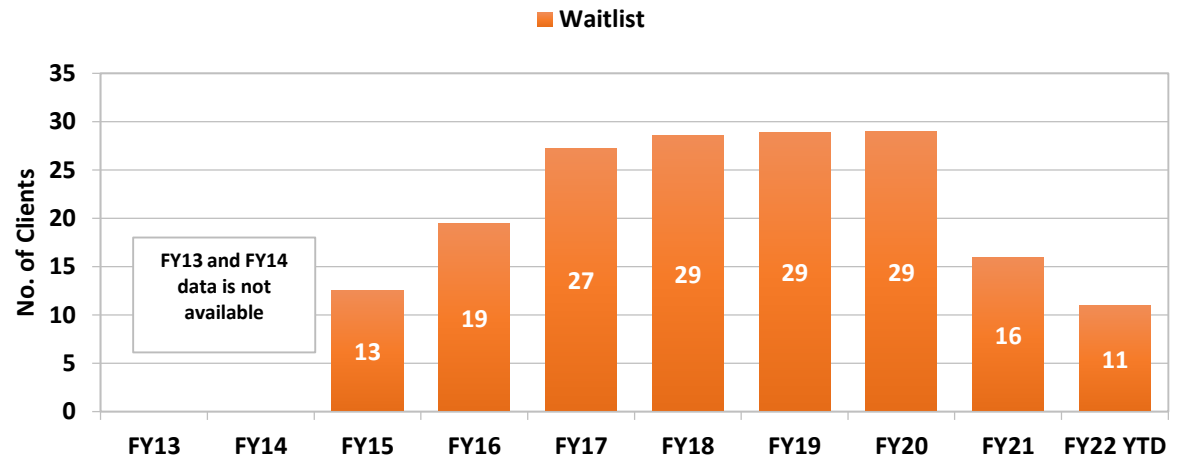

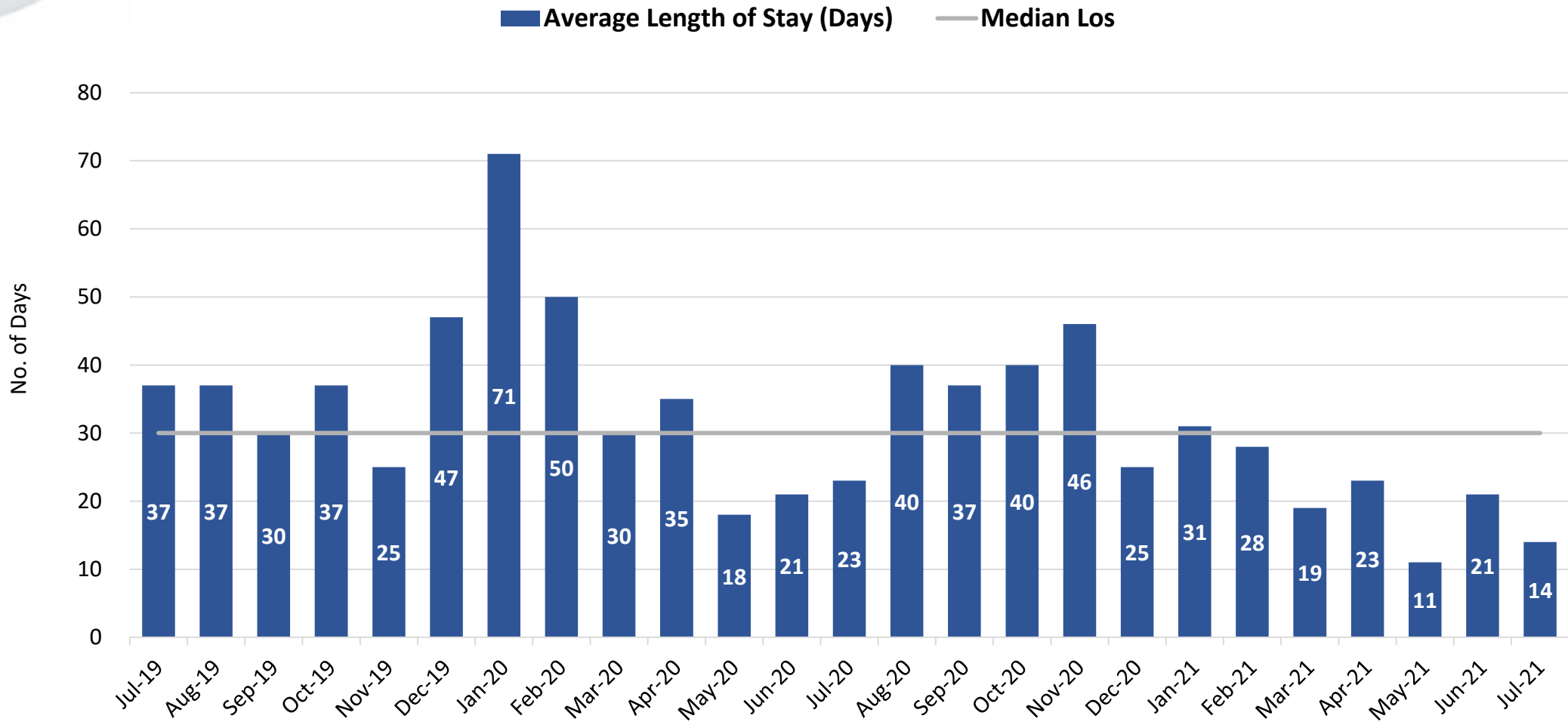


NNAMHS Dini-Townsend Hospital Waitlist - Fiscal Year Averages

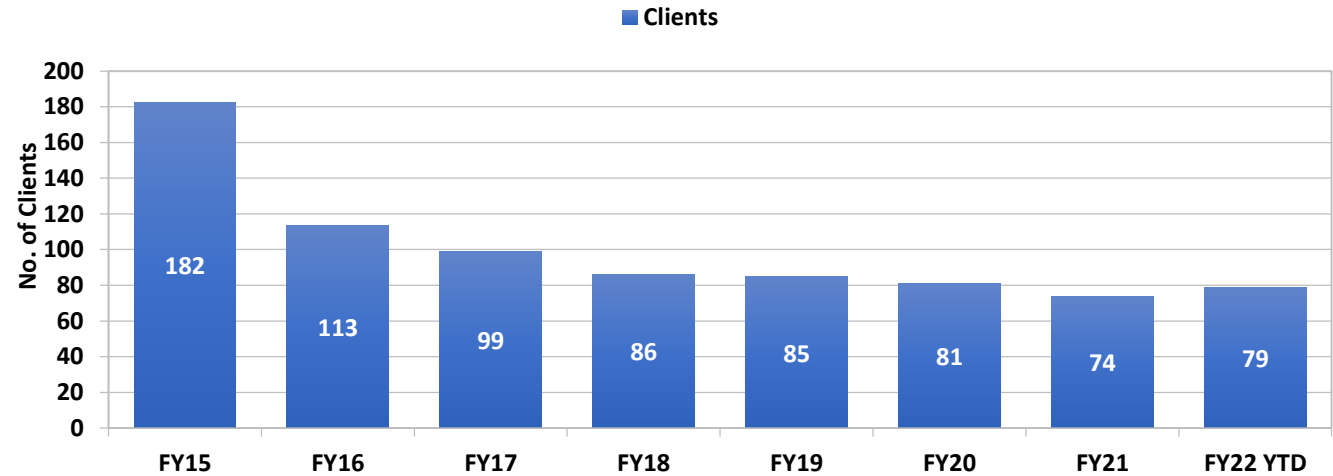

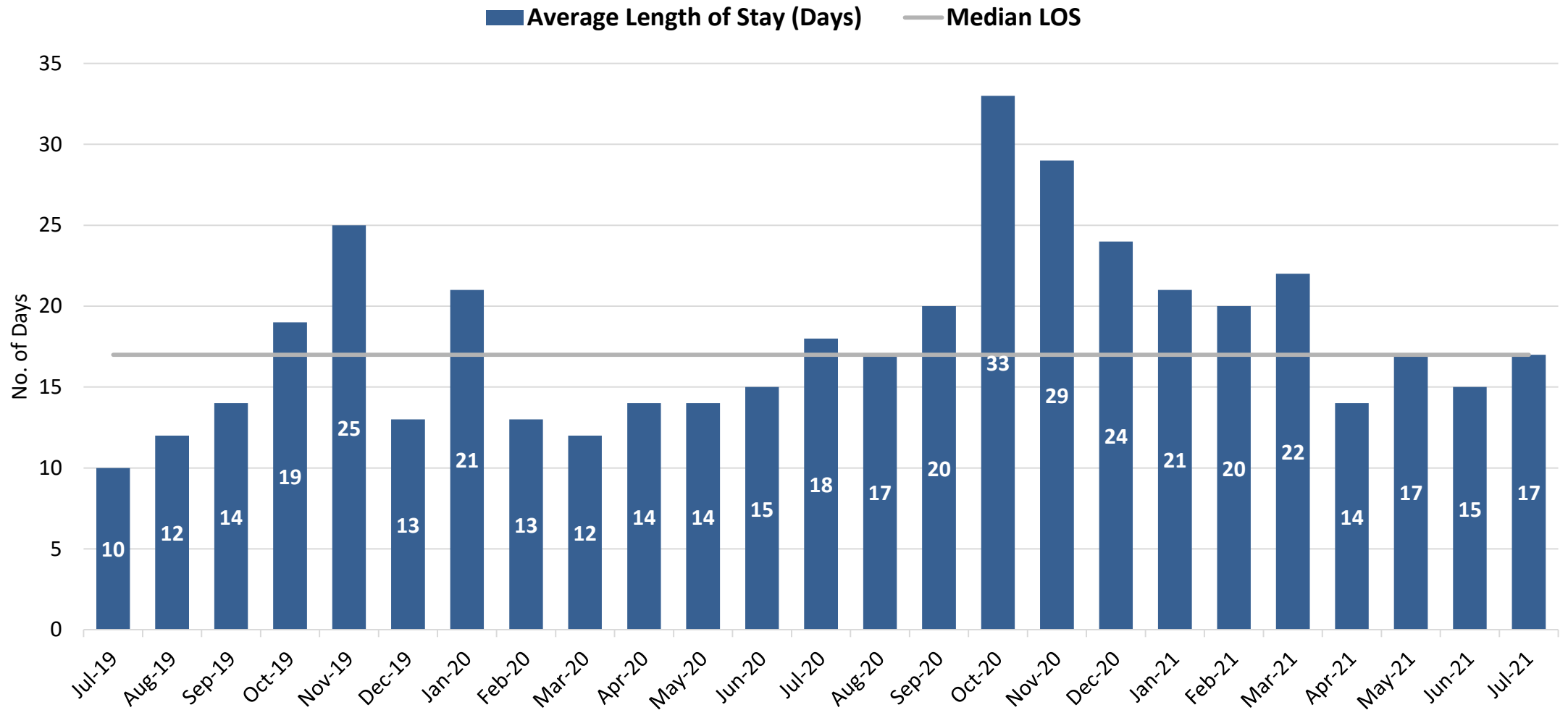
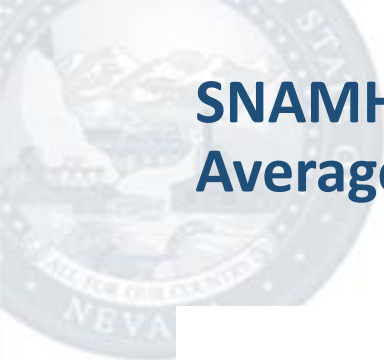


SNAMHS Rawson-Neal Hospital Waitlist - Fiscal Year Averages

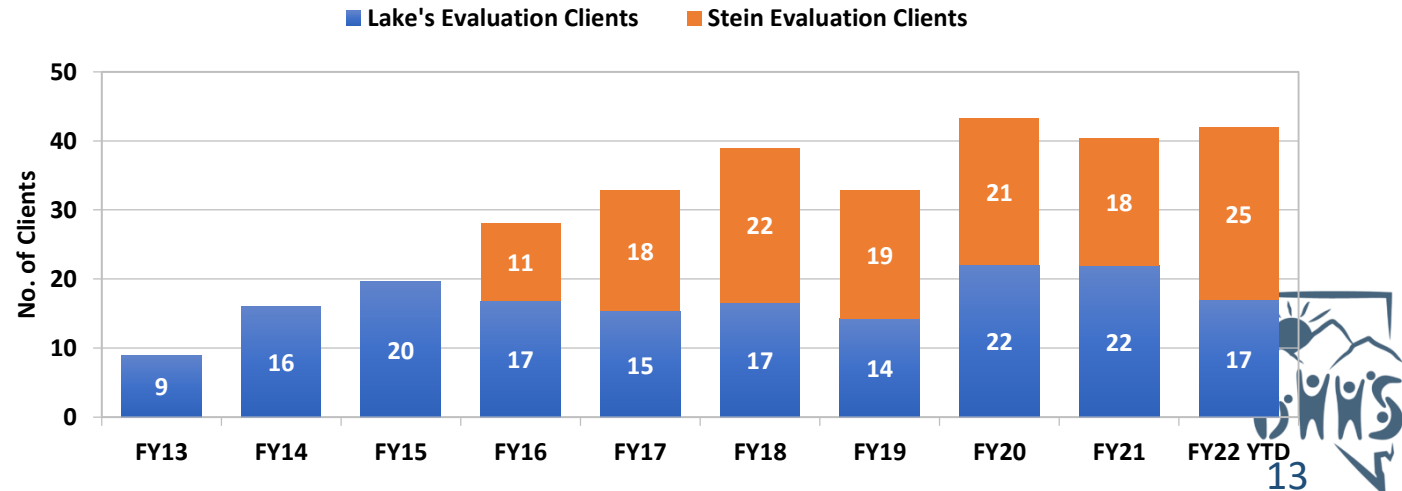

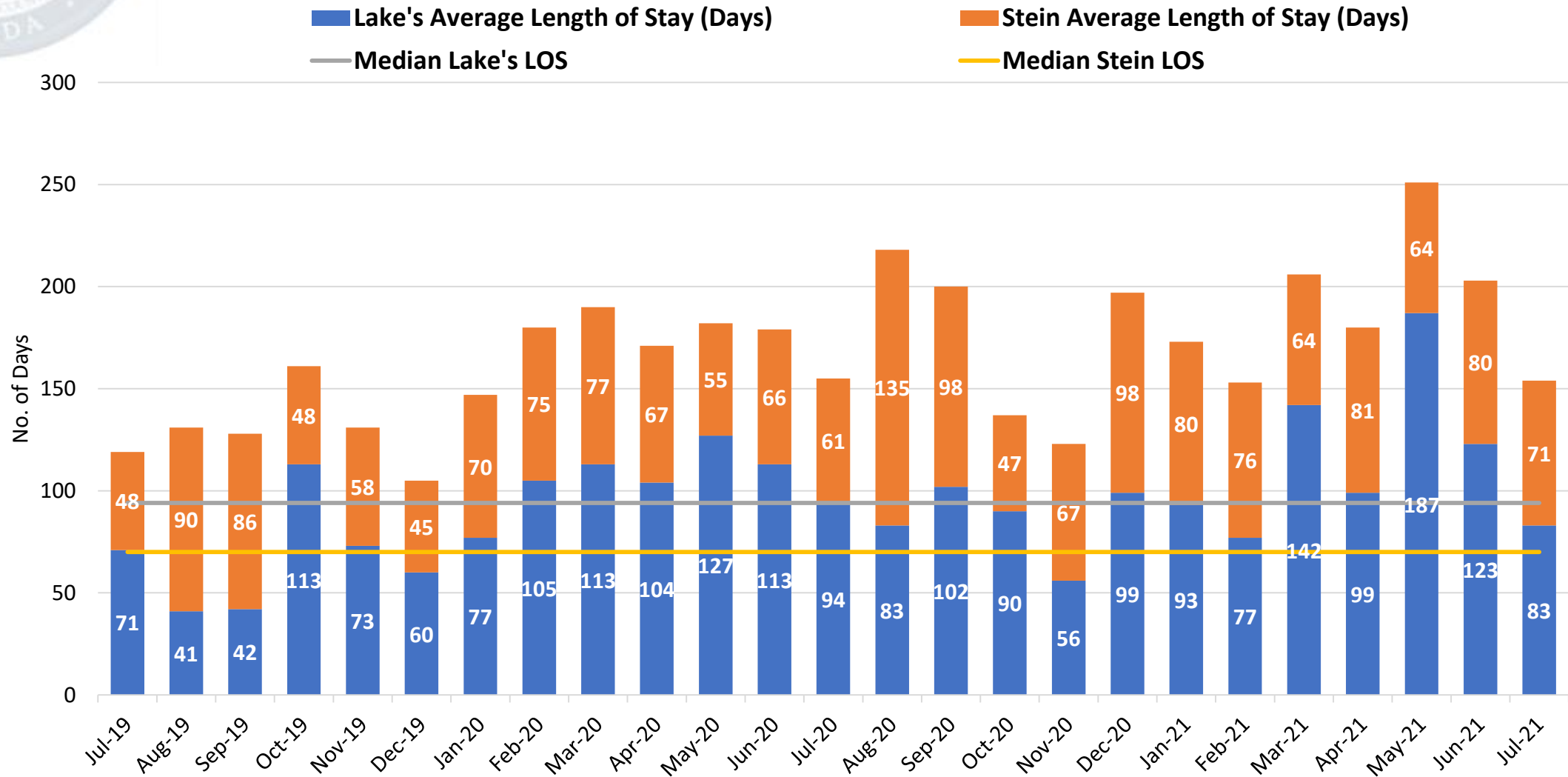

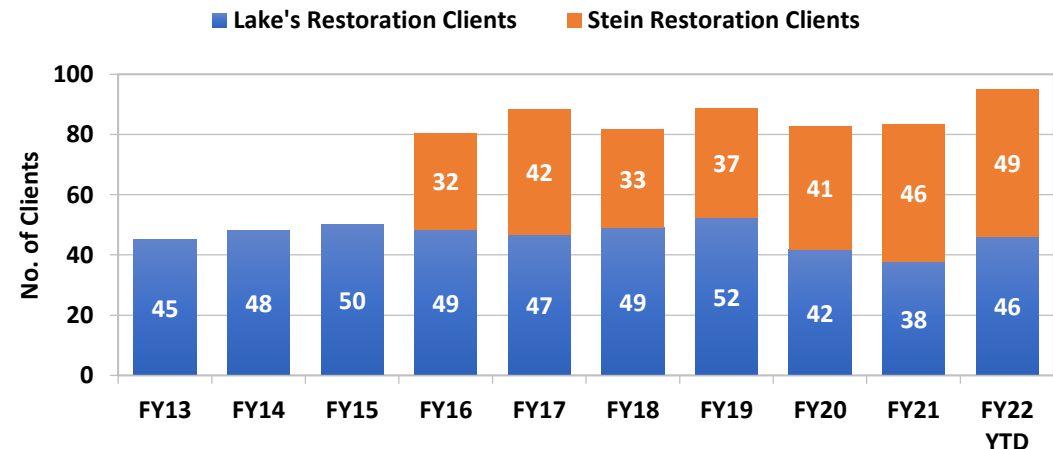

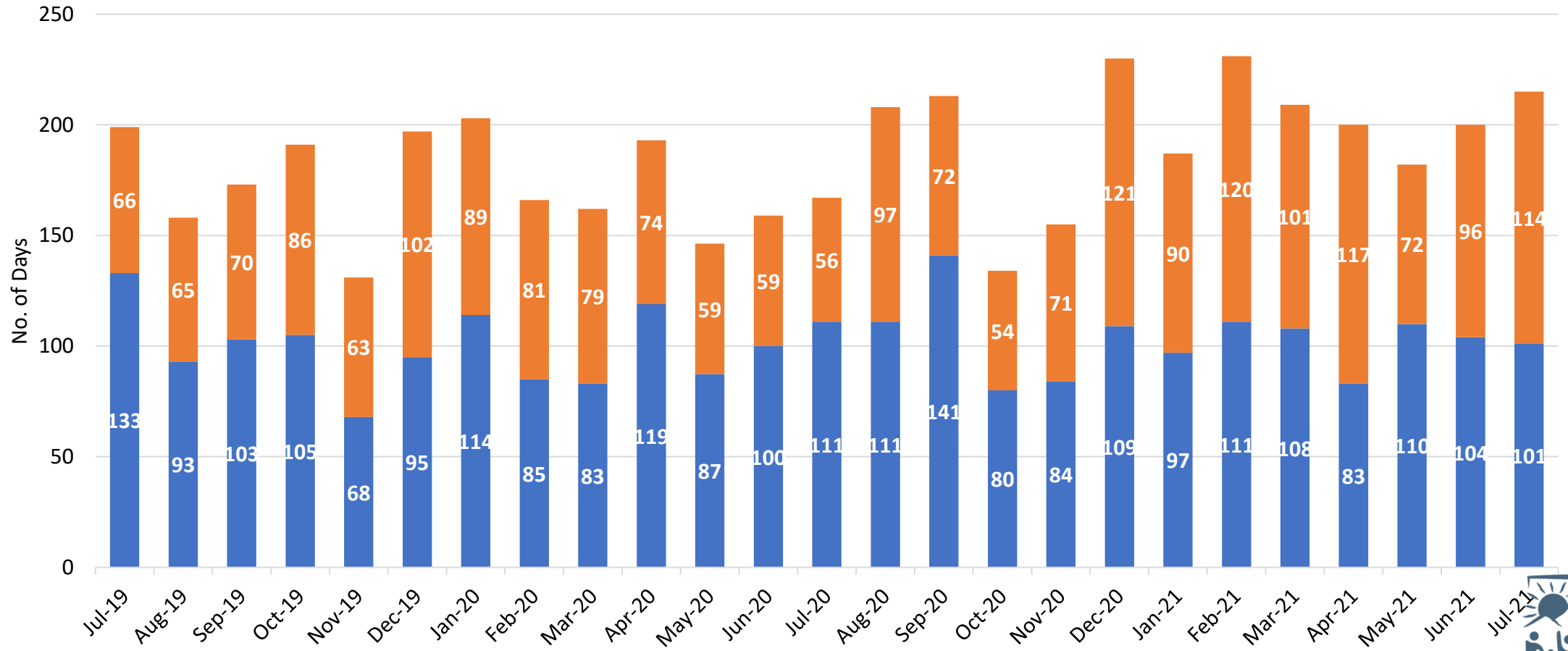


ADULT FORENSIC FACILITIES: RESTORATION CLIENTS

■ Lake's Average Length of Stay (Days) ■ Stein Average Length of Stay (Days)

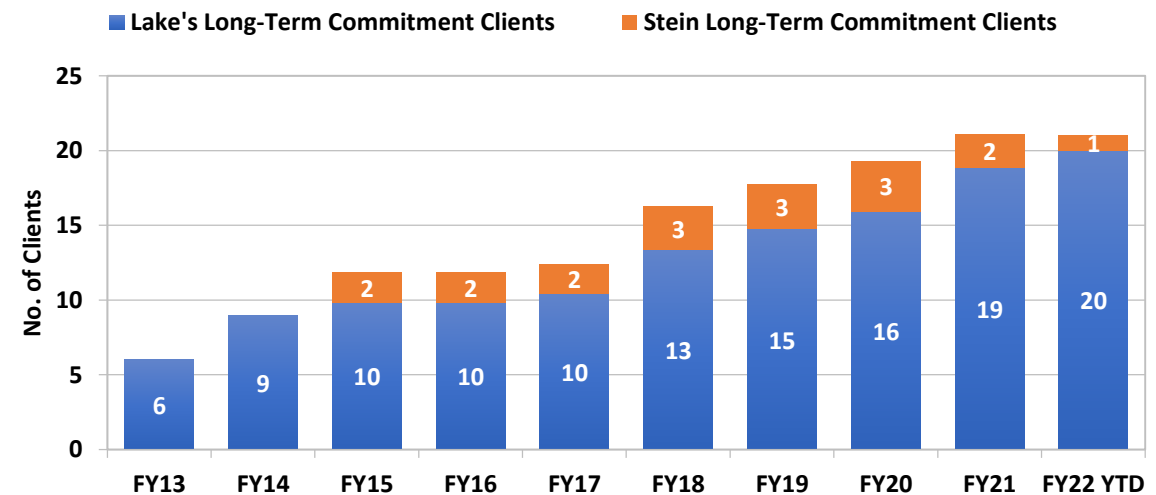


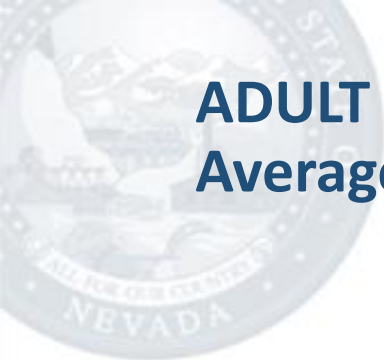

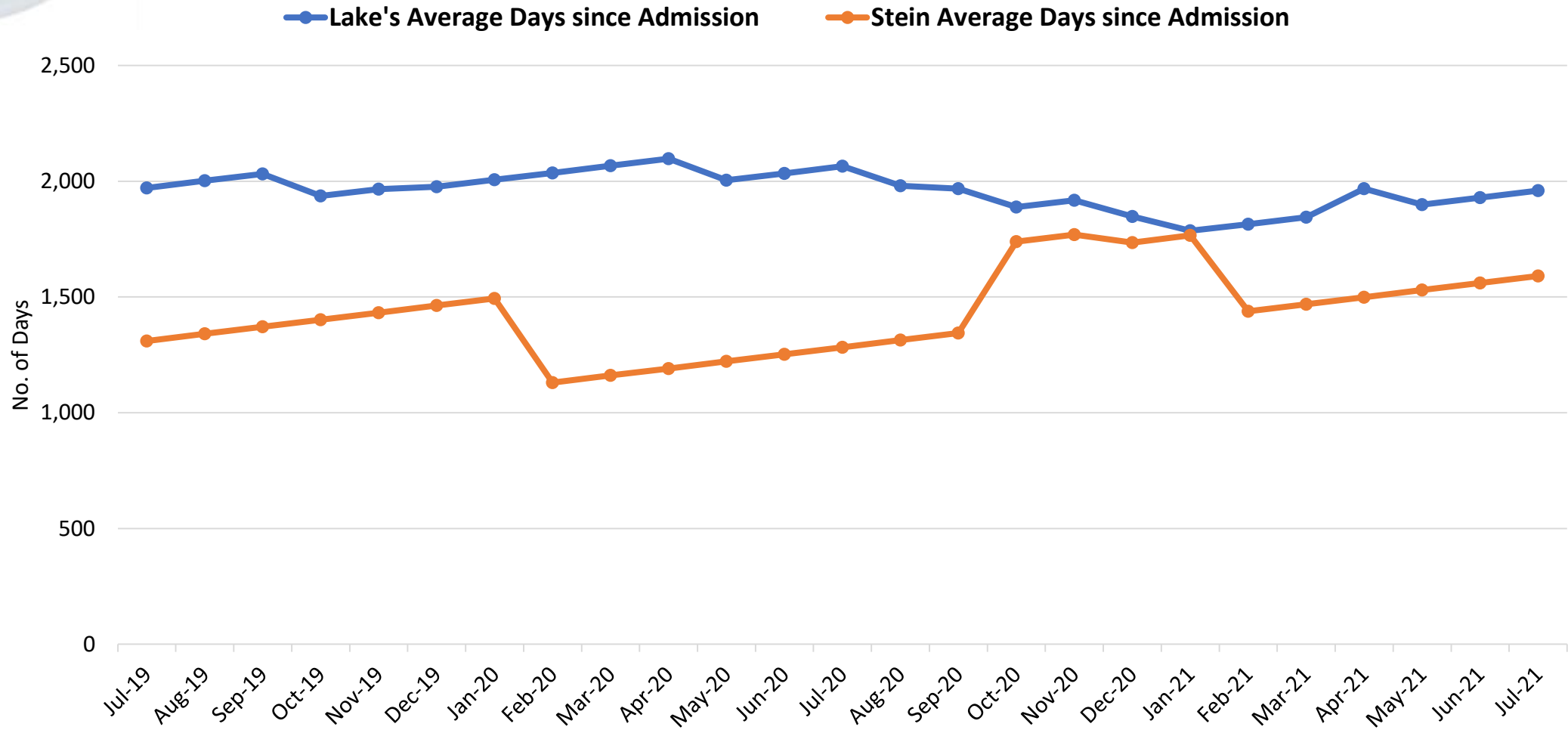
Long-Term Commitments - Fiscal Year Averages
