Overview

- Mission: Ensure the provision of effective supports and services to meet the needs of individuals and families, helping them lead independent, meaningful, and dignified lives
- Vision: Nevadans, regardless of age or ability, will enjoy a meaningful life led with dignity and self-determination
- Nevada Aging and Disability Services Division provides services to people across the lifespan, including:
 - Children with Disabilities
 - Older Adults
 - Adults with Disabilities
 - Family Caregivers
- Services are offered through ADSD directly and in partnership with community organizations.

Nevada Early Intervention Services (NEIS)

- Provides early intervention services to families with eligible children 0-3 years old with a diagnosed disability or developmental delay
- Provides supports and services to include:
 - Service coordination
 - Special instruction
 - Occupational therapy
 - Physical therapy
 - Speech therapy
 - Nutrition services
 - Hearing services
 - Vision services
 - Family training and counseling
 - And more!

Autism Treatment Assistance Program (ATAP)

- Assists parents and caregivers with the expensive cost of providing Autismspecific treatments to their child with Autism Spectrum Disorder (ASD)
- Provides eligible recipients a monthly allotment to pay for on-going treatment development, supervision, and a limited amount of weekly intervention hours based on the child's individual treatment plan, age, and income



Regional Centers

- Statewide, ADSD has 3 Regional Centers that provide services to eligible children and adults with a diagnosis of an intellectual disability or a closely related developmental disability occurring before the age of 22 years.
 - Sierra Regional Center (Northern Nevada)
 - Desert Regional Center (Southern Nevada)
 - Rural Regional Center (Rural Nevada)
- Services can include:
 - Family Support Services
 - Behavioral Consultation
 - Supportive Living Arrangement
 - Nutrition
 - Jobs and Day Training
 - And much more!

Office of Consumer Health Assistance (OCHA)

- Assists health care consumers and injured workers understand their rights and responsibilities under their health plans and/or workers' compensation
- Provides education and advocacy to those who have insurance through an employer, managed care, individuals health policies, Employee Retirement Income Security Act (ERISA), Nevada Workers' Compensation, Medicare, or Medicaid.
- Access to healthcare and prescription medication assistance resources are also provided for the uninsured and under-insured.



Adult Protective Services (APS)

- Serve vulnerable adults (age 18 to 59) and older adults (60+) who are:
 - Abused
 - Neglected
 - Exploited
 - Isolated
 - Abandoned
- Assist by investigating, providing or arranging for services to alleviate and prevent further maltreatment while safeguarding civil liberties
- Protective services are provided if the individual is willing to accept these services

Long Term Care Ombudsman (LTCOP)

• Advocates for residents in long-term care:

- Skilled nursing facilities
- Residential facilities for groups
- Homes for individual residential care
- Day care centers
- Facilities for long-term rehabilitation
- Providers of living arrangement services
- LTCO ensure residents in these settings receive quality care by:
 - Assisting residents with concerns relating to day-to-day care, health, safety, and personal preferences
 - Provide information to the community regarding long term care in NV
 - Provide education to facility staff, families, and residents on a variety of issues relating to aging, long term care, and residents' rights
 - Provide in-service training for long term care professionals regarding trends and best practice to improve the quality of care for residents



Office of Community Living (OCL)



OCL- Intake and Operations Section

- Conduct intake, eligibility, and assessments of two Medicaid waivers
 - Home and Community Based Services (HCBS) Waiver for Frail Elders
 - <u>Home and Community Based Services (HCBS) Waiver for Persons with Physical</u> <u>Disabilities</u>
- Responsible for the Senior and Disability Prescription Assistance Program (<u>Senior/Disability Rx</u>) and the <u>Taxi Assistance Program</u> (Las Vegas)
- Works with Medicaid (Division of Healthcare Finance and Policy [DHCFP]) to conduct HCBS waiver operational activities and participates in the amendment and renewal process with DHCFP



OCL- Supportive Services Section

- Provide the state funded ADSD home and community-based services for older adults and people with disabilities
 - <u>Community Options Program for the Elderly (COPE)</u>
 - Personal Assistance Services Program (PAS)
- Provide Case Management for the Medicaid HCBS waivers listed on the previous slide
- Houses the <u>Communication Access Services (CAS)</u> program which supports individuals who are Deaf, Hard of Hearing, and Speech Impaired



OCL- Community Services Section

- Provides funding and support to community partners to offer a variety of service to individuals throughout Nevada, including:
 - Nutrition Services for Older Adults
 - Transportation
 - Caregiver Support
 - Homemaker
 - <u>Assistive Technology for Independent Living</u>
 - <u>Assistive Technology Collaborative</u>
 - Medicare Assistance Program (MAP)



OCL- Planning Section

- Focused on strategic planning and innovations to expand services to all ADSD populations
- Works closely with advocacy bodies, the community, and various partners to improve access to service and pilot new services
- Includes:
 - <u>Nevada 211</u> the state's information and referral hub for human services
 - <u>Nevada Care Connection</u> one-stop-shop for services and supports for older adults, people with disabilities, veterans, and families
 - **Boards and Commissions**
 - <u>Reports</u>
