Kelli Seals reported on current projects and operational changes within the department, including the retirement of their District Health Officer that are included in the NNPH written report.

Dr. Brooke Conway went over the NICRP written report that included information on the early childhood obesity prevention workgroup, Dr. Conway mentioned the finalized state report and their ongoing work on policy changes.
