**4. Legislative Report/Summary – Chair Ratti *Informational Only***

- **Senate Bill 69:** AN ACT relating to behavioral health; providing for the certification of peer recovery support specialists and peer recovery support specialist supervisors; requiring a peer recovery support specialist or peer recovery support specialist supervisor to report certain information, requiring any instruction, curriculum or program concerning substance misuse or substance use disorder in a public school to be evidence-based, requiring the participation of public schools in a system collect data concerning youth risk behavior of pupils enrolled in certain grades in a public school; providing for the certification of substance use disorder prevention coalitions and

*prescribing the duties of such a coalition; requiring certain reporting concerning curricula and programs on substance misuse and substance use disorders in public schools; providing a penalty.*

- **Senate Bill 154:** *AN ACT relating to Medicaid; requiring the Department of Health and Human Services to Apply for a waiver to receive federal funding for coverage of the treatment of the substance use disorder of a person in an institution for mental diseases; authorizing the Department to apply for a waiver to receive federal funding for coverage of the treatment of certain mental health conditions of persons in an institution for mental diseases.*
- **Senate Bill 156:** *AN ACT relating to mental health; revising certain requirements for an endorsement as a crisis stabilization center.*
- **Senate Bill 390:** *AN ACT relating to mental health; providing for the establishment of a suicide prevention and mental health crisis hotline; requiring the imposition of a surcharge on certain communications services to support the hotline; creating the Capital Fund for Behavioral Health; requiring the State Treasurer to deposit the proceeds of certain litigation into the Fund; requiring the Department of Health and Human Services to award grants from the Fund to support certain capital projects; and providing other matters properly relating thereto.*
- **Assembly Bill 181:** *AN ACT relating to mental health; providing for the reporting of certain information by certain health related facilities relating to suicide; requiring certain insurers and other organizations providing health coverage to adhere to certain provisions of federal law; requiring certain insurers and other organizations providing health coverage to submit a report demonstrating mental health parity and addiction equity compliance.*
