- 3. Presentation on Washoe County Community Court (*Honorable Judge Tammy M. Riggs*) Mr. Duarte clarifies Judge Riggs is with Reno Municipal Court. Judge Riggs explains a new "Community Court" that has been in place since March, to help with "quality of life" crimes/offenses in the downtown area. Discussed process of program and how it has helped not only offenders but the local businesses due to providing a variety of programs and services from area agencies, to those in need. Will continue to monitor effectiveness of program for future potential. Judge Riggs says they are seeing fairly good success with the program. Answered questions of those in attendance.
- 4. Update on AB66: Summary Provides for the Establishment of Crisis Stabilization Centers in Certain Counties (BDR39-486) (Chuck Duarte, Dorothy Edwards)
 Ms. Edwards gave update on latest actions of the bill. Passed through two houses; on Governor's desk for signature. Mr. Duarte explained time frame and follow up to bill regarding Nevada Administrative Code. Questions fielded regarding bill.
