2. Public comment

Dr. Jake Wiskerchen: We have a NRS that sates, If you have a license in another state in good standing, no restrictions and no blemishes and can pass the background check, you can come over and pay the fees and get a license in Nevada. The biggest hang up is getting the background check done and the license. When the Governor issued his emergency directive 011, it made it possible to waive many of the professional licensing requirements. This allows us to expedite more people into our state to help treat our ailing individuals. A lot of us are experiencing a crushing burden of patient demand and we would like some help, if we can get that from out of state from people whose case loads are lower, if they are competent and qualified we should allow them to practice here.



Chair Laughridge: Thanks Jake, Valerie and I are very in tune to some of the conversations you have been having with portability and mockup language, I think will be helpful as we move forward.

4. Development and Approval of Board Meeting Schedule *For Possible Action* (*Chair, Fergus Laughridge*)

I would like to see us meet every other month and then going forward to a quarterly timetable. Valerie, what are your ideas?

Valerie: I would recommend monthly short meetings of about 45 minutes per meeting through the legislative session and then roll to every other month to quarterly afterwards. That way we can make sure board members are available to vote on anything that is necessary for legislative action. That would be my personal preference. I did talk to Senator Goicoechea this morning, and his schedule is packed but most days he could make between 1:00pm and 3:30pm.

Chair Laughridge: Any quick comments from the rest of the board? Like Valerie was saying, if we could meet monthly because we still have a lot of work to do.

Bryce: Considering the workload, I think it is a good idea to meet monthly, as long as it is a short meeting.

Chair Laughridge: This is the fourth Wednesday, it looks like we have more Wednesday in every month, does this date and time work for everybody. I am seeing notes on the chat that the fourth Wednesday at 1:00pm works for everybody. I would entertain a motion to meet the fourth Wednesday of every month at 1:00pm for a brief board meeting.

5. Review and make recommendations: SB 44 For Possible Action

(Chair Laughridge, and Valerie Cauhape, Rural Regional Behavioral Health Coordinator)

The outstanding amount of work Valerie and her team of stakeholders have put together for SB44, as you know, our boards are allowed to have one BDR (Bill Draft Request) to go forward and ours did, we now have language thanks to Valerie's work.

Presentation by Valerie:

- Brief Overview of current SB 44 language:
  - Addition of LMSW licensure type for Board of Social Work, this will be more appealing for professionals practicing at a master's level to come to Nevada.
  - Creation of 6-month grace period (all four Boards), for official transcript submission
  - LCB evaluation study (all four Boards), 3<sup>rd</sup> party evaluation by LCB research division to identify and address barriers
- Stakeholder feedback:
  - Expected friendly amendment from Board of Social Work to adjust language
  - o Bill is not "aggressive enough"
  - "Grace Period" is not necessary, may raise unnecessary concerns
  - Look to other boards who have expedited processes in nonemergency time
  - Consider remote supervision options
  - No action until 2023- too little too late
  - Licensing Boards have not done enough to help expedite process
  - Need to consider Medicaid reimbursements
- Additional data and information:
  - o Data is downloaded by "occupation", not licensure "type"
  - Not sure how accurate data is
- RBHC recommendations:
  - Remove "grace period" and interim study
  - Move forward with licensure portability and expedited Endorsement Process
  - o Medicaid reimbursements
  - Ability to provide tele-health services
  - Remote supervision
- Board discussion and possible action:



Brook: Should we focus our attention on one amendment that would expand the workforce the most? If anybody has any insight that would be helpful.

Matt: It seems to me like the expediting of the licensure is really what's going to move this.

Erika: Thank you so much for your hard work, I agree with Matt, we want to make it easier and quicker for mental health providers to practice in this state. I love that you put Medicaid reimbursement as an issue, but I think it is a humongous challenge and we should save that for to the next biennium.

Valerie: Fergus and I spoke with Senator Spearman to discuss this bill; she is pretty adamant that something needs to be done this session. She's open to us working with her on her bill to make sure they work together. She is not scheduling our bill until we have an amendment, so we need to start working on this quickly.

Chair Fergus: Behavioral Health is on the legislature radar which is good for us. We have the opportunity in the year to make it happen. Its very important in our monthly meetings to work on getting the language right the first time. I would like to put before the board, to allow Valerie and I to continue working with the stakeholders to flush out the language and get an amended version of our bill language back to you for a quick turnaround. Valerie does a better job with summary.

Valerie: The motion would be to approve Fergus and I to draft and submit amendments on behalf of this board and to communicate with board members individually regarding content of the amendment.

Matt: III make motion Brook: III second that motion

Chair Fergus: Any opposed? Hearing none this passes unanimously.
